### **CURRENT RESERVOIR CONDITIONS (May 26, 2011: 10:00am)**

Elevation: 3623.98 Storage: 859,837 acre-feet; River Release: 5,000 cfs; Inflow: 16,000 cfs;

### **GENERAL COMMENTS:**

Precipitation has diminished and streamflows continue to slowly decline but continue to remain high. Inflows into Bighorn Lake continue to remain over 16,000 cfs. To control the reservoir storage and continue preparing for the anticipated snowmelt, the following operations are required at Yellowtail Dam and Powerplant.

### **YELLOWTAIL TURBINE RELEASE:**

**At 1400 hour on Thursday, May 26, 2011:**

*Maintain average daily turbine release at 4,930 cfs ( $\approx$  3,770 MW-Hrs/day using 31.4 cfs/mw).*

**At 1600 hour on Thursday, May 26, 2011:**

*Maintain average daily turbine release at 4,930 cfs ( $\approx$  3,770 MW-Hrs/day using 31.4 cfs/mw).*

**At 1800 hour on Thursday, May 26, 2011:**

*Maintain average daily turbine release at 4,930 cfs ( $\approx$  3,770 MW-Hrs/day using 31.4 cfs/mw).*

### **YELLOWTAIL BYPASS RELEASE:**

**At 1400 hour on Thursday, May 26, 2011:**

*Increase average daily release through river outlet gates to 500 cfs.*

**At 1600 hour on Thursday, May 26, 2011:**

*Increase average daily release through river outlet gates to 1,000 cfs.*

**At 1800 hour on Thursday, May 26, 2011:**

*Increase average daily release through river outlet gates to 2,000 cfs.*

### **AFTERBAY RELEASE AND OPERATION:**

**At 1400 hour on Thursday, May 26, 2011:**

*Maintain diversions to the bighorn Canal at 0 cfs.*

*Increase river release to 5,500 cfs (gage height = 62.02 with -0.12 shift).*

*Increase total release from the Afterbay to 5,500 cfs.*

**At 1600 hour on Thursday, May 26, 2011:**

*Maintain diversions to the bighorn Canal at 0 cfs.*

*Increase river release to 6,000 cfs (gage height = 62.26 with -0.12 shift).*

*Increase total release from the Afterbay to 6,000 cfs.*

**At 1800 hour on Thursday, May 26, 2011:**

*Maintain diversions to the bighorn Canal at 0 cfs.*

*Increase river release to 7,000 cfs (gage height = 62.72 with -0.12 shift).*

*Increase total release from the Afterbay to 7,000 cfs.*
