**The proposed project consists of transferring approximately 8,500 acre-feet of water per year from Stevenson Water District to wildlife refuges within the San Joaquin Valley. The water transfer agreement is for a three-year period beginning in 2004. The sources of transfer will be approximately 5,500 acre-feet of surface water that has historically been locally transferred and about 3,000 acre-feet of water from a groundwater substitution program.**

9. Surrounding land uses and setting: (Briefly describe the project's surroundings.)

**The project is located in the San Joaquin Valley, in Merced County, surrounding Stevenson Water District. The region is characteristic by valley flatlands and agricultural communities. The District, which is primarily agricultural land, is located at the confluence of the San Joaquin and Merced Rivers.**
