- 1) Please provide a four-digit numerical code which will be programmed to open the gate at Black Canyon Park after 9:00 am on the day of your reservation \_\_\_\_\_.
- 2) The gazebo/shelter is available during day-use hours 9 am to 9 pm only. Camping is not permitted in the gazebo/shelter. Reservations are **only** for the gazebo/shelter, not the entire park.
- 3) Pets are not permitted in the area, except for service animals. Owners are responsible for cleaning up after their pet.
- 4) No vehicles on the grass for any reason. "Responsible Person" may be charged for damage.
- 5) Picnic table may not be moved without permission.
- 6) All areas will be left in a clean and sanitary condition. "Responsible Person" may be charged for damage.
- 7) The rules and regulations for the Black Canyon Recreation Area must be complied with.
- 8) Reservations are not finalized until payment is received.
- 9) In the event that the date needs to be changed you must notify our office two weeks in advance.
- 10) Only one reservation can be on the calendar at a time, when one reservation is complete then you can make arrangements for another reservation.
- 11) Any reservation that is made less than 10 days before the reservation date must be paid by money order, cashier's check, or cash.
