SF <sub>6</sub> has been identified as a greenhouse gas that may be responsible for global warming. Release of SF <sub>6</sub> gas into the atmosphere during maintenance work or an accident must be reduced, tracked, and reported to the EPA. This document describes Reclamation's management and safe handling procedures for SF <sub>6</sub> gas. The document outlines Reclamation's SF <sub>6</sub> emission reduction goals and strategy, reporting procedures, safe handling practices, training, and risk assessment and mitigation program.
