

Subject: Water Systems Operation and Maintenance (O&M) Cost Index for 2012

The Bureau of Reclamation has computed the Cost Index for 2012 to be 4.45. The computation is based on an extrapolation of the Cost Index that utilizes the corresponding average rate increase of the average annual Engineering News Record Construction Cost Index for the previous year.

Please refer to the attached table (Attachment 1) for a listing of historical indexes computed by Reclamation, as well as instructions on how to use the indices in estimating costs (Attachment 2).
