## **IIJA Annual Spend Plan Overview**

### **Introduction**

The Infrastructure Investment and Jobs Act provided the Bureau of Reclamation with funding under Title IX (Western Water Infrastructure) for twelve program and activity areas, with accompanying authorization language for some of the programs. The IIJA provides the Bureau of Reclamation a total of \$8.3 billion to be appropriated in equal increments of \$1.66 billion over five years, to be available until expended.

### **IIJA Funding Plan**

A summary funding table showing total enacted amounts for each program for FY 2022-FY 2025 is shown on the next page—with a starting column (as of the date of the published FY25 Spend Plan) and ending column (as of September 30, 2024) for each program. FY 2026 amounts by program activity are provided based on the remaining balances within the legislated ceilings of each program (in the final year of IIJA appropriations). A summary of activities for FY 2022, FY 2023, FY 2024 and FY 2025 is also provided in the pages below, along with plans for FY 2026.
