On March 15, 2022, the Further Consolidated Appropriations Act, 2022, Public Law 117-103 was enacted providing appropriations for Fiscal Year 2022. The Act included funds totaling \$200,300,000 for the Bureau of Reclamation (Reclamation) that were not specified for particular programs, projects, or activities. In Division D of the Joint Explanatory Statement, which accompanied Public Law 117-103, Congress requested Reclamation to provide to the House and Senate Committees on Appropriations a report delineating how these funds are to be distributed, within 45 days of enactment.

Enclosed please find the report detailing how these funds will be allocated within Reclamation for FY 2022, consistent with Division D of the Joint Explanatory Statement. Additional funding provided for water storage will be allocated according to the process set out in the Water Infrastructure Improvements for the Nation Act, Public Law 114-322.
