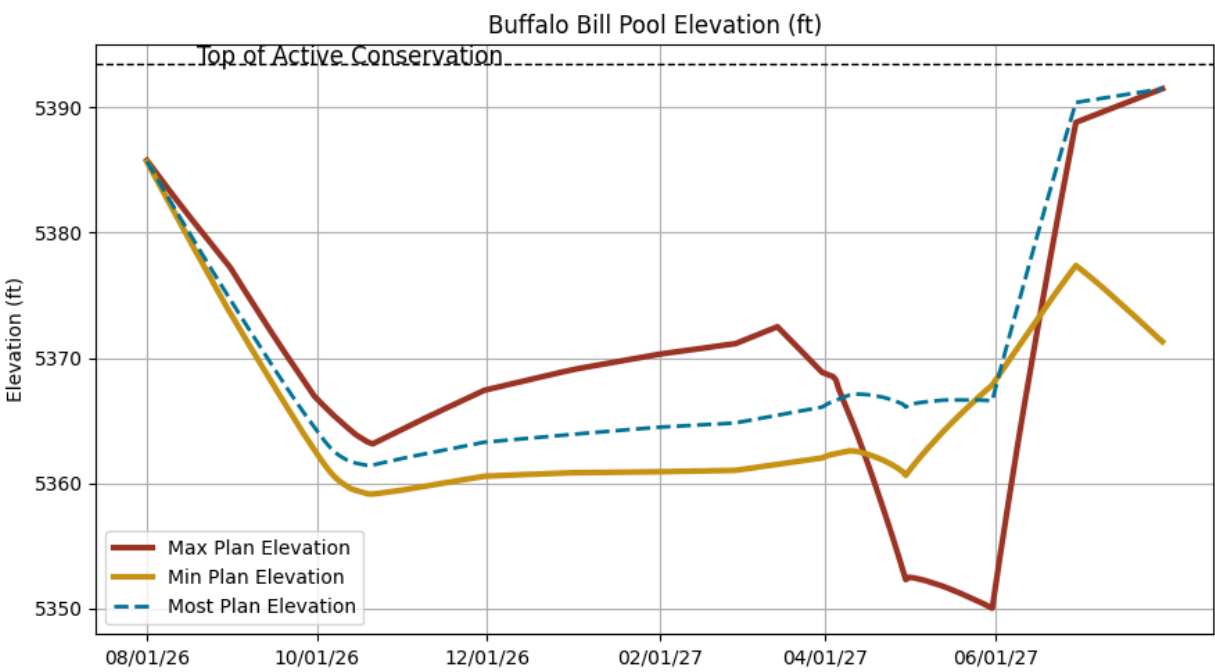


Figure 1: Projected Buffalo Bill Pool Elevations (ft) under the Most Probable, Minimum, and Maximum Plans

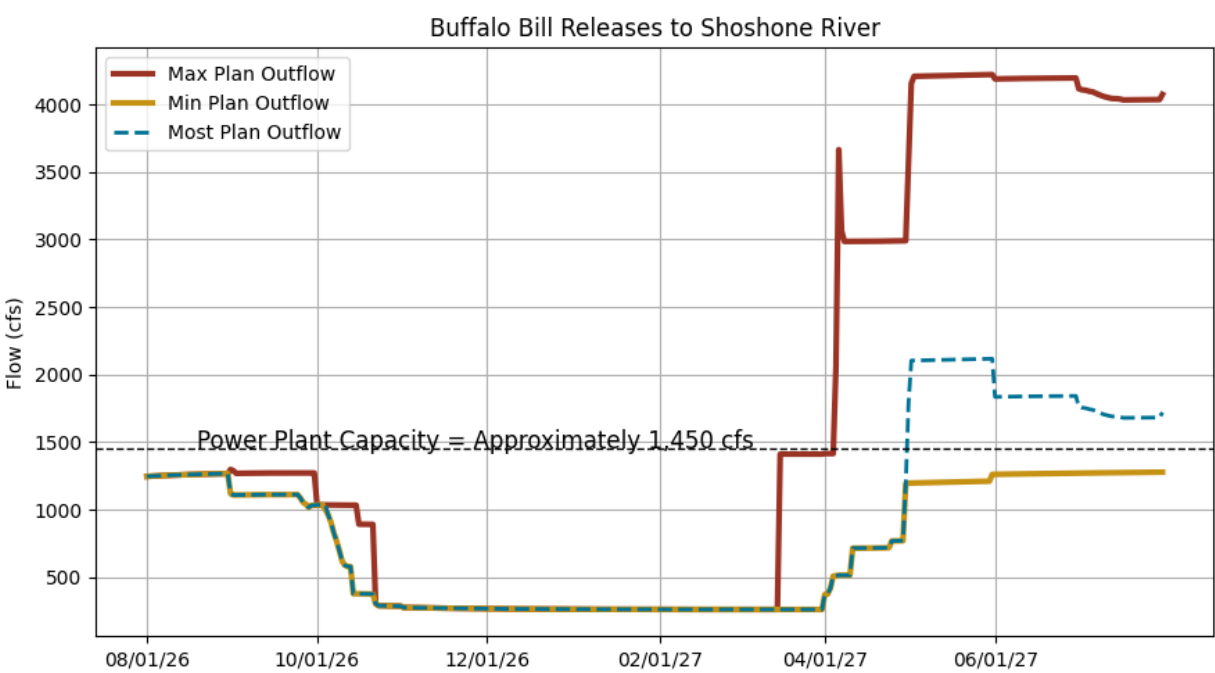


Figure 2: Projected Buffalo Bill Releases to the Shoshone River at Cody Gage(cfs) under the Most Probable, Minimum, and Maximum Plans
