### Introduction

The Dry-Redwater Regional Water Authority (DRWA) was formed by its constituent team members as a regional water authority in 2005 to provide water and sewer services across its service area in eastern Montana. DRWA has since constructed infrastructure projects primarily in areas south of Sidney, Montana. Individual or community groundwater wells with poor water quality currently serve the majority of the DWRA service area. DRWA is proposing a regional water system to provide high quality water to meet the current and future demands of rural towns and individual homes.

DRWA is seeking federal authorization and appropriation to construct the regional water system that will serve five counties in eastern Montana. DRWA previously worked with the U.S. Department of the Interior, Bureau of Reclamation (Reclamation) to complete a regional water system feasibility study under Reclamation's now ended Rural Water Supply Program. Congress authorized and funded Reclamation to continue work on the feasibility study in Public Law 116-260, enacted December 27, 2020. Reclamation's fiscal year 2022 Spend Plan allocated additional funding to complete the Dry-Redwater Rural Water Feasibility Study.

Pursuant to National Environmental Policy Act (NEPA) requirements, Reclamation intends to prepare an Environmental Assessment (EA) to support its feasibility study. This document describes the public scoping activities conducted by Reclamation and DRWA for the Dry-Redwater Rural Water Project (Project).

This scoping report describes the Reclamation/DRWA noticing process, the public scoping meetings, and provides a summary of written and verbal comments received during the public scoping period. At the time of Project scoping, Reclamation served as lead agency for scoping. Since Project scoping was initiated, the Natural Resources Conservation Service (NRCS) has formally accepted the role as a cooperating agency and has designated Reclamation as lead federal agency.

Three federal agencies and one state agency accepted the role as a cooperating agency; US Army Corps of Engineers, US Department of Agriculture, Natural Resource Conservation Service, Western Area Power Administration and Montana Department of Natural Resources & Conservation.

Each of these agencies designated Reclamation as the lead federal agency for NEPA, Section 7 of the Endangered Species Act, and Section 106 of the National Historic Preservation Act (NHPA). NRCS defined their role and responsibilities as a cooperating agency as follows:

The purpose of NRCS cooperation is to ensure that the project EA substantially satisfies NRCS requirements for compliance with the National Environmental Policy Act (NEPA) 42 U.S.C. §§ 4321–4347, and Guidance for Conducting Analyses Under the Principles, Requirements, and Guidelines (PR&G) for Water and Land Related Resources Implementation Studies and Federal Water Resource Investments DM 9500-013 (USDA NRCS, 2017). As a cooperating agency, NRCS anticipates our involvement will or may include:

- 1. Attending coordination meetings related to NRCS proposed actions.
- 2. Writing a Finding of No Significant Impact as our decision-making document and Notice of Availability, if applicable.
- 3. Supplementing the project EA with additional NRCS requirements related to coordination, consultations, and authorization, if not provided in the project EA.

The state or local agencies contacted are not continuing as Cooperating Agencies but will continue their involvement as interested parties.

### **Native American Tribal Consultation**

Tribal consultation is required by NEPA when a federally recognized tribe may be affected by a project. On November 7, 2023, Reclamation sent letters (Attachment B) to the following Native American tribes:

The letters invited the tribes to participate in the NEPA process and NHPA Section 106 consultation process for the Project and requested information under Section 106 of the NHPA regarding the identification of cultural resources in the Project area. Reclamation conducted additional efforts, including phone calls and emails, to confirm receipt of the letters. As of September 30, 2024, no tribes have requested consultation.

# **Summary of Scoping Comments**



The passage of the 2006 Rural Water Supply Act authorized Reclamation and DRWA to initiate a feasibility study intended to provide safe drinking water to communities within the DRWA service area. These initial planning and project design efforts continued through 2016.
