

DAM TAX TOTAL TO BE INCREASED

Approximately \$215,000
Will Be Collected, Ac-
cording to Assessor

Total taxes to be collected on personal property located within the so-called Boulder dam reservation will reach approximately \$215,740.77, according to figures prepared today by County Assessor F. C. DeVinney, who states that all property there has been on the assessment rolls and that nothing will be lost through the delay in making final decision on the liability of the property for taxes.

As was stated in yesterday's Review-Journal, Six Companies and its subsidiaries will pay all taxes due for 1931, 1932 and 1933 within the next few days. Other taxes have been collected at intervals for 1931 and 1932 and the

amount due for 1933 will be collected within the next few days from the other owners of personal property in that area, DeVinney states.
