 - Includes Santa Cruz Basin, Gila chub, and Chiricahua leopard frog
 - Duncan is working on the take statement for the biological opinion
- 5. Any edits to the program strategic plan? (Sorensen)
 - Clarkson provided Sorensen with some hardcopy edits to an earlier draft—most of those edits were already incorporated; remaining edits to be considered.
- 6. External partner opportunities--i.e. SRP's HCP and Desert Fish Habitat Partnership (Paradzick, Messing, Sorensen)
 - Paradzick provided a handout on SRP's HCP and described how it compliments and furthers the Gila River Basin Native Fish Conservation Program's efforts
