Subject: Notice of Availability – Draft Environmental Assessment for the Proposed CO Bar Solar Interconnection Project – Coconino County, Arizona (Action by 30 days from the date of this letter)

Dear Interested Party:




Figure 1. CO Bar Solar Interconnection Project overview.

The U.S. Bureau of Reclamation (Reclamation) has prepared a Draft Environmental Assessment (EA), describing the potential impacts of CO Bar Solar, LLC's proposed interconnection of the CO Bar Solar Complex to the Navajo Southern Transmission System (NSTS) at the Moenkopi to Cedar Mountain 500-kilovolt (kV) transmission line, referred to as the CO Bar Solar Interconnection Project (or Interconnection Project) (Figure 1). Reclamation is a part owner of the NSTS and must approve any interconnection requests.




Figure 2. CO Bar Solar Interconnection Project detail.

The CO Bar Solar Complex will consist of several utility-scale, photovoltaic solar energy generation facilities with a total capacity of 1,000 megawatts (MW) located approximately 30 miles northwest of Flagstaff, Arizona. The Interconnection Project would deliver power generated by the CO Bar Solar Complex to the existing Arizona Public Service (APS)—operated Moenkopi to Cedar Mountain 500-kV transmission line, which crosses through the CO Bar Solar Complex. The proposed point of interconnection is a planned APS 500-kV line tap and switchyard. The Interconnection Project would include collection lines, a collector substation, intertie line(s), improvements within the APS 500-kV switchyard, and temporary laydown areas; maximum output to the NSTS would be 1,000 MW (Figures 1 and 2).

The Interconnection Project would also include improvements to approximately 4.5 miles of roads managed by the U.S. Forest Service (Forest Service) Coconino National Forest (COF); therefore, the Forest Service is participating as a cooperating agency in the National Environmental Policy Act review. CO Bar Solar, LLC, has submitted a special use permit application to the COF for improvements to National Forest Service Road (NFSR) 417 and NFSR 9003 (Figure 1). Aaron Mayville, Forest Supervisor, is the responsible official for the portion of the Interconnection Project on National Forest System (NFS) lands. The COF considers this request in accordance with 36 Code of Federal Regulations (CFR) Part 251, Subpart B, and if approved, would issue a separate decision and the special use permit for long-term use of National Forest lands. The activities proposed on NFS lands are a project implementing the COF's land management plan and are not authorized by the Healthy Forest Restoration Act. As such, proposed activities occurring on NFS lands are subject to the pre-decisional administrative review process at subparts A and B of 36 CFR 218. Only those who submit timely and specific written comments regarding the proposed project or activity during a designated public comment period established by the lead agency are eligible to file an objection under 36 CFR 218.
