Subject: Notice of Availability (NOA) – Final Environmental Assessment (EA) and Finding of No Significant Impact (FONSI) for the Proposed CO Bar Solar Interconnection Project, Coconino County, Arizona (Action by 30 days from the date of this letter)

Dear Interested Party:

The United States (U.S.) Bureau of Reclamation (Reclamation) has prepared a Final EA and FONSI describing the potential environmental effects of CO Bar Solar, LLC's proposed interconnection of the CO Bar Solar Complex to the Navajo Southern Transmission System (NSTS) at the Moenkopi to Cedar Mountain 500-kilovolt (kV) transmission line, referred to as the CO Bar Solar Interconnection Project. Reclamation is a part owner of the NSTS and must approve any interconnection requests.

The Final EA considers the impacts of Reclamation's approval of the interconnection at the Moenkopi to Cedar Mountain 500-kV transmission line. Reclamation has determined that the proposed project does not constitute a major federal action significantly affecting the quality of the human environment, and therefore an Environmental Impact Statement is not required. Reclamation initially solicited input from the public on the proposed project to assist in identifying key issues and defining the scope of the project and environmental analysis. On March 10, 2023, Reclamation sent scoping letters to 96 potentially interested individuals, stakeholders, tribes, and organizations and announced public scoping via a newspaper notice and internet publications. Within the 30-day scoping period, Reclamation received four comment letters.

Following scoping, Reclamation issued a Draft EA that presented the proposed project, existing conditions in the project area, and the environmental effects that would be reasonably expected from implementing the Proposed Action (Selected Alternative) and No Action alternative. The Draft EA was published on August 8, 2023, initiating a 30-day public comment period. Reclamation sent a NOA for the Draft EA to all entities on the mailing list and any commenters from scoping. The NOA and Draft EA were also advertised in the *Arizona Daily Sun*, on

Reclamation's website, and on the U.S. Forest Service's website (a cooperating agency). Four comment letters were received during the Draft EA comment period, which did not result in changes to the Final EA.
