Subject: 2014 Water Order for Colorado River Water

This letter transmits the Coachella Valley Water District (CVWD) 2014 water order for consumptive use of Colorado River water. The order equates to consumptive use of approximately 352,000 acre-feet of Colorado River water at Imperial Dam.

The Colorado River water order reflects the subtraction of:

- 26,000 acre-feet for Coachella Canal Lining, and
- 3,000 acre-feet for Present Perfected Rights;

And the addition of:

- +20,000 acre-feet from the 1988 IID-MWD Water Conservation Agreement
- +31,000 acre-feet from IID-CVWD Acquisition Agreement (2003 QSA), and
- +0 acre-feet from the Agreement for 35,000 Acre-Feet Exchange Water (2003 QSA, MWDSC).

Enclosed are CVWD's monthly consumptive use estimates for Colorado River water. These estimates include direct and in-lieu groundwater recharge for the benefit of Improvement District No. 1. Also enclosed is CVWD's Part 417 Consultation Questionnaire for 2014.
