Subject: Central Arizona Project (CAP) 2023 Diversion Modification 2

Dear Ms. Gould,

On September 29, 2022, Central Arizona Water Conservation District (CAWCD) notified Reclamation of its estimated 2023 diversion of Colorado River water of 1,153,600 acre-feet (AF). The estimated diversion accounted for Arizona's Tier 2a Reduction of 400,000 AF; and per the 2019 Drought Contingency Plan (DCP), an additional mandatory contribution of 192,000 AF, estimated water orders, existing conservation agreements, and CAWCD Intentionally Created Surplus (ICS) withdrawal. In addition, CAWCD provided CAP Diversion Modification #1 on June 15, 2023, to increase CAP's water diversion to 1,155,633 AF to include 2,033 AF for the Town of Queen Creek pursuant to the Reclamation wheeling contract 20-XX-30-W0691.

On January 24, 2023, CAWCD finalized its plans and published its Annual Operating Plan (AOP) resulting in a planned 2023 diversion of 1,164,764 AF including a release of up to 80,528 acre-feet of CAWCD ICS. The diversion reflects all finalized CAP water orders, and existing conservation agreements known at the time, as with conservation activities, reflected in the table below. This modification adjusts CAP's water order to 1,166,797 AF to accommodate the planned diversion in CAP's published AOP as well as CAP's Diversion Modification #1.

Subject: Central Arizona Project (CAP) 2023 Diversion Modification #3

Dear Ms. Gould,

On September 29, 2022, Central Arizona Water Conservation District (CAWCD) notified Reclamation of its estimated 2023 Colorado River water diversion of 1,153,600 acrefeet (AF). The estimated diversion accounted for Arizona's Tier 2a Reduction of 400,000 AF; and per the 2019 Drought Contingency Plan (DCP), an additional mandatory contribution of 192,000 AF, estimated water orders, existing conservation agreements, and CAWCD Intentionally Created Surplus (ICS) withdrawal. In addition, CAWCD provided the following letters:

- CAP Diversion Modification #1 on June 15, 2023, to increase CAP's water diversion to 1,155,633 AF to include 2,033 AF for the Town of Queen Creek pursuant to the Reclamation wheeling contract 20-XX-30-W0691.
- CAP Diversion Modification #2 on July 27, 2023, to increase CAP's water diversion to 1,166,797 AF to accommodate the planned diversion in CAP's published AOP as well as CAP's Diversion Modification #1.

This modification incorporates a reduction in CAP's diversion of 41,776 AF of Intentionally Created Surplus (ICS) withdrawal resulting from CAP subcontractor participation in the 2023 CAWCD/ADWR ICS Preservation Program and a reduction of 246,652 AF in CAP's diversion resulting from system conservation agreements developed pursuant to the Lower Colorado River Basin System Conservation and Efficiency Program. After consideration of these reductions, CAP's revised diversion estimate is 855,094 AF. This diversion letter also acknowledges the additional System Conservation Implementation Agreements between Reclamation and MVIDD, YMIDD, Gabrych, Cathcarts, and CVIDD.

Should there remain an excess to the total state apportionment after the final accounting, CAWCD requests that this excess be accounted to CAWCD prior to the delivery of CAWCD ICS. Conversely, CAWCD requests that Reclamation use up to 50,000 AF of CAWCD ICS to address any exceedance of diversions to the volume available to CAWCD under the adjusted state apportionment. Should the final accounting reveal that 50,000 AF is insufficient to accommodate CAWCD's diversion without creating an inadvertent over-run, CAWCD requests that Reclamation consults with CAWCD to identify measures to address such an overrun.

CAWCD will continue to coordinate with Reclamation and make additional adjustments to its water order should any new conservation developments occur through the end of the year.
