Subject: Bureau of Indian Affairs' (BIA) Approval of Calendar Year (CY) 2025 Tribal Colorado

River Water Diversions

Dear Ms. Durham:

The Bureau of Reclamation received BIA's memorandum dated November 21, 2024, through which BIA provided its formal determination of CY 2025 Colorado River water diversions for the Fort Mojave, Colorado River, Cocopah, Chemehuevi, and Fort Yuma (Quechan) Indian Tribes (Tribes). In accordance with Title 43, Code of Federal Regulations Part 417, this memorandum provides BIA with notice that Reclamation has no comments or objections to BIA's determination. The diversion amounts for each tribe as approved per the determination made by BIA are reflected in the enclosed Table 1.

On August 15, 2024, Reclamation released its Colorado River Basin August 2024 24-Month Study, which projects Lake Mead's most probable elevation on January 1, 2025 to be 1,062.32 feet. In its letter dated August 26, 2024, Reclamation announced that, in accordance with the 2007 Interim Guidelines, Lake Mead and the lower Colorado River will operate in a Tier 1 Shortage Condition in CY 2025. In addition, the 2019 *Lower Basin Drought Contingency Plan Agreement* (LB DCP Agreement) will also govern the operation of Lake Mead for CY 2025. The CY 2025 Shortage Condition and DCP Contributions required by the LB DCP Agreement do not impact the available Colorado River water supply for the Tribes.

Reclamation would like to highlight that, in accordance with the *Inadvertent Overrun and Payback Policy*,³ accumulations of inadvertent overruns are not permitted in CY 2025 and are suspended as long as a Shortage Condition is in effect. To assist entitlement holders in monitoring their Colorado River water use to ensure they remain within available quantities,

Reclamation will project CY 2025 diversions and consumptive use of Colorado River water during CY 2025 and will make these projections available daily on Reclamation's website beginning in January 2025. Reclamation encourages Colorado River water entitlement holders to use the projections to adjust diversions to remain within their Reclamation-approved annual Colorado River water order.

The Cocopah Indian Tribe's diversion entitlement shown above includes an estimated entitlement for use on the Cocopah Indian Tribe's Fee land parcel located within a portion of the area described in Present Perfected Right No. 7. The amount of this entitlement is currently under review.

³ The Consolidated Decree entered March 27, 2006, in Arizona v. California et al (547 U.S. 150 (2006)) allocates 71,616 acre-feet for lands within the boundaries of the Fort Yuma Indian Reservation in the State of California. In accordance with the settlement agreement executed on February 24, 2005 among the Quechan Indian Tribe (Tribe), the United States, The Metropolitan Water District of Southern California (MWD), the Coachella Valley Water District, and the State of California: (1) only 64,616 acre-feet are immediately available to the Tribe; (2) the full 71,616 acre-feet will become available to the Tribe in Year 2035; and (3) 13,000 acre-feet immediately available to the Tribe are available for diversion by MWD through Year 2035 contingent upon conditions set for the in the 2005 settlement agreement and a forbearance agreement between the parties. Pursuant to SCIA No. 23-30-W0783, the Tribe and MWD agree that the 13,000 acre-feet of water previously forborne by the Tribe and made available for diversion by MWD through the February 14, 2005 settlement agreement will instead remain in Lake Mead as System Conservation Water.
