Dear Chairman Williams:

On November 20, 2025 a virtual meeting attended by representatives of Avi Kwa Ame Farms, the Bureau of Reclamation, and the Bureau of Indian Affairs (BIA) was held. The purpose of the meeting was to engage in a 43 CFR, Part 417 (Part 417) consultation with the Ft. Mojave Indian Tribe (Tribe). During this consultation meeting the Tribe's 2026 Colorado River water usage requirements and plans were discussed.

With consideration given to discussion held during the aforementioned consultation meeting and in fulfillment of responsibilities described in Part 417, the Regional Director, Western Regional Office, BIA has formally determined the Tribe's 2026 Colorado River water order. This water order is provided in the table below. The water order figures are equivalent to the estimated diversions for agriculture previously provided by Mr. Andrew Harter, General Manager, Avi Kwa Ame Farms. A copy of the Tribe's completed consultation questionnaire, which includes a diversion estimate table, is enclosed.
