(Through December 31, 2015)

2015 Calculations

1. **Mammal Ponds:** 365 days x 0.42 acre-feet (AF)/day = 153 AF*
* 56 ponds x 1.7 gpm x 0.0044 = 0.42 AF/day estimated by GEI Hydrologist

2. **Unlined Canal Recharge:** 1,932 AF — ACTUAL

3. **Dos Palmas/AquaFarms Recharge (8" Siphon):** 1,118 AF — ACTUAL

Total 2015 Environmental Mitigation Water Used: 3,203 AF
