<sup>1</sup> In accordance with the Settlement Agreement in Arizona v. California By And Among The Quechan Indian Tribe of the Fort Yuma Indian Reservation, the United States of America, The Metropolitan Water District of Southern California, Coachella Valley Water District, and the State of California, dated February 14, 2005, the Quechan Tribe and the Metropolitan Water District of Southern California agree that 7,000 acre-feet or the amount necessary to supply the consumptive use required for irrigation of 1,049.47 acres, and for the satisfaction of related uses, whichever is less, shall be allowed to pass through the priority system and be diverted by Metropolitan. Beginning in calendar year 2035, and continuing thereafter, this water shall become available to the Quechan Tribe.
