Upper Basin Depletion Schedule

This attachment to the Colorado River Interim Surplus Criteria DEIS consists of a table displaying the schedule of projected Colorado River system depletions, or consumptive use, by the Upper Basin States. These depletions were used in the Colorado River Simulation System to model the operation of the river system under baseline conditions and the interim surplus criteria alternatives. Shown in the table are projected depletions of the Upper Division States and Arizona's apportionment of water from the Upper Basin. The depletion schedule was developed in 1996 and was provided by the Upper Colorado River Commission. The Commission developed a new schedule in December 1999 that will be used in the Colorado River Interim Surplus Criteria FEIS.
