Subject: Bureau of Reclamation Mussel Task Force

Reclamation has formed a Mussel Task Force to develop strategies to address the infestation of mussels in the Western river basins. The Task Force will provide a forum for Reclamation to corporately communicate, discuss, and collaborate on mussel related activities, issues, and priorities. The new representative for the Lower Colorado Region is Mr. Leonard Willett, Water Treatment Group Manager of the Lower Colorado Dams Office.

Implementing control and mitigation strategies is important to manage both the long- and shortterm economic and environmental consequences from the infestation of the zebra and quagga mussels. The Task Force recommends that we work closely with our partners, customers, contractors, and state and local governments to implement a four-part strategy of:

- Outreach and education
- Research
- Monitoring and prevention of infestation
- Control and mitigation.

Each region has developed a Regional Mussel Task Force that will work with and report its activities to the corporate team. The Lower Colorado Regional Task Force members are:
