- Operational Updates

- CVP: Lewiston Dam releases at 2,150 cfs, long ramp down through end of June. Whiskeytown Lake is refilling - Whiskeytown Dam releases at 200 cfs (cut down from 225 cfs on 5/6) spring pulse expected mid-month. Keswick Dam releases at 8,000 cfs, spring pulse – 5/9 at 14,000 cfs. Nimbus Dam releases at 3,500 cfs (refill storage management). Goodwin Dam releases at 400 cfs with a Stepped Release Plan spring pulse increasing through 5/10 (peak, pulse extends through end of May). Jones Pumping Plant is exporting 900 cfs (within Controlling requirement D1641) increasing exports when conditions are amenable. Federal share of San Luis Reservoir is 800 TAF. Delta Cross Channel remains closed throughout late May unless water quality issues.
- SWP: Feather River (Oroville-Thermalito Complex) releases are at 1,900 cfs (going down to 1,700 cfs on 5/8). Clifton Court is exporting 600 cfs. Banks Pumping Plant is offline until 5/9 for maintenance. State share of San Luis Reservoir is 825 TAF.
- Hydrology Update
  - Dry weather ahead and no rain in the forecast.
