#### • Operational Updates

- CVP: Lewiston Dam releases at 1,000 cfs, ramp down into June. Whiskeytown Dam releases at 175 cfs (150 cfs on 6/5). Keswick Dam releases at 8,500 cfs (9,000 cfs on 6/6 for downstream demands). Nimbus Dam releases at 2,500 cfs. Goodwin Dam releases at 1,700 cfs (monthly Vernalis target). Jones Pumping Plant is exporting 2,700 cfs (3,200 cfs on 6/7, OMRI -5,000 cfs and D1641). Expecting a transition period with excess/balanced conditions, estimating 1 Chipps day in June, expecting export variability, coordinating with the State on export flexibility. Federal share of San Luis Reservoir is 620 TAF. Delta Cross Channel is currently closed and planned to open on Friday 6/6 and to close on Monday 6/9.
- SWP: Feather River (Oroville-Thermalito Complex) releases are at 2,100 cfs (potential increases later in the week). Clifton Court Forebay is exporting 3,200 cfs. State share of San Luis Reservoir is 664 TAF.
