### **Review Operations Outlook**

- At Oroville Dam on the Feather River, releases are 4,500 cfs.
- CCF exports are 1,700 cfs today (6/17) and will hold for at least the next couple of days.
- At Whiskeytown Dam on Clear Creek, releases are expected to range from 200 cfs to 500 cfs this week.
- At Keswick Dam on the Sacramento River, releases are 11,500 cfs today (6/17) and increasing to 12,000 cfs tomorrow (6/18). Wilkins Slough is being monitored to ensure that there is enough water for downstream contractors.
- At Folsom Dam on the American River, releases are 2,500 cfs.
- At Goodwin Dam on the Stanislaus River, releases are 1,200 cfs and are expected to range from 700 cfs to 1,500 cfs this week.
- JPP exports are 3,200 cfs.

- The X2 Delta Outflow target is 7,100 cfs, but there is also a need to monitor the 0.45 EC water quality standard in the Delta.
- DCC gates are closed during the week and will be opened this Friday (6/20) until further notice reflecting summer operations.
- The combination of reduced natural flows, increased irrigation demand, warmer weather, the expiration of export restrictions during April and May, and higher tides has resulted in significant concerns with water quality in the West Delta, but water quality appears to have stabilized.

# Review Longfin Smelt (LFS) Distribution and ITP Triggers (DWR)

Facilitator's note: Due to the new ITP, DMW will only review the Weekly Fish and Water Operations Outlook. A review of the Risk Assessment may occur if a real-time trigger occurs.

Reclamation shared that larval and juvenile entrainment protection is active, but it was
not triggered by the last 20-millimeter Survey 7 with a recorded Secchi disk depth of
149. The OMR management season for Delta smelt and Longfin smelt will conclude
when three consecutive days of daily mean water temperature at Clifton Court is greater
than or equal to 25°C or on June 30, whichever occurs first. The last three days of
temperature readings were 23.2°C, 23.5°C, and 23.8°C. Conditions are getting closer to
the threshold, but June 30 may be the off ramp date.
