Delta Smelt Consolidated Cases – Ninth Circuit Court of Appeals

- Petition for Rehearing En Banc
 - Opinion issued March 13, 2014
 - Mandate issued September 16, 2014
 - District Court issued Revised Final Order October 1, 2014
 - Judgment is entered in favor of San Luis Plaintiffs' Sixth
 Claim for Relief that Reclamation violated NEPA
 - Judgment is entered in favor of Federal Defendants and Defendant-Intervenors on all remaining claims

Petition for Writ of Certiorari

- Stewart & Jasper Orchards, Arroyo Farms LLC, and King Pistachio Grove
 - 1. Is the Service obligated to demonstrate how a Reasonable and Prudent Alternative (RPA) is economically feasible?
 - 2. To what extent (if any) is the Service's interpretation of its own regulation defining RPA entitled to deference?
 - 3. Does the decision of this Court in *Tennessee Valley*Authority v. Hill, still require federal agencies to protect species and their habitat "whatever the cost"?

Petition for Writ of Certiorari

- State Water Contractors, et al.
 - 1. Whether the Secretary must address in the administrative record the economic and technical feasibility of RPAs including the effects of the proposed alternatives on third parties.
 - 2. Whether the Secretary may disregard the "best scientific data" on the ground that considering the data would lead to a less "conservative" result, because scientific certainty is impossible, or because the Secretary has considered a range of data in reaching a conclusion.

Salmonid Consolidated Cases

- Ninth Circuit Court of Appeals hearing was held on September 15, 2014, in San Francisco
- Several months to several years before an opinion may be given

Draft Alternatives for Remand EIS

EIS Draft Alternatives Analyses

- No Action Alternative (NAA)
- Second Basis of Comparison (SBC)
- Alternatives 1 6
- Alternatives compared to NAA and SBC
- Alternatives and SBC include sea level rise and climate change for 2030
- Analyses will consider potential for water transfers

NEPA NAA and SBC

NAA

- Continuation of existing policy and management direction in Year 2030
- CVP and SWP operations with the RPA actions from the 2008 Fish and Wildlife Service (FWS) and National Marine Fisheries Service (NMFS) biological opinions

SBC

- CVP and SWP operations without RPA actions
- Include actions that are:
 - Constructed (e.g., Red Bluff Pumping Plant)
 - Legislatively mandated (e.g., San Joaquin River Restoration)
 - Substantial progress (e.g., Yolo Bypass Salmonid Habitat Restoration and Fish Passage)

EIS Draft Alternatives

- NAA
- Alternatives 1 -5
 - Comments and information received during preparation of the EIS
- Alternative 6
 - Consideration of all alternatives
 - Informed by preparation of the Draft ESA Proposed Action

EIS Draft Alternatives

- Range of alternatives and major differences
- Examples of major differences
 - Old and Middle River (OMR) criteria
 - New Melones Reservoir operations
 - Delta outflow and other operational criteria
 - Non-operational concepts



Section 7 Consultation Preliminary Draft Proposed Action

- Based on 2011 Proposed Action (PA) with modifications
 - D-1641
- Example of modifications
 - 2008 FWS RPA
 - New Melones Revised Plan of Operations
 - Red Bluff Pumping Plant
 - Yolo Bypass Salmonid Habitat Restoration and Fish Passage
 - Drought Process Language


Section 7 Consultation Approach

- Preliminary Draft Proposed Action in response to the Mandate
- The NEPA Process should inform the ESA Draft PA
- If changes result in effects not previously considered in the 2008 BO, then Reclamation and DWR would consult with FWS

Section 7 Consultation Approach

- Phase 1
 - Complete Preliminary Draft PA to inform Alt 6
 - Analyze Alt 6 and other alternatives
 - Review preliminary assessment to determine if Draft PA should be modified
- Phase 2: Public Draft EIS/Comment
 - Consider public comments to inform if additional modifications to the PA are warranted
