## To all parties and their counsel of record:

On December 20, 2012, Plaintiff-Intervenor California Department of Water Resources ("DWR") and Federal Defendants jointly moved this Court for an extension of the deadlines in the remand schedule. Doc. 1080. That motion was noticed for hearing on January 24, 2013, at 8:30 a.m., or as soon as this matter may be heard in the Courtroom of the Honorable Lawrence J. O'Neill. A similar motion for extension of the remand schedule was made in the related *Consolidated Salmonid Cases*, Civ. No. 09-105, and noticed for the same date and time (Doc. 713).

While Federal Defendants and DWR have not requested a hearing in either case and do not oppose the motions being decided on the papers, in the event the Court will hold hearings on the motions, Federal Defendants have continued the hearing date in the related *Consolidated Salmonid Cases*, Civ. No. 09-1053, by one week — from to January 24 to January 31, 2013 – to accommodate the scheduled travel of counsel for Federal Defendants in that case. A similar continuance of the hearing date in this case is appropriate so that any hearing on the joint motion to extend the remand schedule in this case (Doc. 1080) may be heard together with the corresponding motion in the *Consolidated Salmonid Cases* (Doc. 713). Pursuant to Local Rule 230(c), opposition or response, if any, to the granting of the motion shall be due on or before January 17, 2013. Pursuant to Local Rule 230(d), a reply to any opposition shall be due on or before January 24, 2013.
