Additional Notes on Discussion Items

- Introduction
 - Spent a few minutes on introductions
 - Reviewed purpose of group from OMR Guidance Document
- Review Fish and Water Operation Outlook
 - Reclamation and DWR operators reviewed Fish and Water Operation Outlook
 - Largest tides of the year this week and next. Cautious about this with water quality. Exports are so low because DCC are closed and water quality is not very good. Delta outflow is being met.
- Review PA Assessment and ITP Assessment from Smelt Monitoring Team (SMT) and Salmon Monitoring Team (SaMT)
 - o Reviewed executive summary from PA assessment.
 - Reviewed Longfin Smelt update from ITP assessment. Longfin Smelt seem to be moving upstream and should be spawning quite soon.
- Provide information in DMW notes for consideration by DWR and Reclamation.
 - o The question was asked how we calculate risk. Reclamation responded that they do not calculate risk in the weekly assessment. The monitoring teams review information and takes input on the assessment questions to assess if Reclamation is staying within the effects described in the PA and BiOps.
 - The question was asked if there would be an opportunity for written input. One option is for the members to provide circulate written input to the staff (Josh Israel and Lenny Grimaldo) for inclusion in the notes. It should be noted, this is not the guidance provided for the DMW. DMW members should plan to review documents prior to the workgroup meeting and plan to provide verbal (and written) input during the meeting for the notes.
