Additional Notes on Discussion Items

- Introduction
- Review Fish and Water Operation Outlook
 - No anticipated changes in operations on Clear Creek, Keswick, Oroville, or Nimbus.
 - Wilkins Slough seeing some accretions, but not much expected from this storm, most of storm appears to be snow.
 - Stanislaus instability flows starting this week.
 - Exports at JPP may increase dependent on favorable conditions. DCC gates closed.
 - o Monthly January average outflow is 4500 cfs.
- Review PA Assessment and ITP Assessment from Smelt Monitoring Team (SMT) and Salmon Monitoring Team (SaMT)
 - o Reviewed executive summary from PA assessment.
 - Jersey Point LFS larvae observed and ITP risk assessment requires binning exercise to consider general entrainment risk under different OMR (-2,500 and -5,000) to provide more information. Will use similar particle tracking information until new distribution or operational change occurs.
 - What is the timing of production and surrogate releases and anticipated number? Three surrogate releases are planned.
- Provide information in DMW notes for consideration by DWR and Reclamation.
 - o If there is PTM being done, it would be helpful to include model input and results in appropriate assessment.
 - o It may be good to note if the Bay Study did not go out in December.
 - How long does SLS data take to get into the database? SLS will not be run until 1/11. Typically the data is posted at end of the week of the survey.
