Additional Notes on Discussion Items

- Introduction
 - Review Fish and Water Operation Outlook
 - Minimum releases on Trinity, Keswick, Oroville, and Stanislaus, will reduce releases this week at Nimbus
 - o Exports at JPP may increase, SWP to hold. DCC gates closed.
 - No weather in the forecast this week. Colder and possibly wetter weather next week
- Review PA Assessment and ITP Assessment from Smelt Monitoring Team (SMT) and Salmon Monitoring Team (SaMT)
 - o Reviewed executive summary from PA assessment.
 - Not close to PA performance measures, migrating salmonids continue to enter the Delta.
 - Winter run JPE has been finalized by the IEP PWT, this information has been given to NMFS. NMFS will provide a letter when it does.
 - Check out the SacPAS site for more information that the SMT is reviewing, using, and considering.
 - o No non-consensus issues from SaMT or SMT teams for WOMT this week.
 - o One Delta smelt observed in Sacramento deepwater ship channel.
 - o Precipitation may occur, but turbidity and flows are not likely to exceed levels indicative of first flush. Currently there is a wind driven turbidity event, but it has not moved into the south Delta as of this afternoon.
- ITP Assessment update:
 - LFS larvae observed in Cache Slough at site considered regarding Barker Slough operations. Barker Slough operations will be implemented in line with LFS protections based on presence of LFS at SLS sites. Next SLS is next week, spawning likely to increase and should be seeing more in the next survey.
- Provide information in DMW notes for consideration by DWR and Reclamation.
 - o Interest in how PTM are being used in risk assessment.
