Review Operations Outlook (Randi Field, USBR and Mike Ford, DWR)

- Q: How long can we maintain 5 units at Jones?
- R: That will depend on when we see the creep of those base flows that are flattening out upstream. We did receive some Stockton precipitation that has influenced outflow parameters. There will be a dryer spell coming in a few days and at that point we may creep back down.
- C: Stockton got additional 0.4 inches of precipitation today that hasn't shown up yet that will go into that outflow calculation.
- R: Appreciate that point. We will be more constrained after Delta inflows subside. We will be watching salinity this weekend.
- R: We are coming close to EI as well, which is another factor to be considered.

Review PA Assessment (Suzanne Manugian and Ian Smith, USBR)

- Q: Is there an estimated time for the Winter Run JPE to be released?
- R: The first kick off for that effort is in the process of being scheduled. Based on past year's schedules it may be January when the JPE is released. SaMT representatives can bring back an update to this group, as more detail on timing is available.
