#### Review PA Assessment (Suzanne Manugian and Ian Smith, USBR)

- Q: Loss of steelhead wasn't covered in your overview. Didn't CDFW report a salvage of 4 fish?
- R: To clarify, the loss described in the assessment and outlook was loss of natural fish, which has not occurred in the last week. The combined total hatchery steelhead loss is 17.32 fish. The combined total natural juvenile steelhead loss is 3.4 fish.

#### Review ITP Risk Assessment (Felipe La Luz, CDFW)

- Additional note that the ITP Risk Assessment document this week contains additional
  information, including the basis of advice, the exact language from the ITP and a discussion
  of the conditions of approval that have been considered. There are also four attachments,
