# Review Operations Outlook (USBR, DWR)

- Experiencing some unsettled weather during the transition to spring; expecting warmer weather during the middle of this week with some chance of precipitation later this week, but no measurable amounts in the Sacramento or San Joaquin Valleys.
- Whiskeytown Dam is currently releasing base flows of 200 cfs into Clear Creek.
- Keswick Dam is currently releasing minimum flows of 3,250 cfs into the Sacramento River with no anticipated changes.
- Recently crossed the four million-acre-foot mark at Shasta Reservoir, indicating storage recovery there.
- Nimbus Dam is currently releasing 7,000 cfs into the American River with no anticipated changes; currently monitoring inflows from increased snowmelt in the system due to changing weather conditions.
- In the San Joaquin system, Goodwin Dam is currently releasing 1,500 cfs into the Stanislaus River. There is planned fishery egg basket retrieval on 4/17/2023 and 4/18/2023 which will cause flows to reduce to 300 cfs for a short duration before rising back to 1,500 cfs.
- In the Delta, there are diminishing flows from both the San Joaquin and Sacramento Rivers.
- Daily average flows at Freeport for yesterday was approximately 41,000 cfs.
- Daily average flows at Vernalis for yesterday was approximately 32,000 cfs.

- There are no regulatory constraints controlling operations during high flows; currently seeing a net Delta outflow index of 71,500 as of yesterday (04/10/2023).
- Daily OMRI is grater than +12,500 cfs.
- JPP is currently exporting 1,600 cfs with some anticipated variability.
- Operations at San Luis Reservoir have filled for CVP and SWP and managing for direct conversions; adjustments will be made accordingly depending on variability.
- DCC Gates are closed and will remain closed for seasonal operations.
- Oroville releases are at 10,500 cfs today (04/11/2023); there is a 25,000 acre-foot pulse flow as a result of the amended ITP from CDFW on temporary urgency change communications that were filed by DWR; these releases will stay up for about a week before dropping back to 7,500 cfs.
- Article 21 demands are starting to drop, with exports dropping to 4,000 cfs at Clifton Court during the week of 4/2/2023; exports are at 3,500 cfs today (04/11/2023) and likely holding.
