Review Operations Outlook (Randi Field, USBR and Mike Ford, DWR)

- Sacramento River releases out of Keswick Dam are currently 4,100 cfs; flows will likely drop soon, but not until after this week.
- Releasing 1,500 cfs downstream from Nimbus Dam to the American River; looking for opportunities for storage conservation, but no anticipated flow changes yet.
- Goodwin Dam releases on the Stanislaus River changed today from 150 cfs to 200 for the baseflow.
- San Joaquin River flows will change mid-month.
- Releasing 2,500 cfs from Oroville Complex and exporting 500 cfs at Clifton Court.
- In the Delta, the current export of 1,800 cfs from Jones Pumping Plant will be dropping to a single unit operation to 900 cfs Wednesday 10/5/2022 and the Delta Cross Channel (DCC) Gates will be opened on Friday, 10/7/2022, both actions will help to protect water quality.
- DCC gate closures support the Rio Vista flow regulatory requirement.
- DCC were closed as of this morning 10/4/2022 at 10:00 am; anticipating closing during the week and opening on the weekends but may need to change depending on conditions.

Additional Questions or Comments

- Question: Regarding the release out of Keswick, is it being driven by the need to protect the redds rather than Delta needs? Do you have a sense of when those flows will drop to the minimum release, for example, once the redds have all emerged?
- Response: Yes, it's accurate that redd dewatering concerns are controlling, though both issues are being considered in the operation. It's reasonable to assume we'll hang onto the release until the current concerns pass.
- Question: To follow up, we may see a release drop out of Keswick starting next week but not this week?
- Response: Yes, that's what we're alluding to with all those potential ranges of releases. You see a drop in the range for both the American River and the Sacramento River.

Review PA Assessment (Nick Bertrand, USBR)

- The PA Assessment is currently focused on the Delta Cross Channel Gate operations as opposed to the OMR Assessment that is done later this season.
- Some rotary screw traps aren't monitoring yet; but salmonids are not present in large numbers at this point in time.
- Juvenile winter run have been observed Red Bluff Diversion Dam monitoring, but the Salmon Monitoring Team estimating zero percent of juvenile winter run are present in the delta
- The Salmon Monitoring Team did not provide estimates for spring run and Central Valley steelhead this week.
- Mokelumne River Pulse Flow Plan is attached at the bottom of the PA Assessment for reference.
