Review Operations Outlook (DWR)

- Weather is dry and warm this week, with a few light showers possible in the mountains mid-week.
- CVP releases are stable right now.
- DCC gates closed yesterday (11/20/23) for Rio Vista standard and will open later this week for the long weekend; next Monday (11/27/23) the gates will close and likely will remain closed for the rest of the season. Originally, the close date was December 1, but will likely close earlier due to the Rio Vista standard.
- Full moon on Monday November 27; not anticipating extreme high tides and salinity is good.
- Clifton court releases are at 3,800 cfs today (11/21/23) and will return to the 1,000 cfs to 4,000 cfs range for the week; SWP will work with CVP at JPP to schedule exports in accordance with the 4,500 cfs average monthly outflow for November.
- OMR Index is currently in the -3,000 cfs range.
