- 4. Operations Update and Forecasts/Hydrology
  - a. Daily Operation Report:
    - i. Stanislaus River releases out of Goodwin were 800 cfs on 6/15/22. Operations are focused on meeting Vernalis D-1641 flow requirements. Flows may increase 50 cfs throughout the next week.
  - b. New Melones:
    - i. Storage is currently approximately 827 TAF and is steadily declining.

- 5. Water Temperature Updates
  - a. NMFS provided an overview of Temperature Updates (see Figure 9).
  - b. Water Temperature Updates
    - i. Temperatures are typical for this time of year.
- 6. Flow Planning
  - a. The Stepped Release Plan drop to 150 cfs has not occurred because of downstream demands.
- 7. Stanislaus River Forum (SRF) Call Review

a. FishBio was unable to attend the SRF meeting but sent out information after the call.

## 8. Fish Monitoring and Studies

- a. FishBio pulled the weir on 5/23/2022 and ceased sampling.
- b. Seven spring-run Chinook (all ad-clipped) were detected at the Stanislaus weir between March 1 to May 23.
- c. Mossdale catch has remained low throughout the season. There have been no salmonids caught in June and monitoring has been decreased to three days per week. Three *O. mykiss* were caught in May.
  - i. Beginning in July CDFW will begin doing a split crew with USFWS.
- d. All sampling has ceased at the FishBio's Oakdale rotary screw trap. Sampling at Pacific State's Caswell trap ended on 6/8/2022. There will not be any new rotary screw trap updates until the next water year.
- e. The federal offramps for temperature are when Mossdale water temperatures exceed 71.6 ° F for seven days in June, which has occurred and management of salmonids in Old and Middle River is no longer necessary for the water year.

## 9. Restoration Project Updates

- a. JD Wikert is working with a group to submit one or more Stanislaus River Restoration projects to the recent DWR grant solicitation.
- b. If anyone would like to work on proposals for restoration projects, they should reach out to JD Wikert.
