Subject: Final Environmental Impact Statement for the Lake Berryessa Visitor Services Plan

Dear Ladies and Gentlemen:

The Bureau of Reclamation has released the Final Environmental Impact Statement (EIS) for the Lake Berryessa Visitor Services Plan (VSP). Reclamation is planning for the future of this Federal property located in Napa County, California.

Since the late 1950s, seven concessionaires have had contracts with Reclamation to manage recreation at the lake. Six of the contracts expire in 2008/2009 and one interim contract expires in 2007. The contracts have no provisions for extension or renewal. The purpose of the VSP is to develop a comprehensive plan for the re-development and management of visitor services (both commercial and non-commercial) that support diverse recreational opportunities at Lake Berryessa in compliance with applicable laws, regulations, policies, and codes. Reclamation will not make a decision on the proposed action until at least 30 days after release of the Final EIS. After the 30-day waiting period, Reclamation will complete a Record of Decision (ROD). The ROD will state the action that will be implemented and will discuss all factors leading to the decision.
