WHEREAS, the United States is willing to renew the Existing Interim Renewal Contract pursuant to the terms and conditions set forth below;

NOW, THEREFORE, in consideration of the mutual and dependent covenants herein contained, it is hereby mutually agreed by the parties hereto as follows:

INCORPORATION AND REVISION OF EXISTING INTERIM RENEWAL CONTRACT

- 1. The terms and conditions of the Existing Interim Renewal Contract are hereby incorporated by reference into this Contract with the same force and effect as if they were included in full text with the exception of Article1 thereof, which is revised as follows:
- (a) The first sentence in Subdivision (a) of Article 1 of the Existing Interim Renewal Contract is modified as follows: "This interim renewal contract shall be effective from March 1, 2003, and shall remain in effect through February 29, 2004, and thereafter will be renewed as described in Article 2(a) of Interim Renewal Contract No. 14-06-200-171-A-IR6 if a long-term renewal contract has not been executed with an effective commencement date of March 1, 2004."
