10	THIS CONTRACT, hereinafter referred to as "Settlement Contract," is entered into
11	by THE UNITED STATES OF AMERICA, hereinafter referred to as the United States, made
12	this day of, 2004, pursuant to the applicable authority granted to
13	it generally in the Act of June 17, 1902 (32 Stat. 388), and acts amendatory or supplementary
14	thereto, including, but not limited to, the Acts of August 26, 1937 (50 Stat. 844), as amended and
15	supplemented, August 4, 1939 (53 Stat. 1187), as amended and supplemented, including, but not
16	limited to, Sections 9 and 14 thereto, July 2, 1956 (70 Stat. 483), June 21, 1963 (77 Stat. 68),
17	October 12, 1982 (96 Stat. 1262), October 27, 1986 (100 Stat. 3050), as amended, and Title
18	XXXIV of the Act of October 30, 1992 (106 Stat. 4706), all collectively hereinafter referred to
19	as Federal Reclamation law, and NATOMAS CENTRAL MUTUAL WATER COMPANY,
20	hereinafter referred to as the Contractor, a corporation, acting pursuant to Sections 12003 and
21	12004 of the California Water Code, with its principal place of business in California;
22	WITNESSETH, that:
23	EXPLANATORY RECITALS
24	[1 ^{st]} WHEREAS, the United States has constructed and is operating the Central Valley
25	Project, California, for multiple purposes pursuant to its statutory authority; and

 $[2^{\text{nd}}]$ WHEREAS, the Contractor has rights to divert, is diverting, and will continue to 1 2 divert for reasonable beneficial use, water from the natural flow of the Sacramento River and 3 tributaries thereto, that would have been flowing therein if the Central Valley Project were not in 4 existence; $[3^{rd}]$ 5 WHEREAS, the construction and operation of the integrated and coordinated 6 Central Valley Project has changed and will further change the regimen of the Sacramento, 7 American, San Joaquin, and Trinity Rivers and the Sacramento-San Joaquin Delta from 8 unregulated flow to regulated flow; and [4^{th]} WHEREAS, the United States has rights to divert, is diverting, and will continue 9 10 to divert waters from said Rivers and said Delta in connection with the operation of said Central 11 Valley Project; and [5^{th]} WHEREAS, the Contractor and the United States had a dispute over the 12 13 respective rights of the parties to divert and use water from the regulated flow of the Sacramento 14 River which threatened to result in litigation, and as a means to settle that dispute entered into 15 Contract No. 14-06-200-885A, as revised, hereinafter referred to as the Existing Contract, which 16 established terms for the delivery to the Contractor of Central Valley Project Water, and the 17 quantities of Base Supply the United States and the Contractor agreed may be diverted by the 18 Contractor from the Sacramento River pursuant to such contract; and $[6^{th}]$ WHEREAS, the United States and the Contractor disagree with respect to the 19 20 authority of the United States to change the quantities of Base Supply and/or Project Water 21 specified as available for diversion in this Settlement Contract from the quantities specified in 22 the Existing Contract, and other issues related thereto. That dispute was the subject of 23 litigation in a lawsuit entitled Glenn-Colusa Irrigation District, et al. v. United States, et al.

1 [Civ. No. S-01-1816 GEB/JFM (E.D. Cal.)], but that litigation was dismissed, without prejudice, 2 pursuant to a stipulation of dismissal filed by the parties thereto on August 29, 2002. 3 Notwithstanding that dismissal, the Contractor and the United States enter into this Settlement 4 Contract to renew the Existing Contract, pursuant to the terms of the Existing Contract, Federal 5 Reclamation law, and the laws of the State of California; and [7^{th]} 6 WHEREAS, to assure the Contractor of the enjoyment and use of the regulated 7 flow of the said Rivers and the Delta, and to provide for the economical operation of the Central 8 Valley Project by, and the reimbursement to, the United States for expenditures made for said 9 Project. 10 NOW, THEREFORE, in consideration of the performance of the herein contained 11 provisions, conditions, and covenants, it is agreed as follows: 12 **DEFINITIONS** 13 1. When used herein, unless otherwise expressed or incompatible with the intent 14 hereof, the term: 15 "Base Supply" shall mean the quantity of Surface Water established in (a) 16 Articles 3 and 5 which may be diverted by the Contractor from the Sacramento River each month 17 during the period April through October of each Year without payment to the United States for 18 such quantities diverted; "Basin-Wide Water Management Plan" shall mean the mutually agreeable 19 (b) 20 Sacramento River Basinwide Water Management Plan, dated ______, developed by 21 Glenn-Colusa Irrigation District, Maxwell Irrigation District, Natomas Central Mutual 22 Water Company, Pelger Mutual Water Company, Princeton-Codora-Glenn Irrigation District, 23 Provident Irrigation District, Reclamation District 108, Sutter Mutual Water Company,

1 Anderson-Cottonwood Irrigation District, Meridian Farms Water Company, Reclamation District 2 1004, and the U.S. Bureau of Reclamation; 3 "Charges" shall mean the payments for Project Water that the Contractor (c) 4 is required to pay to the United States in addition to the "Rates" specified in this Settlement 5 Contract. The Contracting Officer will, on an annual basis, determine the extent of these 6 Charges. The type and amount of each Charge shall be specified in Exhibit D; 7 (d) "Contract Total" shall mean the sum of the Base Supply and Project Water 8 available for diversion by the Contractor for the period April 1 through October 31; 9 (e) "Critical Year" shall mean any Year in which either of the following 10 eventualities exists: 11 (1) The forecasted full natural inflow to Shasta Lake for the current 12 Water Year, as such forecast is made by the United States on or before February 15 and reviewed 13 as frequently thereafter as conditions and information warrant, is equal to or less than 3.2 million 14 acre-feet; or 15 (2) The total accumulated actual deficiencies below 4 million acre-feet in the immediately prior Water Year or series of successive prior Water Years each of which had 16 inflows of less than 4 million acre-feet, together with the forecasted deficiency for the current 17 18 Water Year, exceed 800,000 acre-feet. 19 For the purpose of determining a Critical Year, the computation of inflow to 20 Shasta Lake shall be performed in a manner that considers the extent of upstream development 21 above Shasta Lake during the year in question, and shall be used as the full natural flow to 22 Shasta Lake. In the event that major construction has occurred or occurs above Shasta Lake after 23 September 1, 1963, and which has materially altered or alters the regimen of the stream systems

- 1 contributing to Shasta Lake, the computed inflow to Shasta Lake used to define a Critical Year
- 2 will be adjusted to eliminate the effect of such material alterations. After consultation with the
- 3 State of California, the National Weather Service, and other recognized forecasting agencies, the
- 4 Contracting Officer will select the forecast to be used and will make the details of it available to
- 5 the Contractor. The same forecasts used by the United States for the operation of the Project
- 6 shall be used to make the forecasts hereunder;
- 7 (f) "CVPIA" shall mean the Central Valley Project Improvement Act, Title
- 8 XXXIV of the Act of October 30, 1992 (106 Stat. 4706);
- 9 (g) "Eligible Lands" shall mean all lands to which Project Water may be
- delivered in accordance with Section 204 of the Reclamation Reform Act of October 12, 1982
- 11 (96 Stat. 1263), as amended, hereinafter referred to as RRA;
- 12 (h) "Excess Lands" shall mean all lands in excess of the limitations contained
- in Section 204 of the RRA, other than those lands exempt from acreage limitation under Federal
- 14 Reclamation law;
- 15 (i) "Full Cost Rate" shall mean that water rate described in Sections 205(a)(3)
- or 202(3) of the RRA, whichever is applicable;
- 17 (j) "Ineligible Lands" shall mean all lands to which Project Water may not be
- delivered in accordance with Section 204 of the RRA;
- 19 (k) "Landholder" shall mean a party that directly or indirectly owns or leases
- 20 nonexempt land, as provided in 43 CFR 426.2;
- 21 (1) "Project" shall mean the Central Valley Project owned by the United
- 22 States and managed by the Department of the Interior, Bureau of Reclamation;

1	(m) Project water shall mean all Surface water diverted or scheduled to be		
2	diverted each month during the period April through October of each Year by the Contractor		
3	from the Sacramento River which is in excess of the Base Supply. The United States recognizes		
4	the right of the Contractor to make arrangements for acquisition of water from projects of others		
5	than the United States for delivery through the Sacramento River and tributaries subject to		
6	written agreement between Contractor and the United States as to identification of such water		
7	which water when so identified shall not be deemed Project Water under this Settlement		
8	Contract;		
9	(n) "Rates" shall mean the payments for Project Water determined annually		
10	by the Contracting Officer in accordance with the then current applicable water ratesetting		
11	policies for the Project, as described in subdivision (a) of Article 8 of this Settlement Contract;		
12	(o) "Secretary" or "Contracting Officer" shall mean the Secretary of the		
13	Interior, a duly appointed successor, or an authorized representative acting pursuant to any		
14	authority of the Secretary and through any agency of the Department of the Interior;		
15	(p) "Surface Water" shall mean only those waters that are considered as		
16	surface water under California law;		
17	(q) "Water Year" shall mean the period commencing with October 1 of 1 year		
18	and extending through September 30 of the next; and		
19	(r) "Year" shall mean a calendar year.		
20	TERM OF SETTLEMENT CONTRACT		
21	2. (a) This Settlement Contract shall become effective April 1, 2004, and shall		
22	remain in effect until and including March 31, 2044: Provided, that under terms and conditions		
23	mutually agreeable to the parties hereto, renewals may be made for successive periods not to		

exceed 40 years each. The terms and conditions of each renewal shall be agreed upon not later than 1 year prior to the expiration of the then existing Settlement Contract.

pertaining thereto, upon written request by the Contractor of the Secretary made not later than 1 year prior to the expiration of this Settlement Contract, whenever, account being taken of the amount then credited to the costs of construction of water supply works, the remaining amount of construction costs of water supply work which is properly assignable for ultimate return by the Contractor as established by the Secretary of the Interior pursuant to (3) of Section 1 of Public Law 643 (70 Stat. 483), probably can be repaid to the United States within the term of a contract under subsection 9(d) of the 1939 Reclamation Project Act (53 Stat. 1187), the relevant portions of this Settlement Contract may be converted to a contract under said subsection 9(d) upon terms and conditions mutually agreeable to the United States and the Contractor. The Secretary shall make a determination 10 years after the date of execution of this Settlement Contract, and every 5 years thereafter, of whether a conversion to a contract under said subsection 9(d) can be accomplished pursuant to Public Law 643. Notwithstanding any provision of this Settlement Contract, the Contractor reserves and shall have all rights and benefits under Public Law 643.

WATER TO BE FURNISHED TO CONTRACTOR

3. (a) Subject to the conditions, limitations, and provisions hereinafter expressed, the Contractor is hereby entitled and authorized to divert from the Sacramento River at the locations shown in Exhibit A, for beneficial use within the area delineated on Exhibit B, (both Exhibits are attached hereto and made a part hereof), the Contract Total designated in Exhibit A, or any revision thereof, in accordance with the monthly operating schedule required by Article 3(c) of this Settlement Contract. The quantity of any water diverted under this

1 Settlement Contract from the Sacramento River, during the period April through October, for use

2 on any lands delineated on Exhibit B, by the owner of such lands or otherwise shall constitute a

3 part of the Contract Total as shown on Exhibit A and shall be subject to all the provisions of this

Settlement Contract relating to such Contract Total as if such diversion were made by the

Contractor.

- Sacramento River during the period April through October, that were obtained after the date of execution of the Existing Contract, or the Contractor may acquire such rights in the future. All diversions made from the Sacramento River, pursuant to such rights, during the period April through October, shall not be considered a part of the quantity of Base Supply and Project Water specified in Exhibit A; Provided, that the quantities diverted pursuant to the above rights shall be identified on the schedule submitted pursuant to Article 3(c) below, and shall not be substituted for any Base Supply or Project Water; Provided, further, that any such identified quantities of other acquired rights may be diverted by the Contractor before incurring any fee pursuant to Article 3(c)(1), below.
- (c) Before April 1 and before the first day of each month thereafter when a revision is needed, the Contractor shall submit a written schedule to the Contracting Officer indicating the Contract Total to be diverted by the Contractor for agricultural and municipal and industrial purposes during each month under this Settlement Contract. The United States shall furnish water to the Contractor in accordance with the monthly operating schedule or any revisions thereof. However, the United States recognizes the need of the Contractor to change from time to time its monthly diversions of water from the quantities shown in Exhibit A; the Contractor may make such changes, provided:

1	(1) that for the quantity of Base Supply diverted in excess of the
2	monthly quantity shown in Exhibit A, and as may be reduced in accordance with Article 5(a),
3	during June, July, August, September, or October of any Water Year, the Contractor shall be
4	charged a rescheduling fee equal to 50 percent of the sum of the storage operations and
5	maintenance rate and the storage capital rate components of the Project ratesetting policy.
6	(2) that in no event shall the total quantity scheduled for diversion by
7	the Contractor from the Sacramento River:
8	(i) During the period April through October exceed the
9	aggregate of the Contract Total for that period shown in Exhibit A or any revision
10	thereof;
11	(ii) During the period July through September exceed the
12	aggregate of the Contract Total for that period shown in Exhibit A or any revision
13	thereof.
14	(d) In the event conditions warrant, the Contracting Officer reserves the right
15	to require the Contractor to submit, at least 72 hours prior to the beginning of each weekly
16	period, its estimate of daily diversion requirements for each such period from the Sacramento
17	River: <u>Provided</u> , <u>however</u> , that changes during any such period may be made upon the giving of
18	72 hours' notice thereof to the Contracting Officer.
19	(e) No sale, transfer, exchange, or other disposal of any of the Contract Total
20	designated in Exhibit A or the right to the use thereof for use on land other than that shown on
21	Exhibit B shall be made by the Contractor without first obtaining the written consent of the
22	Contracting Officer. Such consent will not be unreasonably withheld and a decision will be
23	rendered in a timely manner. For short-term actions that will occur within 1 year or less, the

1 decision will be rendered within 30 days after receipt of a complete written proposal. For long-2 term actions that will occur in a period longer than 1 year, the decision will be rendered within 3 90 days after receipt of a complete written proposal. For a proposal to be deemed complete by 4 the Contracting Officer, it must comply with all provisions required by State and Federal law, 5 including information sufficient to enable the Contracting Officer to comply with the National 6 Environmental Policy Act, the Endangered Species Act, and applicable rules or regulations then 7 in effect; Provided that, such consent does not authorize the use of Federal facilities to facilitate 8 or effectuate the sale, transfer, exchange, or other disposal of Base Supply. Such use of Federal 9 facilities will be the subject of a separate agreement to be entered into between the Contractor 10 and Reclamation. 11 For the purpose of determining whether Section 3405(a)(1)(M) of the (f) 12 CVPIA applies to the Contractor as a transferor or transferee of Project Water, the Contracting 13 Officer acknowledges that the Contractor is within a county, watershed, or other area of origin, 14 as those terms are utilized under California law. 15 Nothing herein contained shall prevent the Contractor from diverting (g) 16 water during the months of November through March for beneficial use on the land shown on 17 Exhibit B or elsewhere to the extent authorized under the laws of the State of California. 18 (h) The United States assumes no responsibility for and neither it nor its officers, agents, or employees shall have any liability for or on account of: 19 20 (1) The quality of water to be diverted by the Contractor; 21 (2) The control, carriage, handling, use, disposal, or distribution of 22 water diverted by the Contractor outside the facilities constructed and then being operated and

maintained by or on behalf of the United States;

1	(3) Claims of damage of any nature whatsoever, including but not
2	limited to, property loss or damage, personal injury, or death arising out of or connected with the
3	control, carriage, handling, use, disposal, or distribution of said water outside of the hereinabove
4	referred to facilities; and
5	(4) Any damage whether direct or indirect arising out of or in any
6	manner caused by a shortage of water whether such shortage be on account of errors in
7	operation, drought, or unavoidable causes.
8	RETURN FLOW
9	4. Nothing herein shall be construed as an abandonment or a relinquishment by the
10	United States of any right it may have to the use of waste, seepage, and return flow water derived
11	from water diverted by the Contractor hereunder and which escapes or is discharged beyond the
12	boundaries of the lands shown on Exhibit B; Provided, that this shall not be construed as
13	claiming for the United States any right to such water which is recovered by the Contractor
14	pursuant to California law from within the boundaries of the lands shown on Exhibit B, and
15	which is being used pursuant to this Settlement Contract for surface irrigation or underground
16	storage for the benefit of the lands shown on Exhibit B by the Contractor.
17	CONSTRAINTS ON THE AVAILABILITY OF WATER
18	5. (a) In a Critical Year, the Contractor's Base Supply and Project Water agreed
19	to be diverted during the period April through October of the Year in which the principal portion
20	of the Critical Year occurs and, each monthly quantity of said period shall be reduced by
21	25 percent.
22	(b) The amount of any overpayment by the Contractor shall, at its option, be
23	refunded or credited upon amounts to become due to the United States from the Contractor under

the provisions hereof in the ensuing Year. To the extent of such deficiency such adjustment of
 overpayment shall constitute the sole remedy of the Contractor.

INTEGRATED WATER MANAGEMENT AND PARTNERSHIPS

6. The Contractor and United States desire to work together to maximize the reasonable beneficial use of water for their mutual benefit. As a consequence, the United States and the Contractor will work in partnership and with others within the Sacramento Valley, including other Contractors, to facilitate the better integration within the Sacramento Valley of all water supplies including, but not limited to, the better management and integration of surface water and groundwater, the development and better utilization of surface water storage, the effective utilization of waste, seepage and return flow water, and other operational and management options that may be identified in the future.

<u>USE OF WATER FURNISHED TO CONTRACTOR</u>

7. (a) The parties anticipate that, during the term of this Settlement Contract, a gradual change in the purpose of use of water will occur within the place of water use shown in Exhibit B from predominantly agricultural purposes to a mixture of municipal and industrial, wildlife habitat and agricultural purposes, and the parties agree to work cooperatively to accommodate and facilitate such change. Project Water furnished to the Contractor pursuant to this Settlement Contract may be delivered or furnished by the Contractor for agricultural or municipal and industrial purposes: Provided, however, that the Contractor shall not deliver or furnish Project Water for municipal and industrial purposes outside those areas delineated on Exhibit B, as approved for such purposes by the Contracting Officer, without the written consent of the Contracting Officer. Such consent will not be unreasonably withheld and a decision will be provided in a timely manner following completion of any environmental review required

under applicable law. For purposes of this Settlement Contract, "agricultural purposes" includes,
but is not restricted to, the irrigation of crops, the watering of livestock, incidental domestic use
including related landscape irrigation, or underground water replenishment; and "municipal and
industrial purposes" includes, but is not limited to, the watering of landscaping or pasture for
animals (e.g., horses) which are kept for personal enjoyment or water delivered to landholdings
operated in units of less than 5 acres unless the Contractor establishes to the satisfaction of the

Contracting Officer that the use of Project Water is for agricultural purposes.

(b) The Contractor shall comply with requirements applicable to the Contractor in biological opinion(s) prepared as a result of a consultation regarding the execution of this Settlement Contract undertaken pursuant to Section 7 of the Endangered Species Act of 1973, as amended, that are within the Contractor's legal authority to implement. The Contractor shall comply with the limitations or requirements imposed by environmental documentation applicable to the Contractor and within its legal authority to implement. The Existing Contract, which evidences in excess of 40 years of diversions, for agricultural uses, of the quantities of water provided for in Article 3, and the underlying water rights of the Contractor will be considered in developing an appropriate base-line for the Biological Assessment prepared pursuant to the Endangered Species Act, and in any other needed environmental review.

Nothing herein shall be construed to prevent the Contractor from challenging or seeking judicial relief in a court of competent jurisdiction with respect to any biological opinion or other environmental documentation referred to in this Article.

RATE AND METHOD OF PAYMENT FOR WATER

8. (a) The Contractor shall make payments to the United States as provided in this Article for all Project Water shown in Exhibit A as follows:

1 (1) 75 percent of the amount shown as Project Water shall be paid for 2 by the Contractor in each Year; and in addition 3 (2) the Contractor shall pay for Project Water actually diverted in 4 excess of 75 percent of the amount shown as Project Water. 5 Such payments shall be at Rates and Charges established in accordance with: (i) the 6 Secretary's then-current ratesetting policies for the Project; and (ii) applicable Reclamation law 7 and associated rules and regulations, or policies: Provided, that if the Contractor desires to use 8 Project Water for other than agricultural use the Rates and Charges set forth above will be 9 adjusted by the Contracting Officer to the applicable Rates and Charges for such use: Provided, 10 further, that to enable the Contracting Officer to compute the applicable Rates and Charges for 11 Project Water diverted by the Contractor for other than agricultural use, including, but not 12 limited to diversions for municipal and industrial uses and diversions for direct application to 13 wildlife habitat (not including re-use of tailwater for habitat purposes), prior to initiating any 14 such diversions, the Contractor shall provide the Contracting Officer with an estimate of the 15 annual quantities of Project Water to be diverted or furnished for such purposes through the end 16 of the CVP repayment period as identified in the then-current ratesetting policies. The Rates and 17 Charges applicable to the Contractor upon execution of this Settlement Contract are set forth in 18 Exhibit D, as may be revised annually. The Secretary's ratesetting policies for the Project shall 19 be amended, modified, or superseded only through a public notice and comment procedure. The 20 Contracting Officer shall adjust the amount of Project Water for which payment is required to 21 the extent of any reduction in diversions of Project Water made in accordance with the water 22 conservation provisions of Article 29(e).

1 (b) The Contracting Officer shall notify the Contractor of the Rates and 2 Charges as follows: 3 (1) Prior to July 1 of each Year, the Contracting Officer shall provide 4 the Contractor an estimate of the Charges for Project Water that will be applied to the period 5 October 1, of the current Year, through September 30, of the following Year, and the basis for 6 such estimate. The Contractor shall be allowed not less than 2 months to review and comment 7 on such estimates. On or before September 15 of each Year, the Contracting Officer shall notify 8 the Contractor in writing of the Charges to be in effect during the period October 1 of the current 9 Year, through September 30, of the following Year, and such notification shall revise Exhibit D. 10 (2) Prior to October 1 of each Year, the Contracting Officer shall make 11 available to the Contractor an estimate of the Rates for Project Water for the following Year and 12 the computations and cost allocations upon which those Rates are based. The Contractor shall be 13 allowed not less than 2 months to review and comment on such computations and cost 14 allocations. By December 31 of each Year, the Contracting Officer shall provide the Contractor 15 with the final Rates to be in effect for the upcoming Year, and such notification shall revise 16 Exhibit D. 17 (c) The Contractor shall pay the United States for Project Water in the 18 following manner: 19 (1) With respect to Rates, prior to May 1 of each Year, the Contractor 20 shall pay the United States one-half the total amount payable pursuant to subdivision (a) of this 21 Article and the remainder shall be paid prior to July 1 or such later date or dates as may be 22 specified by the United States in a written notice to the Contractor: Provided, however, that if at any time during the Year the amount of Project Water diverted by the Contractor shall equal the 23

amount for which payment has been made, the Contractor shall pay for the remaining amount of such water as shown in Exhibit A in advance of any further diversion of Project Water.

- 3 (2) With respect to Charges, the Contractor shall also make a payment 4 to the United States, in addition to the Rate(s) in subdivision (c)(1) of this Article, at the Charges 5 then in effect, before the end of the month following the month of delivery or transfer. The 6 payments shall be consistent with the quantities of Project Water delivered or transferred. 7 Adjustment for overpayment or underpayment of Charges shall be made through the adjustment 8 of payments due to the United States for Charges for the next month. Any amount to be paid for 9 past due payment of Charges shall be computed pursuant to Article 13 of this Settlement 10 Contract.
 - (d) Payments to be made by the Contractor to the United States under this Settlement Contract may be paid from any revenues available to the Contractor.

- (1) All revenues received by the United States from the Contractor relating to the delivery of Project Water or the delivery of non-Project Water through Project facilities shall be allocated and applied in accordance with Federal Reclamation law and the associated rules or regulations, and the then current Project ratesetting policies for irrigation water.
- (e) The Contracting Officer shall keep its accounts pertaining to the administration of the financial terms and conditions of its long-term water service and Settlement Contracts, in accordance with applicable Federal standards, so as to reflect the application of Project costs and revenues. The Contracting Officer shall, each Year upon request of the Contractor, provide to the Contractor a detailed accounting of all Project and Contractor expense allocations, the disposition of all Project and Contractor revenues, and a summary of all water

delivery information. The Contracting Officer and the Contractor shall enter into good faith

negotiations to resolve any discrepancies or disputes relating to accountings, reports, or

3 information.

(f) The parties acknowledge and agree that the efficient administration of this Settlement Contract is their mutual goal. Recognizing that experience has demonstrated that mechanisms, policies, and procedures used for establishing Rates and Charges and/or for making and allocating payments, other than those set forth in this Article may be in the mutual best interest of the parties, it is expressly agreed that the parties may enter into agreements to modify the mechanisms, policies, and procedures for any of those purposes while this Settlement

Contract is in effect without amendment of this Settlement Contract.

- ratesetting policies for the Project will be established to recover only reimbursable operation and maintenance (including any deficits) and capital costs of the Project, as those terms are used in the then current Project ratesetting policies, and interest, where appropriate, except in instances where a minimum Rate is applicable in accordance with the relevant Project ratesetting policy. Proposed changes of significance in practices which implement the ratesetting policies for the Project will not be implemented until the Contracting Officer has provided the Contractor an opportunity to discuss the nature, need, and impact of the proposed change. The Contractor retains all rights to challenge the validity of Rates and Charges imposed pursuant to this Settlement Contract, including but not limited to operation and maintenance expenses and operation and maintenance deficits, in an appropriate administrative or judicial proceeding.
- (h) Except as provided in subsection 3405(a)(1)(B) of the CVPIA, the Rates for Project Water transferred, exchanged, or otherwise disposed of, by the Contractor shall be the

- 1 Contractor's Rates adjusted upward or downward to reflect the changed costs of delivery (if any)
- of the transferred, exchanged, or otherwise disposed of Project Water to the transferee's point of
- 3 delivery in accordance with the then-current ratesetting policies for the Project. Except as

MEASUREMENT OF WATER

- 10. (a) All water diverted by the Contractor from the Sacramento River will be diverted at the existing point or points of diversion shown on Exhibit A or at such other points as may be mutually agreed upon in writing by the Contracting Officer and the Contractor.
- (b) All water diverted from the Sacramento River pursuant to this Settlement Contract will be measured or caused to be measured by the United States at each point of diversion with existing equipment or equipment to be installed, operated, and maintained by the United States, and/or others, under contract with and at the option of the United States. The equipment and methods used to make such measurement shall be in accordance with sound engineering practices. Upon request of the Contractor, the accuracy of such measurements will be investigated by the Contracting Officer and any errors appearing therein will be corrected.
- (c) The right of ingress to and egress from all points of diversion is hereby granted to all authorized employees of the United States. The Contractor also hereby grants to the United States the right to install, operate, maintain, and replace such equipment on diversion or carriage facilities at each point of diversion as the Contracting Officer deems necessary.
- (d) The Contractor shall not modify, alter, remove, or replace diversion facilities or do any other act which would alter the effectiveness or accuracy of the measuring equipment installed by the United States or its representatives unless and until the Contracting Officer has been notified with due diligence and has been given an opportunity to modify such measuring equipment in such manner as may be necessary or appropriate. In the event of an emergency the Contractor shall notify the United States within a reasonable time thereafter as to

1 the existence of the emergency and the nature and extent of such modification, alteration, 2 removal, or replacement of diversion facilities. 3 (e) The Contractor shall pay the United States for the costs to repair, relocate, 4 or replace measurement equipment when the Contractor modifies, alters, removes, or replaces 5 diversion or carriage facilities. 6 (f) Contractor and Contracting Officer shall develop a mutually agreeable 7 surface water delivery water measurement program which shall be implemented by the 8 Contractor, and such measurement program shall be consistent with the conservation and 9 efficiency criteria for evaluating water conservation plans as provided in Article 29(a). 10 All new surface water delivery systems installed within the lands (g) 11 delineated on Exhibit B after the effective date of this Settlement Contract shall also comply with 12 the measurement provisions described in this Article. The Contractor shall inform the Contracting Officer on or before the 10th 13 (h) 14 calendar day of each month of the quantity of Contract Total diverted or furnished for 15 agricultural and municipal and industrial purposes during the preceding month. 16 **RULES AND REGULATIONS** 17 11. The parties agree that the delivery of Project Water for irrigation use or use of 18 Federal facilities pursuant to this Settlement Contract is subject to Federal Reclamation law, 19 including but not limited to, the Reclamation Reform Act of 1982 (43 U.S.C. 390aa et seq.), as 20 amended and supplemented, and the rules and regulations promulgated by the Secretary of the 21 Interior under Federal Reclamation law. 22 GENERAL OBLIGATION--BENEFITS CONDITIONED UPON PAYMENT 23 12. (a) The obligation of the Contractor to pay the United States as provided in 24 this Settlement Contract is a general obligation of the Contractor notwithstanding the manner in

which the obligation may be distributed among the Contractor's water users and notwithstanding 1 the default of individual water users in their obligations to the Contractor. 2 3 (b) The payment of Charges becoming due hereunder is a condition precedent 4 to receiving benefits under this Settlement Contract. The United States shall not make water 5 available to the Contractor through Project facilities during any period in which the Contractor 6 may be in arrears in the advance payment of water Rates due the United States. The Contractor 7 shall not furnish water made available pursuant to this Settlement Contract for lands or parties 8 which are in arrears in the advance payment of water rates levied or established by the 9 Contractor. 10 With respect to subdivision (b) of this Article, the Contractor shall have no (c) 11 obligation to require advance payment for water Rates which it levies. 12 CHARGES FOR DELINQUENT PAYMENTS 13 13. (a) The Contractor shall be subject to interest, administrative and penalty charges on delinquent installments or payments. When a payment is not received by the due 14 15 date, the Contractor shall pay an interest charge for each day the payment is delinquent beyond 16 the due date. When a payment becomes 60 days delinquent, the Contractor shall pay an 17 administrative charge to cover additional costs of billing and processing the delinquent payment. 18 When a payment is delinquent 90 days or more, the Contractor shall pay an additional penalty charge of six percent per year for each day the payment is delinquent beyond the due date. 19 20 Further, the Contractor shall pay any fees incurred for debt collection services associated with a 21 delinquent payment. 22 The interest charge rate shall be the greater of the rate prescribed quarterly 23 in the Federal Register by the Department of the Treasury for application to overdue payments. 24 or the interest rate of one-half of one percent per month prescribed by Section 6 of the 25 Reclamation Project Act of 1939 (Public Law 76-260). The interest charge rate shall be 26 determined as of the due date and remain fixed for the duration of the delinquent period. 27 When a partial payment on a delinquent account is received, the amount 28 received shall be applied, first to the penalty, second to the administrative charges, third to the 29 accrued interest, and finally to the overdue payment. 30 **QUALITY OF WATER** 31 14. The operation and maintenance of Project facilities shall be performed in such manner as is practicable to maintain the quality of raw water made available through such 32 33 facilities at the highest level reasonably attainable as determined by the Contracting Officer. The

1 United States does not warrant the quality of water and is under no obligation to construct or 2 furnish water treatment facilities to maintain or better the quality of water. 3 WATER AND AIR POLLUTION CONTROL 4 15. The Contractor, in carrying out this Settlement Contract, shall comply with all 5 applicable water and air pollution laws and regulations of the United States and the State of 6 California, and shall obtain all required permits or licenses from the appropriate Federal, State, 7 or local authorities. 8 **EQUAL OPPORTUNITY** 9 16. During the performance of this Settlement Contract, the Contractor agrees as 10 follows: 11 (a) The Contractor will not discriminate against any employee or applicant for 12 employment because of race, color, religion, sex, or national origin. The Contractor will take 13 affirmative action to ensure that applicants are employed, and that employees are treated during employment, without regard to their race, color, religion, sex, or national origin. Such action 14 15 shall include, but not be limited to, the following: Employment, upgrading, demotion, or 16 transfer; recruitment or recruitment advertising; layoff or termination, rates of payment or other 17 forms of compensation; and selection for training, including apprenticeship. The Contractor 18 agrees to post in conspicuous places, available to employees and applicants for employment, 19 notices to be provided by the Contracting Officer setting forth the provisions of this 20 nondiscrimination clause. 21 The Contractor will, in all solicitations or advertisements for employees (b) 22 placed by or on behalf of the Contractor, state that all qualified applicants will receive consideration for employment without discrimination because of race, color, religion, sex, or 23 24 national origin. 25 The Contractor will send to each labor union or representative of workers with which it has a collective bargaining agreement or other contract or understanding, a notice, 26 27 to be provided by the Contracting Officer, advising the said labor union or workers' representative of the Contractor's commitments under Section 202 of Executive Order No. 11246 28 29 of September 24, 1965, as amended, and shall post copies of the notice in conspicuous places 30 available to employees and applicants for employment. 31 (d) The Contractor will comply with all provisions of Executive Order 32 No. 11246 of September 24, 1965, as amended, and of the rules, regulations, and relevant orders 33 of the Secretary of Labor.

(e) The Contractor will furnish all information and reports required by said amended Executive Order and by the rules, regulations, and orders of the Secretary of Labor, or pursuant thereto, and will permit access to its books, records, and accounts by the Contracting Officer and the Secretary of Labor for purposes of investigation to ascertain compliance with such rules, regulations, and orders.

- (f) In the event of the Contractor's noncompliance with the nondiscrimination clauses of this Settlement Contract or with any of the said rules, regulations, or orders, this Settlement Contract may be canceled, terminated, or suspended, in whole or in part, and the Contractor may be declared ineligible for further Government contracts in accordance with procedures authorized in said amended Executive Order, and such other sanctions may be imposed and remedies invoked as provided in said Executive Order, or by rule, regulation, or order of the Secretary of Labor, or as otherwise provided by law.
- The Contractor will include the provisions of paragraphs (a) through (g) in (g) every subcontract or purchase order unless exempted by the rules, regulations, or orders of the Secretary of Labor issued pursuant to Section 204 of said amended Executive Order, so that such provisions will be binding upon each subcontractor or vendor. The Contractor will take such action with respect to any subcontract or purchase order as may be directed by the Secretary of Labor as a means of enforcing such provisions, including sanctions for noncompliance: Provided, however, that in the event the Contractor becomes involved in, or is threatened with, litigation with a subcontractor or vendor as a result of such direction, the Contractor may request the United States to enter into such litigation to protect the interests of the United States.

COMPLIANCE WITH CIVIL RIGHTS LAWS AND REGULATIONS

- 17. (a) The Contractor shall comply with Title VI of the Civil Rights Act of 1964 (42 U.S.C. 2000d), Section 504 of the Rehabilitation Act of 1975 (P.L. 93-112, as amended), the Age Discrimination Act of 1975 (42 U.S.C. 6101, et seq.) and any other applicable civil rights laws, as well as with their respective implementing regulations and guidelines imposed by the U.S. Department of the Interior and/or Bureau of Reclamation.
 - (b) These statutes require that no person in the United States shall, on the grounds of race, color, national origin, handicap, or age, be excluded from participation in, be denied the benefits of, or be otherwise subjected to discrimination under any program or activity receiving financial assistance from the Bureau of Reclamation. By executing this Settlement Contract, the Contractor agrees to immediately take any measures necessary to implement this obligation, including permitting officials of the United States to inspect premises, programs, and documents.
 - (c) The Contractor makes this agreement in consideration of and for the purpose of obtaining any and all Federal grants, loans, contracts, property discounts, or other Federal financial assistance extended after the date hereof to the Contractor by the Bureau of Reclamation, including installment payments after such date on account of arrangements for Federal financial assistance which were approved before such date. The Contractor recognizes and agrees that such Federal assistance will be extended in reliance on the representations and

agreements made in this Article, and that the United States reserves the right to seek judicial enforcement thereof.

MINGLING OF CONTRACTOR'S PROJECT AND NON-PROJECT WATER

- 18. (a) Project Water must of necessity be transported by the Contractor to its water users by means of the same works and channels used for the transport of its non-Project Water including Base Supply. Notwithstanding such mingling of water, the provisions of Article 11 hereof shall be applicable only to Project Water, and such mingling of water shall not in any manner subject to the provisions of Article 11 hereof the Contractor's non-Project Water including Base Supply.
- (b) If required in accordance with subdivision (c) of this Article, the

 Contractor shall install and maintain such measuring equipment and distribution facilities and
 maintain such records as may be necessary to determine the amounts of water delivered to

 Excess Lands served by the Contractor. The Contractor shall not within any month deliver to

 Ineligible Lands water in excess of the non-Project Water, including Base Supply, for that
 month. The Contracting Officer or authorized representative shall have the right at all
 reasonable times to inspect such records and measuring equipment.
 - (c) The Contractor will not be considered in violation of the requirement that Project Water be delivered only to Eligible Lands during any month of the irrigation season that the water requirement for beneficial use on Eligible Lands for that month is equal to or in excess of the Project Water for that month as shown on Exhibit A or any revision thereof pursuant to subdivision (c) of Article 3. The water requirement for beneficial use on Eligible Lands will be determined by multiplying:
- (1) the number of irrigable acres of the particular types of crops grown in that year on the acreage designated as eligible by

1 (2) the Unit Duties as set forth in Exhibit C attached hereto and made 2 a part hereof, or by such other Unit Duties mutually agreed upon by the Contractor and the 3 Contracting Officer. In order to make the computation of the water requirement for Eligible 4 Lands, on April 1 of each Year and concurrently with its order for water for the irrigation season, 5 the Contractor shall designate the acreage of and type of crops to be grown on its Eligible Lands 6 that irrigation season. During any month the water requirement as above determined for crops 7 growing on Eligible Lands during such month is equal to or in excess of the Project Water for 8 that month as provided herein the Contractor shall not be required to measure the water delivered 9 to Excess Lands. Any month the said water requirement is less than the amount of Project Water 10 as provided herein, the Contractor will be required to measure water delivered to excess land in 11 accordance with subdivision (b) hereof. 12 BOOKS, RECORDS, AND REPORTS 13 19. The Contractor shall establish and maintain accounts and other books and records 14 pertaining to administration of the terms and conditions of this Settlement Contract, including: the Contractor's financial transactions, water supply data, and Project land and right-of-way 15 agreements; the water users' land-use (crop census), land ownership, land-leasing and water use 16 17 data; and other matters that the Contracting Officer may require. Reports thereon shall be furnished to the Contracting Officer in such form and on such date or dates as the Contracting 18 19 Officer may require. Subject to applicable Federal laws and regulations, each party to this 20 Settlement Contract shall have the right during office hours to examine and make copies of each other's books and official records relating to matters covered by this Settlement Contract. 21 22 CHANGE OF PLACE OF USE OR ORGANIZATION 23 20. Unless the written consent of the United States is first obtained no change (a) 24 shall be made in the place of water use shown on Exhibit B. While this Settlement Contract is in effect, no change shall be made in the 25 (b) 26 area of the Contractor as shown on its Exhibit B, by inclusion, exclusion, annexation, or 27 detachment of lands, by dissolution, consolidation, or merger or otherwise, except upon the

1	Contracting Officer's written consent thereto. Such consent will not be unreasonably withheld
2	and a decision will be provided in a timely manner.
3	(c) In the event lands are annexed to or detached from the area of the
4	Contractor, as provided herein, the quantity of Project Water to be diverted may be increased or
5	decreased, as may be appropriate, pursuant to a supplemental agreement to be executed in
6	respect thereto.
7	CONSOLIDATION OF CONTRACTING ENTITIES
8	21. Consolidation of Contractors may be approved by the Contracting Officer
9	provided: (i) the Contracting Officer approves the form and organization of the resulting entity
10	and the utilization by it of the Contract Total; and (ii) the obligations of the Contractors are
11	assumed by such entity.
12	No such consolidation shall be valid unless and until approved by the Contracting
13	Officer.

(a) Prior to the diversion of Project Water, the Contractor shall be implementing an effective water conservation and efficiency program based on the Basin-Wide Water Management Plan and/or Contractor's water conservation plan that has been determined by the Contracting Officer to meet the conservation and efficiency criteria for evaluating water conservation plans established under Federal law. The water conservation and efficiency program shall contain definite water conservation objectives, appropriate economically feasible

water conservation measures, and time schedules for meeting those objectives. Continued

OPINIONS AND DETERMINATIONS

30. (a) Where the terms of this Settlement Contract provide for actions to be based upon the opinion or determination of either party to this Settlement Contract, said terms shall not be construed as permitting such action to be predicated upon arbitrary, capricious, or unreasonable opinions or determinations. Both parties, notwithstanding any other provisions of this Settlement Contract, expressly reserve the right to seek relief from and appropriate adjustment for any such arbitrary, capricious, or unreasonable opinion or determination. Each opinion or determination by either party shall be provided in a timely manner. Nothing in subdivision (a) of Article 30 of this Settlement Contract is intended to or shall affect or alter the standard of judicial review applicable under Federal law to any opinion or determination implementing a specific provision of Federal law embodied in statute or regulation.

(b) The Contracting Officer shall have the right to make determinations necessary to administer this Settlement Contract that are consistent with the provisions of this Settlement Contract, the laws of the United States and of the State of California, and the rules and regulations promulgated by the Secretary of the Interior. Such determinations shall be made in consultation with the Contractor to the extent reasonably practicable.

CONTRACTOR TO PAY CERTAIN MISCELLANEOUS COSTS

31. (a) In addition to all other payments to be made by the Contractor pursuant to this Settlement Contract, the Contractor shall pay to the United States, within 60 days after receipt of a bill and detailed statement submitted by the Contracting Officer to the Contractor for such specific items of direct cost incurred by the United States for work requested by the Contractor associated with this Settlement Contract plus indirect costs in accordance with applicable Bureau of Reclamation policies and procedures. All such amounts referred to in this

- 1 Article shall not exceed the amount agreed to in writing in advance by the Contractor. This
- 2 Article shall not apply to costs for routine contract administration.
- 3 (b) All advances for miscellaneous costs incurred for work requested by the
- 4 Contractor pursuant to Article 31 of this Settlement Contract shall be adjusted to reflect the
- 5 actual costs when the work has been completed. If the advances exceed the actual costs incurred,
- 6 the difference will be refunded to the Contractor. If the actual costs exceed the Contractor's
- 7 advances, the Contractor will be billed for the additional costs pursuant to Article 31 of this
- 8 Settlement Contract.

9 WAIVER OF DEFAULT

- The waiver by either party to this Settlement Contract as to any default shall not
- be construed as a waiver of any other default or as authority of the other party to continue such
- default or to make, do, or perform, or not to make, do, or perform, as the case may be, any act or
