13	THIS CONTRACT, hereinafter referred to as "Settlement Contract," is entered into
14	by THE UNITED STATES OF AMERICA, hereinafter referred to as the United States, made
15	this day of, 2004, pursuant to the applicable authority granted to
16	it generally in the Act of June 17, 1902 (32 Stat. 388), and acts amendatory or supplementary
17	thereto, including, but not limited to, the Acts of August 26, 1937 (50 Stat. 844), as amended and
18	supplemented, August 4, 1939 (53 Stat. 1187), as amended and supplemented, including, but not
19	limited to, Sections 9 and 14 thereto, July 2, 1956 (70 Stat. 483), June 21, 1963 (77 Stat. 68),
20	October 12, 1982 (96 Stat. 1262), October 27, 1986 (100 Stat. 3050), as amended, and Title
21	XXXIV of the Act of October 30, 1992 (106 Stat. 4706), all collectively hereinafter referred to
22	as Federal Reclamation law, and PACIFIC REALTY ASSOCIATES, L.P. dba M&T CHICO
23	RANCH, hereinafter referred to as the Contractor, a limited partnership acting pursuant to
24	Sections 12003 and 12004 of the California Water Code, with its principal place of business in
25	Oregon;
26	WITNESSETH, that:

1	EXPLANATORY RECITALS
2	[1 ^{st]} WHEREAS, the United States has constructed and is operating the Central Valley
3	Project, California, for multiple purposes pursuant to its statutory authority; and
4	[2 ^{nd]} WHEREAS, the Contractor has rights to divert, is diverting, and will continue to
5	divert for reasonable beneficial use, water from the natural flow of the Sacramento River and
6	tributaries thereto, that would have been flowing therein if the Central Valley Project were not in
7	existence and water from Butte Creek; and
8	[3 ^{rd]} WHEREAS, the construction and operation of the integrated and coordinated
9	Central Valley Project has changed and will further change the regimen of the Sacramento,
10	American, San Joaquin, and Trinity Rivers and the Sacramento-San Joaquin Delta from
11	unregulated flow to regulated flow; and
12	[4 ^{th]} WHEREAS, the United States has rights to divert, is diverting, and will continue
13	to divert waters from said Rivers and said Delta in connection with the operation of said Central
14	Valley Project; and
15	[5 ^{th]} WHEREAS, the Contractor and the United States had a dispute over the
16	respective rights of the parties to divert and use water from the regulated flow of the Sacramento
17	River which threatened to result in litigation, and as a means to settle that dispute entered into
18	Contract No. 14-06-200-940A, as revised, hereinafter referred to as the Existing Contract, which
19	established terms for the delivery to the Contractor of Central Valley Project Water, and the
20	quantities of Base Supply the United States and the Contractor agreed may be diverted by the
21	Contractor from the Sacramento River pursuant to such contract; and
22	[6 ^{th]} WHEREAS, the United States and the Contractor disagree with respect to the
23	authority of the United States to change the quantities of Base Supply and/or Project Water

1	specified as available for diversion in this Settlement Contract from the quantities specified in
2	the Existing Contract, and other issues related thereto. That dispute was the subject of litigation
3	in a lawsuit entitled Glenn-Colusa Irrigation District, et al. v. United States, et al. [Civ. No. S-
4	01-1816 GEB/JFM (E.D. Cal.)], but that litigation was dismissed, without prejudice, pursuant to
5	a stipulation of dismissal filed by the parties thereto on August 29, 2002. Notwithstanding that
6	dismissal, the Contractor and the United States enter into this Settlement Contract to renew the
7	Existing Contract, pursuant to the terms of the Existing Contract, Federal Reclamation law, and
8	the laws of the State of California; and
9	[7 ^{th]} WHEREAS, to assure the Contractor of the enjoyment and use of the regulated
10	flow of the said Rivers and the Delta, and to provide for the economical operation of the Central
11	Valley Project by, and the reimbursement to, the United States for expenditures made for said
12	Project.
13	NOW, THEREFORE, in consideration of the performance of the herein contained
14	provisions, conditions, and covenants, it is agreed as follows:
15	<u>DEFINITIONS</u>
16	1. When used herein, unless otherwise expressed or incompatible with the intent
17	hereof, the term:
18	(a) "Base Supply" shall mean the quantity of Surface Water established in
19	Articles 3 and 5 which may be diverted by the Contractor from the Sacramento River each month
20	during the period April through October of each Year without payment to the United States for
21	such quantities diverted;
22	(b) "Basin-Wide Water Management Plan" shall mean the mutually agreeable
23	Sacramento River Basinwide Water Management Plan, dated, developed by

- 1 Glenn-Colusa Irrigation District, Maxwell Irrigation District, Natomas Central Mutual Water
- 2 Company, Pelger Mutual Water Company, Princeton-Codora-Glenn Irrigation District, Provident
- 3 Irrigation District, Reclamation District 108, Sutter Mutual Water Company, Anderson-
- 4 Cottonwood Irrigation District, Meridian Farms Water Company, Reclamation District 1004, and
- 5 the U.S. Bureau of Reclamation;
- 6 (c) "Charges" shall mean the payments for Project Water that the Contractor
- 7 is required to pay to the United States in addition to the "Rates" specified in this Settlement
- 8 Contract. The Contracting Officer will, on an annual basis, determine the extent of these
- 9 Charges. The type and amount of each Charge shall be specified in Exhibit D;
- 10 (d) "Contract Total" shall mean the sum of the Base Supply and Project Water
- available for diversion by the Contractor for the period April 1 through October 31;
- (e) "Critical Year" shall mean any Year in which either of the following
- 13 eventualities exists:
- 14 (1) The forecasted full natural inflow to Shasta Lake for the current
- Water Year, as such forecast is made by the United States on or before February 15 and reviewed
- as frequently thereafter as conditions and information warrant, is equal to or less than 3.2 million
- 17 acre-feet; or
- 18 (2) The total accumulated actual deficiencies below 4 million acre-feet
- in the immediately prior Water Year or series of successive prior Water Years each of which had
- 20 inflows of less than 4 million acre-feet, together with the forecasted deficiency for the current
- 21 Water Year, exceed 800,000 acre-feet.

For the purpose of determining a Critical Year, the computation of inflow to 1 2 Shasta Lake shall be performed in a manner that considers the extent of upstream development 3 above Shasta Lake during the year in question, and shall be used as the full natural flow to 4 Shasta Lake. In the event that major construction has occurred or occurs above Shasta Lake after 5 September 1, 1963, and which has materially altered or alters the regimen of the stream systems 6 contributing to Shasta Lake, the computed inflow to Shasta Lake used to define a Critical Year 7 will be adjusted to eliminate the effect of such material alterations. After consultation with the 8 State of California, the National Weather Service, and other recognized forecasting agencies, the 9 Contracting Officer will select the forecast to be used and will make the details of it available to 10 the Contractor. The same forecasts used by the United States for the operation of the Project 11 shall be used to make the forecasts hereunder; 12 (f) "CVPIA" shall mean the Central Valley Project Improvement Act, Title XXXIV of the Act of October 30, 1992 (106 Stat. 4706); 13 14 "Eligible Lands" shall mean all lands to which Project Water may be (g) 15 delivered in accordance with Section 204 of the Reclamation Reform Act of October 12, 1982 (96 Stat. 1263), as amended, hereinafter referred to as RRA; 16 "Excess Lands" shall mean all lands in excess of the limitations contained 17 (h) 18 in Section 204 of the RRA, other than those lands exempt from acreage limitation under Federal 19 Reclamation law; 20 (i) "Full Cost Rate" shall mean that water rate described in Sections 205(a)(3) 21 or 202(3) of the RRA, whichever is applicable; 22 "Ineligible Lands" shall mean all lands to which Project Water may not be (j) 23 delivered in accordance with Section 204 of the RRA;

1	(k) "Landholder" shall mean a party that directly or indirectly owns or leases
2	nonexempt land, as provided in 43 CFR 426.2;
3	(l) "Project" shall mean the Central Valley Project owned by the United
4	States and managed by the Department of the Interior, Bureau of Reclamation;
5	(m) "Project Water" shall mean all Surface Water diverted or scheduled to be
6	diverted each month during the period April through October of each Year by the Contractor
7	from the Sacramento River which is in excess of the Base Supply. The United States recognizes
8	the right of the Contractor to make arrangements for acquisition of water from projects of others
9	than the United States for delivery through the Sacramento River and tributaries subject to
10	written agreement between Contractor and the United States as to identification of such water
11	which water when so identified shall not be deemed Project Water under this Settlement
12	Contract;
13	(n) "Rates" shall mean the payments for Project Water determined annually
14	by the Contracting Officer in accordance with the then current applicable water ratesetting
15	policies for the Project, as described in subdivision (a) of Article 8 of this Settlement Contract;
16	(o) "Secretary" or "Contracting Officer" shall mean the Secretary of the
17	Interior, a duly appointed successor, or an authorized representative acting pursuant to any
18	authority of the Secretary and through any agency of the Department of the Interior;
19	(p) "Surface Water" shall mean only those waters that are considered as
20	surface water under California law;
21	(q) "Water Year" shall mean the period commencing with October 1 of 1 year
22	and extending through September 30 of the next; and
23	(r) "Year" shall mean a calendar year.

TERM OF SETTLEMENT CONTRACT

- 2. (a) This Settlement Contract shall become effective April 1, 2004, and shall remain in effect until and including March 31, 2044: <u>Provided</u>, that under terms and conditions mutually agreeable to the parties hereto, renewals may be made for successive periods not to exceed 40 years each. The terms and conditions of each renewal shall be agreed upon not later than 1 year prior to the expiration of the then existing Settlement Contract.
- pertaining thereto, upon written request by the Contractor of the Secretary made not later than 1 year prior to the expiration of this Settlement Contract, whenever, account being taken of the amount then credited to the costs of construction of water supply works, the remaining amount of construction costs of water supply work which is properly assignable for ultimate return by the Contractor as established by the Secretary of the Interior pursuant to (3) of Section 1 of Public Law 643 (70 Stat. 483), probably can be repaid to the United States within the term of a contract under subsection 9(d) of the 1939 Reclamation Project Act (53 Stat. 1187), the relevant portions of this Settlement Contract may be converted to a contract under said subsection 9(d) upon terms and conditions mutually agreeable to the United States and the Contractor. The Secretary shall make a determination 10 years after the date of execution of this Settlement Contract, and every 5 years thereafter, of whether a conversion to a contract under said subsection 9(d) can be accomplished pursuant to Public Law 643. Notwithstanding any provision of this Settlement Contract, the Contractor reserves and shall have all rights and benefits under Public Law 643.

WATER TO BE FURNISHED TO CONTRACTOR

3. (a) Subject to the conditions, limitations, and provisions hereinafter expressed, the Contractor is hereby entitled and authorized to divert from the Sacramento River

1 at the locations shown in Exhibit A, for beneficial use within the area delineated on Exhibit B, 2 (both Exhibits are attached hereto and made a part hereof), the Contract Total designated in 3 Exhibit A, or any revision thereof, in accordance with the monthly operating schedule required 4 by Article 3(c) of this Settlement Contract. The quantity of any water diverted under this 5 Settlement Contract from the Sacramento River, during the period April through October, for use 6 on any lands delineated on Exhibit B, by the owner of such lands or otherwise shall constitute a 7 part of the Contract Total as shown on Exhibit A and shall be subject to all the provisions of this Settlement Contract relating to such Contract Total as if such diversion were made by the 8 9 Contractor: Provided, however, that the Contractor reserves the right to, and may at its option, 10 divert water from Butte Creek to the extent permitted under Permits Nos. 4743, 4744, 5847, 11 5848; Licenses Nos. 2614, 2615, 2616, 2617; and the Decree rendered on May 25, 1920, by the 12 Superior Court of Sutter County in the matter of Central California Investment Company v. John Crouch Land Company, et al., Action No. 1355, for beneficial use within the area delineated on 13 14 Exhibit B; Provided, further that the Contractor is permitted during April, May, June, and 15 October of each Year to divert water from the Sacramento River in excess of the amounts 16 specified in Exhibit A in accordance with the Agreement Between the United States and M&T 17 Chico Ranch, Incorporated, and Parrott Investment Company, Incorporated, For Exchange of 18 Water from Butte Creek for Water from the Sacramento River, dated _____. The lawfulness 19 of the Contractor's points of diversion for said area from Butte Creek will not be challenged by, 20 or on behalf of, the Bureau of Reclamation except in the case of a general adjudication as 21 provided in subdivisions (b) and (c) of Article 9. The Contractor may have acquired rights to divert water from the 22 (b) 23 Sacramento River during the period April through October, that were obtained after the date of

1 execution of the Existing Contract, or the Contractor may acquire such rights in the future. All

2 diversions made from the Sacramento River, pursuant to such rights, during the period April

3 through October, shall not be considered a part of the quantity of Base Supply and Project Water

specified in Exhibit A; Provided, that the quantities diverted pursuant to the above rights shall be

identified on the schedule submitted pursuant to Article 3(c) below, and shall not be substituted

for any Base Supply or Project Water; Provided, further, that any such identified quantities of

other acquired rights may be diverted by the Contractor before incurring any fee pursuant to

8 Article 3(c)(1), below.

- (c) Before April 1 and before the first day of each month thereafter when a revision is needed, the Contractor shall submit a written schedule to the Contracting Officer indicating the Contract Total to be diverted by the Contractor during each month under this Settlement Contract. The United States shall furnish water to the Contractor in accordance with the monthly operating schedule or any revisions thereof. However, the United States recognizes the need of the Contractor to change from time to time its monthly diversions of water from the quantities shown in Exhibit A; the Contractor may make such changes, provided:
- (1) that for the quantity of Base Supply diverted in excess of the monthly quantity shown in Exhibit A, and as may be reduced in accordance with Article 5(a), during June, July, August, September, or October of any Water Year, the Contractor shall be charged a rescheduling fee equal to 50 percent of the sum of the storage operations and maintenance rate and the storage capital rate components of the Project ratesetting policy.
- 21 (2) that in no event shall the total quantity scheduled for diversion by 22 the Contractor from the Sacramento River:

1	(i) During the period April through October exceed the
2	aggregate of the Contract Total for that period shown in Exhibit A or any revision
3	thereof;
4	(ii) During the period July through September exceed the
5	aggregate of the Contract Total for that period shown in Exhibit A or any revision
6	thereof.
7	(d) In the event conditions warrant, the Contracting Officer reserves the right
8	to require the Contractor to submit, at least 72 hours prior to the beginning of each weekly
9	period, its estimate of daily diversion requirements for each such period from the Sacramento
10	River: <u>Provided</u> , <u>however</u> , that changes during any such period may be made upon the giving of
11	72 hours' notice thereof to the Contracting Officer.
12	(e) No sale, transfer, exchange, or other disposal of any of the Contract Total
13	designated in Exhibit A or the right to the use thereof for use on land other than that shown on
14	Exhibit B shall be made by the Contractor without first obtaining the written consent of the
15	Contracting Officer. Such consent will not be unreasonably withheld and a decision will be
16	rendered in a timely manner. For short-term actions that will occur within 1 year or less, the
17	decision will be rendered within 30 days after receipt of a complete written proposal. For long-
18	term actions that will occur in a period longer than 1 year, the decision will be rendered within
19	90 days after receipt of a complete written proposal. For a proposal to be deemed complete by
20	the Contracting Officer, it must comply with all provisions required by State and Federal law,
21	including information sufficient to enable the Contracting Officer to comply with the National
22	Environmental Policy Act, the Endangered Species Act, and applicable rules or regulations then
23	in effect; <u>Provided</u> that, such consent does not authorize the use of Federal facilities to facilitate

1 or effectuate the sale, transfer, exchange, or other disposal of Base Supply. Such use of Federal 2 facilities will be the subject of a separate agreement to be entered into between the Contractor 3 and Reclamation. 4 (f) For the purpose of determining whether Section 3405(a)(1)(M) of the 5 CVPIA applies to the Contractor as a transferor or transferee of Project Water, the Contracting 6 Officer acknowledges that the Contractor is within a county, watershed, or other area of origin, 7 as those terms are utilized under California law. 8 (g) Nothing herein contained shall prevent the Contractor from diverting 9 water during the months of November through March for beneficial use on the land shown on 10 Exhibit B or elsewhere to the extent authorized under the laws of the State of California. 11 (h) The United States assumes no responsibility for and neither it nor its 12 officers, agents, or employees shall have any liability for or on account of: 13 (1) The quality of water to be diverted by the Contractor; 14 (2) The control, carriage, handling, use, disposal, or distribution of 15 water diverted by the Contractor outside the facilities constructed and then being operated and 16 maintained by or on behalf of the United States; 17 (3) Claims of damage of any nature whatsoever, including but not 18 limited to, property loss or damage, personal injury, or death arising out of or connected with the 19 control, carriage, handling, use, disposal, or distribution of said water outside of the hereinabove 20 referred to facilities; and 21 (4) Any damage whether direct or indirect arising out of or in any 22 manner caused by a shortage of water whether such shortage be on account of errors in

23

operation, drought, or unavoidable causes.

1 <u>RETURN FLOW</u>

4. Nothing herein shall be construed as an abandonment or a relinquishment by the United States of any right it may have to the use of waste, seepage, and return flow water derived from water diverted by the Contractor hereunder and which escapes or is discharged beyond the boundaries of the lands shown on Exhibit B; Provided, that this shall not be construed as claiming for the United States any right to such water which is recovered by the Contractor pursuant to California law from within the boundaries of the lands shown on Exhibit B, and which is being used pursuant to this Settlement Contract for surface irrigation or underground storage for the benefit of the lands shown on Exhibit B by the Contractor.

CONSTRAINTS ON THE AVAILABILITY OF WATER

5. (a) In a Critical Year, the Contractor's Base Supply and Project Water agreed to be diverted during the period April through October of the Year in which the principal portion of the Critical Year occurs and, each monthly quantity of said period shall be reduced by 25 percent.

(b) The amount of any overpayment by the Contractor shall, at its option, be refunded or credited upon amounts to become due to the United States from the Contractor under the provisions hereof in the ensuing Year. To the extent of such deficiency such adjustment of overpayment shall constitute the sole remedy of the Contractor.

INTEGRATED WATER MANAGEMENT AND PARTNERSHIPS

6. The Contractor and United States desire to work together to maximize the reasonable beneficial use of water for their mutual benefit. As a consequence, the United States and the Contractor will work in partnership and with others within the Sacramento Valley, including other Contractors, to facilitate the better integration within the Sacramento Valley of

- all water supplies including, but not limited to, the better management and integration of surface
- 2 water and groundwater, the development and better utilization of surface water storage, the
- 3 effective utilization of waste, seepage and return flow water, and other operational and
- 4 management options that may be identified in the future.

USE OF WATER FURNISHED TO CONTRACTOR

- 6 7. (a) Project Water furnished to the Contractor pursuant to this Settlement
- 7 Contract shall not be delivered or furnished by the Contractor for any purposes other than
- 8 agricultural purposes without the written consent of the Contracting Officer. For purposes of this
- 9 Settlement Contract, "agricultural purposes" includes, but is not restricted to, the irrigation of
- 10 crops, the watering of livestock, incidental domestic use including related landscape irrigation, or
- 11 underground water replenishment.

- 12 (b) The Contractor shall comply with requirements applicable to the
- 13 Contractor in biological opinion(s) prepared as a result of a consultation regarding the execution
- of this Settlement Contract undertaken pursuant to Section 7 of the Endangered Species Act of
- 15 1973, as amended, that are within the Contractor's legal authority to implement. The Contractor
- shall comply with the limitations or requirements imposed by environmental documentation
- applicable to the Contractor and within its legal authority to implement. The Existing Contract,
- which evidences in excess of 40 years of diversions, for agricultural uses, of the quantities of
- 19 water provided for in Article 3, and the underlying water rights of the Contractor will be
- 20 considered in developing an appropriate base-line for the Biological Assessment prepared
- 21 pursuant to the Endangered Species Act, and in any other needed environmental review.
- Nothing herein shall be construed to prevent the Contractor from challenging or seeking judicial

2 environmental documentation referred to in this Article. 3 RATE AND METHOD OF PAYMENT FOR WATER 4 8. (a) The Contractor shall make payments to the United States as provided in 5 this Article for all Project Water shown in Exhibit A as follows: 6 (1) 75 percent of the amount shown as Project Water shall be paid for 7 by the Contractor in each Year; and in addition 8 (2) the Contractor shall pay for Project Water actually diverted in 9 excess of 75 percent of the amount shown as Project Water. 10 Such payments shall be at Rates and Charges established in accordance with: (i) the 11 Secretary's then-current ratesetting policies for the Project; and (ii) applicable Reclamation law 12 and associated rules and regulations, or policies: Provided, that if the Contractor desires to use 13 Project Water for other than agricultural use the Rates and Charges set forth above will be adjusted by the Contracting Officer to the applicable Rates and Charges for such use. The Rates 14 15 and Charges applicable to the Contractor upon execution of this Settlement Contract are set forth 16 in Exhibit D, as may be revised annually. The Secretary's ratesetting policies for the Project 17 shall be amended, modified, or superseded only through a public notice and comment procedure. 18 The Contracting Officer shall adjust the amount of Project Water for which payment is required 19 to the extent of any reduction in diversions of Project Water made in accordance with the water 20 conservation provisions of Article 29(e). 21 (b) The Contracting Officer shall notify the Contractor of the Rates and 22 Charges as follows:

1	(1) Prior to July 1 of each Year, the Contracting Officer shall provide
2	the Contractor an estimate of the Charges for Project Water that will be applied to the period
3	October 1, of the current Year, through September 30, of the following Year, and the basis for
4	such estimate. The Contractor shall be allowed not less than 2 months to review and comment
5	on such estimates. On or before September 15 of each Year, the Contracting Officer shall notify
6	the Contractor in writing of the Charges to be in effect during the period October 1 of the current

15	(c) The Contractor shall pay the United States for Project Water in the
16	following manner:
17	(1) With respect to Rates, prior to May 1 of each Year, the Contractor
18	shall pay the United States one-half the total amount payable pursuant to subdivision (a) of this
19	Article and the remainder shall be paid prior to July 1 or such later date or dates as may be
20	specified by the United States in a written notice to the Contractor: <u>Provided</u> , <u>however</u> , that if at
21	any time during the Year the amount of Project Water diverted by the Contractor shall equal the
22	amount for which payment has been made, the Contractor shall pay for the remaining amount of
23	such water as shown in Exhibit A in advance of any further diversion of Project Water.

1	(2) With respect to Charges, the Contractor shall also make a payment
2	to the United States, in addition to the Rate(s) in subdivision (c)(1) of this Article, at the Charges
3	then in effect, before the end of the month following the month of delivery or transfer. The
4	payments shall be consistent with the quantities of Project Water delivered or transferred.
5	Adjustment for overpayment or underpayment of Charges shall be made through the adjustment
6	of payments due to the United States for Charges for the next month. Any amount to be paid for
7	past due payment of Charges shall be computed pursuant to Article 13 of this Settlement
8	Contract.
9	(d) Payments to be made by the Contractor to the United States under this
10	Settlement Contract may be paid from any revenues available to the Contractor.
11	(1) All revenues received by the United States from the Contractor
12	relating to the delivery of Project Water or the delivery of non-Project Water through Project
13	facilities shall be allocated and applied in accordance with Federal Reclamation law and the
14	associated rules or regulations, and the then current Project ratesetting policies for irrigation
15	water.
16	(e) The Contracting Officer shall keep its accounts pertaining to the
17	administration of the financial terms and conditions of its long-term water service and Settlement
18	Contracts, in accordance with applicable Federal standards, so as to reflect the application of
19	Project costs and revenues. The Contracting Officer shall, each Year upon request of the
20	Contractor, provide to the Contractor a detailed accounting of all Project and Contractor expense
21	allocations, the disposition of all Project and Contractor revenues, and a summary of all water
22	delivery information. The Contracting Officer and the Contractor shall enter into good faith

1 negotiations to resolve any discrepancies or disputes relating to accountings, reports, or 2

information.

3 (f) The parties acknowledge and agree that the efficient administration of this 4 Settlement Contract is their mutual goal. Recognizing that experience has demonstrated that 5 mechanisms, policies, and procedures used for establishing Rates and Charges and/or for making 6 and allocating payments, other than those set forth in this Article may be in the mutual best 7 interest of the parties, it is expressly agreed that the parties may enter into agreements to modify 8 the mechanisms, policies, and procedures for any of those purposes while this Settlement

Contract is in effect without amendment of this Settlement Contract.

For the term of this Settlement Contract, Rates under the respective (g) ratesetting policies for the Project will be established to recover only reimbursable operation and maintenance (including any deficits) and capital costs of the Project, as those terms are used in the then current Project ratesetting policies, and interest, where appropriate, except in instances where a minimum Rate is applicable in accordance with the relevant Project ratesetting policy. Proposed changes of significance in practices which implement the ratesetting policies for the Project will not be implemented until the Contracting Officer has provided the Contractor an opportunity to discuss the nature, need, and impact of the proposed change. The Contractor retains all rights to challenge the validity of Rates and Charges imposed pursuant to this Settlement Contract, including but not limited to operation and maintenance expenses and operation and maintenance deficits, in an appropriate administrative or judicial proceeding.

(h) Except as provided in subsection 3405(a)(1)(B) of the CVPIA, the Rates for Project Water transferred, exchanged, or otherwise disposed of, by the Contractor shall be the Contractor's Rates adjusted upward or downward to reflect the changed costs of delivery (if any)

- of the transferred, exchanged, or otherwise disposed of Project Water to the transferee's point of
- 2 delivery in accordance with the then-current ratesetting policies for the Project. Except as
- 3 provided in subsection 3407(d)(2)(A) of the CVPIA, the Charges for Project Water transferred,
- 4 exchanged, or otherwise disposed of, by the Contractor shall be the Contractor's Charges
- 5 specified in Exhibit D. If the Contractor is receiving lower Rates and Charges because of
- 6 inability to pay and is transferring, exchanging, or otherwise disposing of Project Water to
- 7 another entity whose Rates and Charges are not adjusted due to inability to pay, the Rates and
- 8 Charges for transferred, exchanged, or otherwise disposed of Project Water shall be the
- 9 Contractor's Rates and Charges unadjusted for ability to pay.

- Officer is authorized to adjust determinations of ability to pay every 5 years.

- by cash transaction, wire, or any other mechanism as may be agreed to in writing by the

- the amount due, the delinquent payment provisions of Article 13 shall apply. The Contractor
- shall not be relieved of the whole or any part of its said obligation by, on account of, or
- 20 notwithstanding, as the case may be:
- 21 (1) Its failure, refusal, or neglect to divert 75 percent of the quantity of
- 22 Project Water shown on Exhibit A;

10	9. (a) During the term of this Settlement Contract and any renewals thereof:
11	(1) It shall constitute full agreement as between the United States and
12	the Contractor as to the quantities of water and the allocation thereof between Base Supply and
13	Project Water which may be diverted by the Contractor from the Sacramento River for beneficial
14	use on the land shown on Exhibit B which said diversion, use, and allocation shall not be
15	disturbed so long as the Contractor shall fulfill all of its obligations hereunder;

MEASUREMENT OF WATER

- 10. (a) All water diverted by the Contractor from the Sacramento River will be diverted at the existing point or points of diversion shown on Exhibit A or at such other points as may be mutually agreed upon in writing by the Contracting Officer and the Contractor.
- (b) All water diverted from the Sacramento River pursuant to this Settlement Contract will be measured or caused to be measured by the United States at each point of diversion with existing equipment or equipment to be installed, operated, and maintained by the United States, and/or others, under contract with and at the option of the United States. The equipment and methods used to make such measurement shall be in accordance with sound engineering practices. Upon request of the Contractor, the accuracy of such measurements will be investigated by the Contracting Officer and any errors appearing therein will be corrected.
- (c) The right of ingress to and egress from all points of diversion is hereby granted to all authorized employees of the United States. The Contractor also hereby grants to the United States the right to install, operate, maintain, and replace such equipment on diversion or carriage facilities at each point of diversion as the Contracting Officer deems necessary.
- (d) The Contractor shall not modify, alter, remove, or replace diversion facilities or do any other act which would alter the effectiveness or accuracy of the measuring equipment installed by the United States or its representatives unless and until the Contracting Officer has been notified with due diligence and has been given an opportunity to modify such measuring equipment in such manner as may be necessary or appropriate. In the event of an emergency the Contractor shall notify the United States within a reasonable time thereafter as to

1 the existence of the emergency and the nature and extent of such modification, alteration, 2 removal, or replacement of diversion facilities. 3 The Contractor shall pay the United States for the costs to repair, relocate, (e) 4 or replace measurement equipment when the Contractor modifies, alters, removes, or replaces 5 diversion or carriage facilities. 6 (f) Contractor and Contracting Officer shall develop a mutually agreeable 7 surface water delivery water measurement program which shall be implemented by the 8 Contractor, and such measurement program shall be consistent with the conservation and 9 efficiency criteria for evaluating water conservation plans as provided in Article 29(a). 10 All new surface water delivery systems installed within the lands (g) 11 delineated on Exhibit B after the effective date of this Settlement Contract shall also comply with 12 the measurement provisions described in this Article. **RULES AND REGULATIONS** 13 14 11. The parties agree that the delivery of Project Water for irrigation use or use of 15 Federal facilities pursuant to this Settlement Contract is subject to Federal Reclamation law, 16 including but not limited to, the Reclamation Reform Act of 1982 (43 U.S.C. 390aa et seq.), as 17 amended and supplemented, and the rules and regulations promulgated by the Secretary of the 18 Interior under Federal Reclamation law. 19 GENERAL OBLIGATION--BENEFITS CONDITIONED UPON PAYMENT 20 12. (a) The obligation of the Contractor to pay the United States as provided in 21 this Settlement Contract is a general obligation of the Contractor notwithstanding the manner in which the obligation may be distributed among the Contractor's water users and notwithstanding 22 23 the default of individual water users in their obligations to the Contractor. 24 The payment of Charges becoming due hereunder is a condition precedent to receiving benefits under this Settlement Contract. The United States shall not make water 25 available to the Contractor through Project facilities during any period in which the Contractor 26

may be in arrears in the advance payment of water Rates due the United States. The Contractor 1 2 shall not furnish water made available pursuant to this Settlement Contract for lands or parties 3 which are in arrears in the advance payment of water rates levied or established by the 4 Contractor. 5 With respect to subdivision (b) of this Article, the Contractor shall have no (c) 6 obligation to require advance payment for water Rates which it levies. 7 CHARGES FOR DELINQUENT PAYMENTS 8 13. (a) The Contractor shall be subject to interest, administrative and penalty 9 charges on delinquent installments or payments. When a payment is not received by the due 10 date, the Contractor shall pay an interest charge for each day the payment is delinquent beyond 11 the due date. When a payment becomes 60 days delinquent, the Contractor shall pay an administrative charge to cover additional costs of billing and processing the delinquent payment. 12 13 When a payment is delinquent 90 days or more, the Contractor shall pay an additional penalty charge of six percent per year for each day the payment is delinquent beyond the due date. 14 15 Further, the Contractor shall pay any fees incurred for debt collection services associated with a delinquent payment. 16 17 The interest charge rate shall be the greater of the rate prescribed quarterly 18 in the Federal Register by the Department of the Treasury for application to overdue payments, 19 or the interest rate of one-half of one percent per month prescribed by Section 6 of the 20 Reclamation Project Act of 1939 (Public Law 76-260). The interest charge rate shall be 21 determined as of the due date and remain fixed for the duration of the delinquent period. 22 When a partial payment on a delinquent account is received, the amount 23 received shall be applied, first to the penalty, second to the administrative charges, third to the 24 accrued interest, and finally to the overdue payment. 25 QUALITY OF WATER 26 14. The operation and maintenance of Project facilities shall be performed in such 27 manner as is practicable to maintain the quality of raw water made available through such 28 facilities at the highest level reasonably attainable as determined by the Contracting Officer. The 29 United States does not warrant the quality of water and is under no obligation to construct or 30 furnish water treatment facilities to maintain or better the quality of water.

1 WATER AND AIR POLLUTION CONTROL 2 15. The Contractor, in carrying out this Settlement Contract, shall comply with all 3 applicable water and air pollution laws and regulations of the United States and the State of 4 California, and shall obtain all required permits or licenses from the appropriate Federal, State, 5 or local authorities. 6 **EQUAL OPPORTUNITY** 7 During the performance of this Settlement Contract, the Contractor agrees as 16. 8 follows: 9 (a) The Contractor will not discriminate against any employee or applicant for employment because of race, color, religion, sex, or national origin. The Contractor will take 10 affirmative action to ensure that applicants are employed, and that employees are treated during 11 12 employment, without regard to their race, color, religion, sex, or national origin. Such action shall include, but not be limited to, the following: Employment, upgrading, demotion, or 13 14 transfer; recruitment or recruitment advertising; layoff or termination, rates of payment or other 15 forms of compensation; and selection for training, including apprenticeship. The Contractor 16 agrees to post in conspicuous places, available to employees and applicants for employment, 17 notices to be provided by the Contracting Officer setting forth the provisions of this nondiscrimination clause. 18 19 The Contractor will, in all solicitations or advertisements for employees 20 placed by or on behalf of the Contractor, state that all qualified applicants will receive 21 consideration for employment without discrimination because of race, color, religion, sex, or 22 national origin. 23 The Contractor will send to each labor union or representative of workers (c) 24 with which it has a collective bargaining agreement or other contract or understanding, a notice, 25 to be provided by the Contracting Officer, advising the said labor union or workers' 26 representative of the Contractor's commitments under Section 202 of Executive Order No. 11246 of September 24, 1965, as amended, and shall post copies of the notice in conspicuous places 27 available to employees and applicants for employment. 28 29 (d) The Contractor will comply with all provisions of Executive Order 30 No. 11246 of September 24, 1965, as amended, and of the rules, regulations, and relevant orders 31 of the Secretary of Labor. 32 (e) The Contractor will furnish all information and reports required by said 33 amended Executive Order and by the rules, regulations, and orders of the Secretary of Labor, or 34 pursuant thereto, and will permit access to its books, records, and accounts by the Contracting

28 29 30 31 32 33 34	26. The Contractor, after the execution of this Settlement Contract, shall promptly seek to secure a decree of a court of competent jurisdiction of the State of California, if appropriate, confirming the execution of this Settlement Contract. The Contractor shall furnish the United States a certified copy of the final decree, the validation proceedings, and all pertinent supporting records of the court approving and confirming this Settlement Contract, and decreeing and adjudging it to be lawful, valid, and binding on the Contractor. This Settlement Contract shall not be binding on the United States until such final decree has been secured.

1 UNAVOIDABLE GROUNDWATER PERCOLATION 2 27. To the extent applicable, the Contractor shall not be deemed to have delivered Project Water to Excess Lands or Ineligible Lands if such lands are irrigated with groundwater 3 4 that reaches the underground strata as an unavoidable result of the delivery of Project Water by 5 the Contractor to Eligible Lands. 6 PRIVACY ACT COMPLIANCE 7 28. (a) The Contractor shall comply with the Privacy Act of 1974 (5 U.S.C. 552a) (the Act) and the Department of the Interior rules and regulations under the Act (43 CFR 2.45 et 8 9 seq.) in maintaining Landholder acreage certification and reporting records, required to be 10 submitted to the Contractor for compliance with Sections 206 and 228 of the Reclamation Reform Act of 1982 (96 Stat. 1266), and pursuant to 43 CFR 426.18. 11 12 (b) With respect to the application and administration of the criminal penalty 13 provisions of the Act (5 U.S.C. 552a(i)), the Contractor and the Contractor's employees 14 responsible for maintaining the certification and reporting records referenced in (a) above are 15 considered to be employees of the Department of the Interior. See 5 U.S.C. 552a(m). 16 The Contracting Officer or a designated representative shall provide the Contractor with current copies of the Interior Department Privacy Act regulations and the Bureau 17 18 of Reclamation Federal Register Privacy Act System of Records Notice (Acreage Limitation--19 Interior, Reclamation-31) which govern the maintenance, safeguarding, and disclosure of 20 information contained in the Landholder's certification and reporting records. 21 The Contracting Officer shall designate a full-time employee of the 22 Bureau of Reclamation to be the System Manager who shall be responsible for making decisions 23 on denials pursuant to 43 CFR 2.61 and 2.64 amendment requests pursuant to 43 CFR 2.72. The 24 Contractor is authorized to grant requests by individuals for access to their own records. 25 The Contractor shall forward promptly to the System Manager each proposed denial of access under 43 CFR 2.64; and each request for amendment of records filed 26 27 under 43 CFR 2.71; notify the requester accordingly of such referral; and provide the System 28 Manager with information and records necessary to prepare an appropriate response to the 29 requester. These requirements do not apply to individuals seeking access to their own 30 certification and reporting forms filed with the Contractor pursuant to 43 CFR 426.18, unless the 31 requester elects to cite the Privacy Act as a basis for the request.

WATER CONSERVATION

29. (a) Prior to the diversion of Project Water, the Contractor shall be
implementing an effective water conservation and efficiency program based on the Basin-Wide
Water Management Plan and/or Contractor's water conservation plan that has been determined
by the Contracting Officer to meet the conservation and efficiency criteria for evaluating water
conservation plans established under Federal law. The water conservation and efficiency
program shall contain definite water conservation objectives, appropriate economically feasible
water conservation measures, and time schedules for meeting those objectives. Continued
diversion of Project Water pursuant to this Settlement Contract shall be contingent upon the
Contractor's continued implementation of such water conservation program. In the event the
Contractor's water conservation plan or any revised water conservation plan completed pursuant
to subdivision (c) of Article 29 of this Settlement Contract have not yet been determined by the
Contracting Officer to meet such criteria, due to circumstances which the Contracting Officer
determines are beyond the control of the Contractor, Project Water deliveries shall be made
under this Settlement Contract so long as the Contractor diligently works with the Contracting
Officer to obtain such determination at the earliest practicable date, and thereafter the Contractor
immediately begins implementing its water conservation and efficiency program in accordance
with the time schedules therein.
(b) The Contractor shall submit to the Contracting Officer a report on the
status of its implementation of the water conservation plan on the reporting dates specified in the
then existing conservation and efficiency criteria established under Federal law.
(c) At 5-year intervals, the Contractor shall revise its water conservation plan
to reflect the then current conservation and efficiency criteria for evaluating water conservation

- 1 plans established under Federal law and submit such revised water management plan to the
- 2 Contracting Officer for review and evaluation. The Contracting Officer will then determine if
- 3 the water conservation plan meets Reclamation's then current conservation and efficiency
- 4 criteria for evaluating water conservation plans established under Federal law.
- 5 (d) If the Contractor is engaged in direct ground-water recharge, such activity
- 6 shall be described in the Contractor's water conservation plan.
- 7 (e) In order to provide incentives for water conservation, the Contractor may
- 8 reduce the amount of Project Water for which payment is required under Article 8(a) in
- 9 accordance with the provisions of this Article 29(e).
- 10 On or before February 15 of any Water Year, the Contractor may
- 11 file with Reclamation an offer to reduce Project Water use, hereinafter referred to as Offer. The
- 12 Offer shall specify the maximum quantity of Project Water to be diverted by the Contractor for
- each month that Project Water is available for that Water Year under this Settlement Contract.
- 14 The Contracting Officer shall provide the Contractor with a decision, in writing, to the Offer on
- or before March 15 of that Water Year. The dates specified in this Article 29(e)(1) can be
- 16 changed if mutually agreed to, in writing, by the Contractor and Contracting Officer.
- 17 (2) If Reclamation accepts the Offer, the Contractor's payment
- obligation under Article 8(a)(1) shall be reduced to the maximum quantity of Project Water to be
- diverted by the Contractor as specified in the Offer. The Contractor shall not divert Project
- Water in excess of the quantities set forth in the Offer: Provided, however, if the Contractor's
- 21 diversions of Project Water exceed the quantities set forth in the Offer, the Contractor shall pay
- 22 to Reclamation the applicable Rates and Charges plus an amount equal to the applicable Rates

- and Charges, unadjusted for ability to pay, for each acre-foot of Project Water diverted in excess
 of the quantities set forth in the Offer.
- 3 (3) If Reclamation decides not to accept the Offer, the Contractor's payment obligation will remain as specified in Article 8(a)(1).
- 5 (4) The provisions of this Article 29(e) shall be in addition to and shall not affect the provisions of Article 3(e) pertaining to the sale, transfer, exchange, or other disposal of the Contract Total designated in Exhibit A.

OPINIONS AND DETERMINATIONS

- 30. (a) Where the terms of this Settlement Contract provide for actions to be based upon the opinion or determination of either party to this Settlement Contract, said terms shall not be construed as permitting such action to be predicated upon arbitrary, capricious, or unreasonable opinions or determinations. Both parties, notwithstanding any other provisions of this Settlement Contract, expressly reserve the right to seek relief from and appropriate adjustment for any such arbitrary, capricious, or unreasonable opinion or determination. Each opinion or determination by either party shall be provided in a timely manner. Nothing in subdivision (a) of Article 30 of this Settlement Contract is intended to or shall affect or alter the standard of judicial review applicable under Federal law to any opinion or determination implementing a specific provision of Federal law embodied in statute or regulation.
- (b) The Contracting Officer shall have the right to make determinations necessary to administer this Settlement Contract that are consistent with the provisions of this Settlement Contract, the laws of the United States and of the State of California, and the rules and regulations promulgated by the Secretary of the Interior. Such determinations shall be made in consultation with the Contractor to the extent reasonably practicable.

CONTRACTOR TO PAY CERTAIN MISCELLANEOUS COSTS

Settlement Contract.

31. (a) In addition to all other payments to be made by the Contractor pursuant to this Settlement Contract, the Contractor shall pay to the United States, within 60 days after receipt of a bill and detailed statement submitted by the Contracting Officer to the Contractor for such specific items of direct cost incurred by the United States for work requested by the Contractor associated with this Settlement Contract plus indirect costs in accordance with applicable Bureau of Reclamation policies and procedures. All such amounts referred to in this Article shall not exceed the amount agreed to in writing in advance by the Contractor. This Article shall not apply to costs for routine contract administration.

(b) All advances for miscellaneous costs incurred for work requested by the Contractor pursuant to Article 31 of this Settlement Contract shall be adjusted to reflect the actual costs when the work has been completed. If the advances exceed the actual costs incurred, the difference will be refunded to the Contractor. If the actual costs exceed the Contractor's

advances, the Contractor will be billed for the additional costs pursuant to Article 31 of this

32. The waiver by either party to this Settlement Contract as to any default shall not be construed as a waiver of any other default or as authority of the other party to continue such default or to make, do, or perform, or not to make, do, or perform, as the case may be, any act or thing which would constitute a default.

1 CONTRACT ASSIGNMENT OR TERMINATION UPON TRANSFER OF LAND 2 33. The rights and obligations of the Contractor may be transferred in (a) 3 connection with the transfer of title to the land or any portion thereof delineated on Exhibit B on 4 the following terms and conditions: 5 (1) A voluntary inter vivos transfer may be made, upon mutual 6 agreement of the United States and the Contractor, to a person eligible to hold title to the land as 7 a nonexcess landowner: 8 (2) A voluntary inter vivos transfer may be made to a person ineligible 9 to hold title to the land as a nonexcess landowner provided that no Project Water may thereafter 10 be used on Excess Lands and the assignee shall not be privileged to obtain such use of Project 11 Water on Excess Lands. 12 (3) In the event the title of the Contractor to such land, or any portion 13 thereof, is transferred by operation of law, such as by conveyance in satisfaction of a mortgage, 14 by inheritance, or by devise, the rights and obligations of the Contractor shall pass with the title 15 and the land shall be subject to provisions of Reclamation law pertaining to such transfers. Any 16 transfer of the rights and obligations of this Settlement Contract by the person acquiring title by 17 operation of law shall be in accordance with provisions of subsection (1) or (2) above. 18 (b) The Contractor shall notify the Contracting Officer in writing of any 19 proposed transfer of this Settlement Contract. In addition, in the case of a partial assignment the 20 Contractor shall: 21 (1) Designate the proportionate quantities of Base Supply and Project 22 Water which it desires to assign;

1	(2) Furnish the United States with a copy of the deed transferring title.
2	(c) No transfer of this Settlement Contract shall be effective unless and until
3	approved by the Contracting Officer, and, if approved, shall be effective from the date of such
4	approval.
5	(d) Upon mutual agreement between the United States and the Contractor, thi
6	Settlement Contract or a portion thereof may be terminated and the new landowner will have the
7	privilege of entering into a Settlement Contract for water service for a proportionate share of the

10	34. This Settlement Contract will terminate upon mutual agreement of the parties
11	prior to the end of the term or any renewal thereof.
