13	THIS CONTRACT, hereinafter referred to as "Settlement Contract," is entered
14	into by THE UNITED STATES OF AMERICA, hereinafter referred to as the United States,
15	made this day of, 2004, pursuant to the applicable authority
16	granted to it generally in the Act of June 17, 1902 (32 Stat. 388), and acts amendatory or
17	supplementary thereto, including, but not limited to, the Acts of August 26, 1937 (50 Stat. 844),
18	as amended and supplemented, August 4, 1939 (53 Stat. 1187), as amended and supplemented,
19	including but not limited to Sections 9 and 14 thereto, July 2, 1956 (70 Stat. 483), June 21, 1963
20	(77 Stat. 68), October 12, 1982 (96 Stat. 1262), October 27, 1986 (100 Stat. 3050), as amended,
21	and Title XXXIV of the Act of October 30, 1992 (106 Stat. 4706), all collectively hereinafter
22	referred to as Federal Reclamation law, and MARILYN LAMB WIRTH, TRUSTEE OF THE
23	MARILYN LAMB WIRTH TRUST, hereinafter referred to as the Contractor, a trust, acting
24	pursuant to Sections 12003 and 12004 of the California Water Code, with its principal place of
25	business in California;
26	WITNESSETH, that:

1 EXPLANATORY RECITALS $[1^{st]}$ 2 WHEREAS, the United States has constructed and is operating the Central Valley 3 Project, California, for multiple purposes pursuant to its statutory authority; and $[2^{nd}]$ 4 WHEREAS, the Contractor has rights to divert, is diverting, and will continue to 5 divert for reasonable beneficial use, water from the natural flow of the Sacramento River and 6 tributaries thereto, that would have been flowing therein if the Central Valley Project were not in 7 existence; and $[3^{rd}]$ 8 WHEREAS, the construction and operation of the integrated and coordinated 9 Central Valley Project has changed and will further change the regimen of the Sacramento, 10 American, San Joaquin, and Trinity Rivers and the Sacramento-San Joaquin Delta from 11 unregulated flow to regulated flow; and [4^{th]} WHEREAS, the United States has rights to divert, is diverting, and will continue 12 13 to divert waters from said Rivers and said Delta in connection with the operation of said Central 14 Valley Project; and [5^{th]} WHEREAS, the Contractor and the United States had a dispute over the 15 16 respective rights of the parties to divert and use water from the regulated flow of the Sacramento 17 River which threatened to result in litigation, and as a means to settle that dispute entered into 18 Contract No. 14-06-200-2486A, as amended, hereinafter referred to as the Existing Contract, 19 which established terms for the delivery to the Contractor of Central Valley Project Water, and 20 the quantities of Base Supply the United States and the Contractor agreed may be diverted by the 21 Contractor from the Sacramento River pursuant to such contract; and

[5.1] WHEREAS, Marilyn Lamb Wirth, Trustee of the Marilyn Lamb Wirth Trust is the successor in interest to Marilyn L. Davis and Rosamond L. Vallejo, Co-Trustees of the Lamb Family Trust; and

[6^{th]} WHEREAS, the United States and the Contractor disagree with respect to the authority of the United States to change the quantities of Base Supply and/or Project Water specified as available for diversion in this Settlement Contract from the quantities specified in the Existing Contract, and other issues related thereto. That dispute was the subject of litigation in a lawsuit entitled Glenn-Colusa Irrigation District, et al. v. United States, et al. [Civ. No. S-01-1816 GEB/JFM (E.D. Cal.)], but that litigation was dismissed, without prejudice, pursuant to a stipulation of dismissal filed by the parties thereto on August 29, 2002. Notwithstanding that dismissal, the Contractor and the United States enter into this Settlement Contract to renew the Existing Contract, pursuant to the terms of the Existing Contract, Federal Reclamation law, and the laws of the State of California; and [7^{th]} WHEREAS, to assure the Contractor of the enjoyment and use of the regulated flow of the said Rivers and the Delta, and to provide for the economical operation of the Central Valley Project by, and the reimbursement to, the United States for expenditures made for said Project. NOW, THEREFORE, in consideration of the performance of the herein contained

provisions, conditions, and covenants, it is agreed as follows:

1. When used herein, unless otherwise expressed or incompatible with the intent hereof, the term:

1	(a) "Base Supply" shall mean the quantity of Surface Water established in		
2	Articles 3 and 5 which may be diverted by the Contractor from the Sacramento River each month		
3	during the period April through October of each Year without payment to the United States for		
4	such quantities diverted;		
5	(b) "Basin-Wide Water Management Plan" shall mean the mutually agreeable		
6	Sacramento River Basinwide Water Management Plan, dated, developed by Glenn-		
7	Colusa Irrigation District, Maxwell Irrigation District, Natomas Central Mutual Water Company,		
8	Pelger Mutual Water Company, Princeton-Codora Glenn Irrigation District, Provident Irrigation		
9	District, Reclamation District 108, Sutter Mutual Water Company, Anderson-Cottonwood		
10	Irrigation District, Meridian Farms Water Company, Reclamation District 1004, and the U.S.		
11	Bureau of Reclamation;		
12	(c) "Charges" shall mean the payments for Project Water that the Contractor		
13	is required to pay to the United States in addition to the "Rates" specified in this Settlement		
14	Contract. The Contracting Officer will, on an annual basis, determine the extent of these		
15	Charges. The type and amount of each Charge shall be specified in Exhibit D;		
16	(d) "Contract Total" shall mean the sum of the Base Supply and Project Water		
17	available for diversion by the Contractor for the period April 1 through October 31;		
18	(e) "Critical Year" shall mean any Year in which either of the following		
19	eventualities exists:		
20	(1) The forecasted full natural inflow to Shasta Lake for the current		
21	Water Year, as such forecast is made by the United States on or before February 15 and reviewed		
22	as frequently thereafter as conditions and information warrant, is equal to or less than 3.2 million		
23	acre-feet; or		

1 (2) The total accumulated actual deficiencies below 4 million acre-feet 2 in the immediately prior Water Year or series of successive prior Water Years each of which had 3 inflows of less than 4 million acre-feet, together with the forecasted deficiency for the current 4 Water Year, exceed 800,000 acre-feet. 5 For the purpose of determining a Critical Year, the computation of inflow to 6 Shasta Lake shall be performed in a manner that considers the extent of upstream development 7 above Shasta Lake during the year in question, and shall be used as the full natural flow to 8 Shasta Lake. In the event that major construction has occurred or occurs above Shasta Lake after 9 September 1, 1963, and which has materially altered or alters the regimen of the stream systems 10 contributing to Shasta Lake, the computed inflow to Shasta Lake used to define a Critical Year 11 will be adjusted to eliminate the effect of such material alterations. After consultation with the 12 State of California, the National Weather Service, and other recognized forecasting agencies, the 13 Contracting Officer will select the forecast to be used and will make the details of it available to 14 the Contractor. The same forecasts used by the United States for the operation of the Project 15 shall be used to make the forecasts hereunder; (f) 16 "CVPIA" shall mean the Central Valley Project Improvement Act, 17 Title XXXIV of the Act of October 30, 1992 (106 Stat. 4706); 18 "Eligible Lands" shall mean all lands to which Project Water may be (g) 19 delivered in accordance with Section 204 of the Reclamation Reform Act of October 12, 1982 20 (96 Stat. 1263), as amended, hereinafter referred to as RRA; 21 (h) "Excess Lands" shall mean all lands in excess of the limitations contained 22 in Section 204 of the RRA, other than those lands exempt from acreage limitation under Federal 23 Reclamation law;

1	(i) "Full Cost Rate" shall mean that water rate described in Sections 205(a)(3)		
2	or 202(3) of the RRA, whichever is applicable;		
3	(j) Omitted;		
4	(k) "Landholder" shall mean a party that directly or indirectly owns or leases		
5	nonexempt land, as provided in 43 CFR 426.2;		
6	(l) "Project" shall mean the Central Valley Project owned by the United		
7	States and managed by the Department of the Interior, Bureau of Reclamation;		
8	(m) "Project Water" shall mean all Surface Water diverted or scheduled to be		
9	diverted each month during the period April through October of each Year by the Contractor		
10	from the Sacramento River which is in excess of the Base Supply. The United States recognizes		
11	the right of the Contractor to make arrangements for acquisition of water from projects of others		
12	than the United States for delivery through the Sacramento River and tributaries subject to		
13	written agreement between Contractor and the United States as to identification of such water,		
14	which water, when so identified, shall not be deemed Project Water under this Settlement		
15	Contract;		
16	(n) "Rates" shall mean the payments for Project Water determined annually		
17	by the Contracting Officer in accordance with the then current applicable water ratesetting		
18	policies for the Project, as described in subdivision (a) of Article 8 of this Settlement Contract;		
19	(o) "Secretary" or "Contracting Officer" shall mean the Secretary of the		
20	Interior, a duly appointed successor, or an authorized representative acting pursuant to any		
21	authority of the Secretary and through any agency of the Department of the Interior;		
22	(p) "Surface Water" shall mean only those waters that are considered as		
23	surface water under California law;		

- 1 (q) "Water Year" shall mean the period commencing with October 1 of 1 year 2 and extending through September 30 of the next; and
- 3 (r) "Year" shall mean a calendar year.

TERM OF SETTLEMENT CONTRACT

- 2. (a) This Settlement Contract shall become effective April 1, 2004, and shall remain in effect until and including March 31, 2044: <u>Provided</u>, that under terms and conditions mutually agreeable to the parties hereto, renewals may be made for successive periods not to exceed 40 years each. The terms and conditions of each renewal shall be agreed upon not later than 1 year prior to the expiration of the then existing Settlement Contract.
- pertaining thereto, upon written request by the Contractor of the Secretary made not later than 1 year prior to the expiration of this Settlement Contract, whenever, account being taken of the amount then credited to the costs of construction of water supply works, the remaining amount of construction costs of water supply work which is properly assignable for ultimate return by the Contractor as established by the Secretary of the Interior pursuant to (3) of Section 1 of Public Law 643 (70 Stat. 483), probably can be repaid to the United States within the term of a contract under subsection 9(d) of the 1939 Reclamation Project Act (53 Stat. 1187), the relevant portions of this Settlement Contract may be converted to a contract under said subsection 9(d) upon terms and conditions mutually agreeable to the United States and the Contractor. The Secretary shall make a determination 10 years after the date of execution of this Settlement Contract, and every 5 years thereafter, of whether a conversion to a contract under said subsection 9(d) can be accomplished pursuant to Public Law 643. Notwithstanding any provision of this Settlement Contract, the Contractor reserves and shall have all rights and benefits under Public Law 643.

WATER TO BE FURNISHED TO CONTRACTOR

3. Subject to the conditions, limitations, and provisions hereinafter (a) expressed, the Contractor is hereby entitled and authorized to divert from the Sacramento River at the locations shown in Exhibit A, for beneficial use within the area delineated on Exhibit B, (both Exhibits are attached hereto and made a part hereof), the Contract Total designated in Exhibit A, or any revision thereof. (b) No sale, transfer, exchange, or other disposal of any of the Contract Total designated in Exhibit A or the right to the use thereof for use on land other than that shown on Exhibit B shall be made by the Contractor without first obtaining the written consent of the Contracting Officer. Such consent will not be unreasonably withheld and a decision will be rendered in a timely manner. For short-term actions that will occur within 1 year or less, the decision will be rendered within 30 days after receipt of a complete written proposal. For longterm actions that will occur in a period longer than 1 year, the decision will be rendered within 90 days after receipt of a complete written proposal. For a proposal to be deemed complete by the Contracting Officer, it must comply with all provisions required by State and Federal law, including information sufficient to enable the Contracting Officer to comply with the National Environmental Policy Act, the Endangered Species Act, and applicable rules or regulations then in effect; Provided that, such consent does not authorize the use of Federal facilities to facilitate or effectuate the sale, transfer, exchange or other disposal of Base Supply. Such use of Federal facilities will be the subject of a separate agreement to be entered into between the Contractor and Reclamation. For the purpose of determining whether Section 3405(a)(1)(M) of the (c) CVPIA applies to the Contractor as a transferor or transferee of Project Water, the Contracting

1 Officer acknowledges that the Contractor is within a county, watershed, or other area of origin, 2 as those terms are utilized under California law, of water that constitutes the natural flow of the 3 Sacramento River and its tributaries above the confluence of the American and Sacramento 4 Rivers. 5 (d) Nothing herein contained shall prevent the Contractor from diverting 6 water during the months of November through March for beneficial use on the land shown on 7 Exhibit B or elsewhere to the extent authorized under the laws of the State of California. 8 (e) The United States assumes no responsibility for and neither it nor its 9 officers, agents, or employees shall have any liability for or on account of: 10 (1) The quality of water to be diverted by the Contractor; 11 (2) The control, carriage, handling, use, disposal, or distribution of 12 water diverted by the Contractor outside the facilities constructed and then being operated and 13 maintained by or on behalf of the United States; 14 Claims of damage of any nature whatsoever, including but not (3) 15 limited to, property loss or damage, personal injury, or death arising out of or connected with the 16 control, carriage, handling, use, disposal, or distribution of said water outside of the hereinabove referred to facilities; and 17 18 (4) Any damage whether direct or indirect arising out of or in any 19 manner caused by a shortage of water whether such shortage be on account of errors in 20 operation, drought, or unavoidable causes. 21 **RETURN FLOW** 22 4. Nothing herein shall be construed as an abandonment or a relinquishment by the 23 United States of any right it may have to the use of waste, seepage, and return flow water derived

1 from water diverted by the Contractor hereunder and which escapes or is discharged beyond the 2 boundaries of the lands shown on Exhibit B; Provided, that this shall not be construed as 3 claiming for the United States any right to such water which is recovered by the Contractor 4 pursuant to California law from within the boundaries of the lands shown on Exhibit B, and 5 which is being used pursuant to this Settlement Contract for surface irrigation or underground 6 storage for the benefit of the lands shown on Exhibit B by the Contractor. 7 CONSTRAINTS ON THE AVAILABILITY OF WATER 5. 8 In a Critical Year, the Contractor shall have the option to: 9 (a) Irrigate not in excess of 75 percent of their irrigable acreage shown on 10 Exhibit A; or 11 (b) Divert from the Sacramento River not in excess of 75 percent of the 12 Contract Total shown on Exhibit A, subject to the installation of measurement equipment 13 satisfactory to the Contracting Officer. The Contractor shall install, operate, and maintain this 14 equipment at the Contractor's expense. The Contractor shall submit, by April 1 of that Critical 15 Year, a written schedule to the Contracting Officer indicating the Contract Total to be diverted 16 by the Contractor during each month of that Critical Year under this Settlement Contract. 17 (c) The amount of any overpayment by the Contractor shall, at its option, be 18 refunded or credited upon amounts to become due to the United States from the Contractor under 19 the provisions hereof in the ensuing Year. To the extent of such deficiency such adjustment of 20 overpayment shall constitute the sole remedy of the Contractor. 21 INTEGRATED WATER MANAGEMENT AND PARTNERSHIPS 22 6. The Contractor and United States desire to work together to maximize the 23 reasonable beneficial use of water for their mutual benefit. As a consequence, the United States

- and the Contractor will work in partnership and with others within the Sacramento Valley,
- 2 including other Contractors, to facilitate the better integration within the Sacramento Valley of
- 3 all water supplies including, but not limited to, the better management and integration of surface
- 4 water and groundwater, the development and better utilization of surface water storage, the
- 5 effective utilization of waste, seepage and return flow water, and other operational and
- 6 management options that may be identified in the future.

USE OF WATER FURNISHED TO CONTRACTOR

- 7. (a) Project Water furnished to the Contractor pursuant to this Settlement Contract shall not be delivered or furnished by the Contractor for any purposes other than
- agricultural purposes without the written consent of the Contracting Officer. For purposes of this
- 11 Settlement Contract, "agricultural purposes" includes, but is not restricted to, the irrigation of
- crops, the watering of livestock, incidental domestic use including related landscape irrigation, or
- 13 underground water replenishment.

- 14 (b) The Contractor shall comply with requirements applicable to the
- 15 Contractor in biological opinion(s) prepared as a result of a consultation regarding the execution
- of this Settlement Contract undertaken pursuant to Section 7 of the Endangered Species Act of
- 17 1973, as amended, that are within the Contractor's legal authority to implement. The Contractor
- shall comply with the limitations or requirements imposed by environmental documentation
- 19 applicable to the Contractor and within its legal authority to implement. The Existing Contract,
- which evidences in excess of 40 years of diversions, for agricultural uses, of the quantities of
- 21 water provided for in Article 3, and the underlying water rights of the Contractor will be
- considered in developing an appropriate base-line for the Biological Assessment prepared
- pursuant to the Endangered Species Act, and in any other needed environmental review.

- 1 Nothing herein shall be construed to prevent the Contractor from challenging or seeking judicial
- 2 relief in a court of competent jurisdiction with respect to any biological opinion or other
- 3 environmental documentation referred to in this Article.

RATE AND METHOD OF PAYMENT FOR WATER

- 8. (a) The Contractor shall make payments to the United States as provided in this Article for each acre of land irrigated in each Year.
- Such payments shall be at Rates and Charges established in accordance with: (i) the Secretary's then current ratesetting policies for the Project; and (ii) applicable Reclamation law and associated rules and regulations, or policies: Provided, that if the Contractor desires to use Project Water for other than agricultural use the Rates and Charges set forth above will be adjusted by the Contracting Officer to the applicable Rates and Charges for such use. The Rates and Charges applicable to the Contractor upon execution of this Settlement Contract are set forth in Exhibit D, as may be revised annually. The Secretary's ratesetting policies for the Project shall be amended, modified, or superseded only through a public notice and comment procedure.
- (b) The Contracting Officer shall notify the Contractor of the Rates and Charges as follows:
- (1) Prior to July 1 of each Year, the Contracting Officer shall provide the Contractor an estimate of the Charges for Project Water that will be applied to the period October 1, of the current Year, through September 30, of the following Year, and the basis for such estimate. The Contractor shall be allowed not less than 2 months to review and comment on such estimates. On or before September 15 of each Year, the Contracting Officer shall notify the Contractor in writing of the Charges to be in effect during the period October 1 of

2 Exhibit D. 3 (2) Prior to October 1 of each Year, the Contracting Officer shall make 4 available to the Contractor an estimate of the Rates for Project Water for the following Year and 5 the computations and cost allocations upon which those Rates are based. The Contractor shall be 6 allowed not less than 2 months to review and comment on such computations and cost 7 allocations. By December 31 of each Year, the Contracting Officer shall provide the Contractor 8 with the final Rates to be in effect for the upcoming Year, and such notification shall revise 9 Exhibit D. 10 The Contractor shall pay the United States for Project Water in the (c) 11 following manner: 12 (1) With respect to Rates and Charges, on or before May 1 of each 13 Year, the Contractor shall pay the United States one-half the total amount payable pursuant to 14 subdivision (a) of this Article and the remainder shall be paid on or before July 1 or such later 15 date or dates as may be specified by the United States in a written notice to the Contractor: 16 (2) The amount to be paid on or before May 1 of each Year shall be based on a written estimate, provided to the Contracting Officer by the Contractor on or before 17 18 April 1 of each Year, of the total area to be irrigated during the ensuing irrigation season. 19 (3) The amount to be paid on or before July 1 shall be equal to the 20 difference between the amount paid on May 1 and the total amount due for the Year, based on 21 the total area actually irrigated prior to July 1.

1	(4) If additional areas are placed under irrigation on or after July 1,
2	additional payment shall be made in advance of such additional irrigation at the Rates and
3	Charges shown in Exhibit D for each additional acre placed under irrigation.
4	(d) Payments to be made by the Contractor to the United States under this
5	Settlement Contract may be paid from any revenues available to the Contractor.
6	(1) All revenues received by the United States from the Contractor
7	relating to the delivery of Project Water or the delivery of non-Project Water through Project
8	facilities shall be allocated and applied in accordance with Federal Reclamation law and the
9	associated rules or regulations, and the then current Project ratesetting policies for irrigation
10	water.
11	(e) The Contracting Officer shall keep its accounts pertaining to the
12	administration of the financial terms and conditions of its long-term water service and Settlement
13	Contracts, in accordance with applicable Federal standards, so as to reflect the application of
14	Project costs and revenues. The Contracting Officer shall, each Year upon request of the
15	Contractor, provide to the Contractor a detailed accounting of all Project and Contractor expense
16	allocations, the disposition of all Project and Contractor revenues, and a summary of all water
17	delivery information. The Contracting Officer and the Contractor shall enter into good faith
18	negotiations to resolve any discrepancies or disputes relating to accountings, reports, or
19	information.
20	(f) The parties acknowledge and agree that the efficient administration of this
21	Settlement Contract is their mutual goal. Recognizing that experience has demonstrated that
22	mechanisms, policies, and procedures used for establishing Rates and Charges and/or for making
23	and allocating payments, other than those set forth in this Article may be in the mutual best

- 1 interest of the parties, it is expressly agreed that the parties may enter into agreements to modify
- 2 the mechanisms, policies, and procedures for any of those purposes while this Settlement
- 3 Contract is in effect without amendment of this Settlement Contract.
- 4 (g) For the term of this Settlement Contract, Rates under the respective
- 5 ratesetting policies for the Project will be established to recover only reimbursable operation and
- 6 maintenance (including any deficits) and capital costs of the Project, as those terms are used in
- 7 the then-current Project ratesetting policies, and interest, where appropriate, except in instances
- 8 where a minimum Rate is applicable in accordance with the relevant Project ratesetting policy.
- 9 Proposed changes of significance in practices which implement the ratesetting policies for the
- 10 Project will not be implemented until the Contracting Officer has provided the Contractor an
- opportunity to discuss the nature, need, and impact of the proposed change. The Contractor
- retains all rights to challenge the validity of Rates and Charges imposed pursuant to this
- 13 Settlement Contract, including but not limited to operation and maintenance expenses and
- operation and maintenance deficits, in an appropriate administrative or judicial proceeding.
- 15 (h) Except as provided in subsection 3405(a)(1)(B) of the CVPIA, the Rates
- 16 for Project Water transferred, exchanged, or otherwise disposed of, by the Contractor shall be the
- 17 Contractor's Rates adjusted upward or downward to reflect the changed costs of delivery (if any)
- of the transferred, exchanged, or otherwise disposed of Project Water to the transferee's point of
- delivery in accordance with the then-current ratesetting policies for the Project. Except as
- provided in subsection 3407(d)(2)(A) of the CVPIA, the Charges for Project Water transferred,
- 21 exchanged, or otherwise disposed of, by the Contractor shall be the Contractor's Charges
- specified in Exhibit D. If the Contractor is receiving lower Rates and Charges because of
- 23 inability to pay and is transferring, exchanging, or otherwise disposing of Project Water to

1 another entity whose Rates and Charges are not adjusted due to inability to pay, the Rates and 2 Charges for transferred, exchanged, or otherwise disposed of Project Water shall be the 3 Contractor's Rates and Charges unadjusted for ability to pay. 4 (i) Pursuant to the Act of October 27, 1986 (100 Stat. 3050), the Contracting 5 Officer is authorized to adjust determinations of ability to pay every 5 years. 6 (j) Each payment to be made pursuant to subdivisions (a) and (b) of this 7 Article shall be made at the office of the Bureau of Reclamation, Mid-Pacific Region, File 8 No. 11546, P.O. Box 6000, San Francisco, California 94160-1546, or at such other place as the 9 United States may designate in a written notice to the said Contractor. Payments shall be made 10 by cash transaction, wire, or any other mechanism as may be agreed to in writing by the 11 Contractor and the Contracting Officer. In event there should be a default in the payment of the 12 amount due, the delinquent payment provisions of Article 13 shall apply. The Contractor shall 13 not be relieved of the whole or any part of its said obligation by, on account of, or 14 notwithstanding, as the case may be its failure, refusal, or neglect to divert the quantity of Project 15 Water shown on Exhibit A. 16 AGREEMENT ON WATER QUANTITIES 9. 17 (a) During the term of this Settlement Contract and any renewals thereof: 18 (1) It shall constitute full agreement as between the United States and 19 the Contractor as to the quantities of water and the allocation thereof between Base Supply and 20 Project Water which may be diverted by the Contractor from the Sacramento River for beneficial 21 use on the land shown on Exhibit B which said diversion, use, and allocation shall not be 22

disturbed so long as the Contractor shall fulfill all of its obligations hereunder;

1 (2) Neither party shall claim any right against the other in conflict with 2 the provisions of Article 9(a)(1) hereof.

(b) Nothing herein contained is intended to or does limit rights of the Contractor against others than the United States or of the United States against any person other than the Contractor: Provided, however, that in the event the Contractor, the United States, or any other person shall become a party to a general adjudication of rights to the use of water of the Sacramento River system, this Settlement Contract shall not jeopardize the rights or position of either party hereto or of any other person and the rights of all such persons in respect to the use of such water shall be determined in such proceedings the same as if this Settlement Contract had not been entered into, and if final judgment in any such general adjudication shall determine that the rights of the parties hereto are different from the rights as assumed herein, the parties shall negotiate an amendment to give effect to such judgment. In the event the parties are unable to agree on an appropriate amendment they shall, within 60 days of determining that there is an impasse, employ the services of a neutral mediator, experienced in resolving water rights disputes, to assist in resolving the impasse. The cost of the mediation will be shared equally. A failure to reach agreement on an amendment within 60 days of the end of mediation will cause the immediate termination of this Settlement Contract.

(c) In the event that the California State Water Resources Control Board or a court of competent jurisdiction issues a final decision or order modifying the terms and conditions of the water rights of either party to this Settlement Contract in order to impose Bay-Delta water quality obligations, the Contractor and the United States shall promptly meet to determine whether or not to modify any of the terms of this Settlement Contract to comply with the final decision or order, including, but not limited to, the applicability of the rescheduling

charge in Article 3(c)(1) of this Settlement Contract. If within 60 days of the date of the issuance of the final decision or order the parties are not able to reach agreement regarding either the need to modify this Settlement Contract or the manner in which this Settlement Contract is to be modified, the parties shall promptly retain a neutral mediator, experienced in resolving water right disputes, to assist the parties in resolving their dispute. The cost of the mediator shall be shared equally. In the event that either of the parties to this Settlement Contract determines that the parties will not be able to develop mutually-agreeable modification(s) to this Settlement Contract even with the assistance of a mediator, either of the parties to this Settlement Contract may attempt to resolve the impasse by seeking appropriate judicial relief including, but not limited to, filing a general adjudication of the rights to the use of water in the Sacramento River system. The foregoing provisions of this sub-article shall only apply to the incremental obligations contained within a final decision or order of the State Water Resources Control Board that reflects a modification to the obligations imposed in State Water Resources Control Board Revised Water Rights Decision 1641 dated March 15, 2000, and its associated 1995 Water Quality Control Plan which, taken together, will be considered the baseline for the application of the provisions of this sub-article. (d) In the event this Settlement Contract terminates, the rights of the parties to thereafter divert and use water shall exist as if this Settlement Contract had not been entered into; and the fact that as a compromise settlement of a controversy as to the respective rights of the parties to divert and use water and the yield of such rights during the term hereof, this Settlement Contract places a limit on the Contract Total to be diverted annually by the Contractor during the Settlement Contract term and segregates it into Base Supply and Project Water shall not

In the event of an

The Contractor, in carrying out this Settlement Contract, shall comply with all 24 applicable water and air pollution laws and regulations of the United States and the State of California, and shall obtain all required permits or licenses from the appropriate Federal, State, 25 26 or local authorities. 27 **EQUAL OPPORTUNITY** 28 16. During the performance of this Settlement Contract, the Contractor agrees as 29 follows:

1 The Contractor will not discriminate against any employee or applicant for (a) 2 employment because of race, color, religion, sex, or national origin. The Contractor will take 3 affirmative action to ensure that applicants are employed, and that employees are treated during 4 employment, without regard to their race, color, religion, sex, or national origin. Such action 5 shall include, but not be limited to, the following: Employment, upgrading, demotion, or 6 transfer; recruitment or recruitment advertising; layoff or termination, rates of payment or other 7 forms of compensation; and selection for training, including apprenticeship. The Contractor 8 agrees to post in conspicuous places, available to employees and applicants for employment, 9 notices to be provided by the Contracting Officer setting forth the provisions of this 10 nondiscrimination clause.

(b) The Contractor will, in all solicitations or advertisements for employees placed by or on behalf of the Contractor, state that all qualified applicants will receive consideration for employment without discrimination because of race, color, religion, sex, or national origin.

If the actual costs exceed the Contractor's advances, the Contractor will be billed for the additional costs pursuant to Article 31 of this Settlement Contract. WAIVER OF DEFAULT 32. The waiver by either party to this Settlement Contract as to any default shall not be construed as a waiver of any other default or as authority of the other party to continue such default or to make, do, or perform, or not to make, do, or perform, as the case may be, any act or thing which would constitute a default. CONTRACT ASSIGNMENT OR TERMINATION UPON TRANSFER OF LAND 33. The rights and obligations of the Contractors may be transferred in (a) connection with the transfer of title to the land or any portion thereof delineated on Exhibit B on the following terms and conditions: (1) A voluntary inter vivos transfer may be made, upon mutual agreement of the United States and the Contractors, to a person eligible to hold title to the land as a nonexcess landowner; and (2) In the event the title of the Contractors to such land, or any portion thereof, is transferred by operation of law, such as by conveyance in satisfaction of a mortgage, by inheritance, or by device, the rights and obligations of the Contractors shall pass with the title and the land shall be subject to provisions of Reclamation law pertaining to such transfers.
