24	WHEREAS, the United States, DWR, and the Contractor entered into interim	
25	renewal Contract (long-form interim renewal contract) No. 14-06-200-8238A-IR1 which	

26	provided for the continued water service to the Contractor following expiration of Contract		
27	No. 14-06-200-8238A; and		
28	WHEREAS, the last long-form interim renewal contract between the United		
29	States, DWR, and the Contractor is Contract No. 14-06-200-8238A-IR5, hereinafter referred		
30	to as IR5; and		
31	WHEREAS, the United States, DWR, and the Contractor have entered into		
32	successive renewals of IR5, the most recent of which is Contract No. 14-06-200-8238A-IR14,		
33	hereinafter referred to as the IR14, effective March 1, 2012, through February 28, 2014; and		
34	WHEREAS, the United States, DWR, and the Contractor have made significant		
35	progress in their negotiations of a long-term renewal contract, believe that further negotiations on		
36	the long-term renewal contract would be beneficial, and mutually commit to continue to		
37	negotiate to seek to reach agreement, but anticipate that the environmental documentation		
38	necessary for execution of any long-term renewal contract may be delayed for reasons beyond		
39	the control of the parties; and		
40	WHEREAS, the Contractor has requested a subsequent interim renewal contract		
41	pursuant to IR14; and		
42	WHEREAS, the United States has determined that the Contractor has to date		
43	fulfilled all of its obligations under IR14; and		
44	WHEREAS, the United States and DWR are willing to renew IR14 pursuant to		
45	the terms and conditions set forth below;		
46	NOW, THEREFORE, in consideration of the mutual and dependent covenants		
47	herein contained, it is hereby mutually agreed by the parties hereto as follows:		

48 49	RENEWAL AND REVISION OF CONTRACT NO. 14-06-200-8238A-IR14		
50	1. Except as specifically modified by this Contract, all provisions of IR14 are		
51	renewed with the same force and effect as if they were included in full text with the exception of		
52	Article 1 of IR14 thereof, which is revised as follows:		
53	(a) The first sentence in subdivision (a) of Article 1 of IR14 is replaced with		
54	the following language: "This Contract shall be effective from March 1, 2014, and shall remain		
55	in effect through February 29, 2016, and thereafter will be renewed as described in Article 2 of		
56	IR5 if a long-term renewal contract has not been executed with an effective commencement date		
57	of March 1, 2016."		
58	(b) Subdivision (b) of Article 1 of IR14 is amended by deleting the date		
59	"February 15, 2014," and replacing same with the date "February 15, 2016."		
60	(c) Subdivision (c) of Article 1 of IR14 is amended by deleting the dates		
61	"February 1, 2014", "February 15, 2014", and "February 28, 2014", respectively, and		
62	replacing same with the dates "February 1, 2016", "February 15, 2016", and		
63	"February 29, 2016", respectively.
