23	EXPLANATORY RECITALS		
24	WHEREAS, the United States, DWR, and the Contractor entered into interim		
25	renewal Contract (long-form interim renewal contract) No. 14-06-200-8601A-IR1 which		

provided for the continued water service to the Contractor following expiration of Contract

No. 14-06-200-8601A; and		
WHEREAS, the last long-form interim renewal contract between the United		
States, DWR, and the Contractor is Contract No. 14-06-200-8601A-IR5, hereinafter referred		
to as IR5; and		
WHEREAS, the United States, DWR, and the Contractor have entered into		
successive renewals of IR5, the most recent of which is Contract No. 14-06-200-8601A-IR15,		
hereinafter referred to as IR15, effective March 1, 2014, through February 29, 2016; and		
WHEREAS, the United States, DWR, and the Contractor have made significant		
progress in their negotiations of a long-term renewal contract, believe that further negotiations on		
the long-term renewal contract would be beneficial, and mutually commit to continue to		
negotiate to seek to reach agreement, but anticipate that the environmental documentation		
necessary for execution of any long-term renewal contract may be delayed for reasons beyond		
the control of the parties; and		
WHEREAS, the Contractor has requested a subsequent interim renewal contract		
pursuant to IR15; and		
WHEREAS, the United States has determined that the Contractor has to date		
fulfilled all of its obligations under IR15; and		
WHEREAS, the United States and DWR are willing to renew IR15 pursuant to		
the terms and conditions set forth below;		
NOW, THEREFORE, in consideration of the mutual and dependent covenants		
herein contained, it is hereby mutually agreed by the parties hereto as follows:

50	1. Except as specifically modified by this Contract, all provisions of IR15 are		
51	renewed with the same force and effect as if they were included in full text with the exception of		
52	Article 1 of IR15 thereof, which is revised as follows:		
53	(a) The first sentence in subdivision (a) of Article 1 of IR15 is replaced with		
54	the following language: "This Contract shall be effective from March 1, 2016, and shall remain		
55	in effect through February 28, 2018, and thereafter will be renewed as described in Article 2 of		
56	IR5 if a long-term renewal contract has not been executed with an effective commencement date		
57	of March 1, 2018."		
58	(b) Subdivision (b) of Article 1 of IR15 is amended by deleting the date		
59	"February 15, 2016," and replacing same with the date "February 15, 2018."		
60	(c) Subdivision (c) of Article 1 of IR15 is amended by deleting the dates		
61	"February 1, 2016", "February 15, 2016", and "February 29, 2016", respectively, and		
62	replacing same with the dates "February 1, 2018", "February 15, 2018", and		
63	"February 28, 2018", respectively.
