22	contract identified as Contract No. 14.06.200.77724 ID1 hereinafter referred to as ID1 which
23	contract identified as Contract No. 14-06-200-7773A-IR1, hereinafter referred to as IR1, which
24	provided for the continued water corrige to the Contractor offective from January 1, 2000
24	provided for the continued water service to the Contractor effective from January 1, 2009,
25	through Eshmum 29, 2011, and
25	through February 28, 2011; and

26	WHEREAS, the United States and the Contractor have entered into successive
27	renewals of IR1, the most recent of which is Contract No. 14-06-200-7773A-IR4, hereinafter
28	referred to as IR4, effective from March 1, 2015, through February 28, 2017; and
29	WHEREAS, the United States and the Contractor have made significant progress
30	in their negotiations of a long-term renewal contract, believe that further negotiations on the
31	long-term renewal contract would be beneficial, and mutually commit to continue to negotiate to
32	seek to reach agreement, but anticipate that the environmental documentation necessary for
33	execution of any long-term renewal contract may be delayed for reasons beyond the control of
34	the parties; and
35	WHEREAS, the Contractor has requested a subsequent interim renewal contract
36	pursuant to Article 2 of IR1; and
37	WHEREAS, the United States has determined that the Contractor has to date
38	fulfilled all of its obligations under IR4; and
39	WHEREAS, the United States is willing to renew IR4 pursuant to the terms and
40	conditions set forth below;
41	NOW, THEREFORE, in consideration of the mutual and dependent covenants
42	herein contained, it is hereby mutually agreed by the parties hereto as follows:

43 44	<u>RENEWAL AND REVISION OF</u> CONTRACT NO. 14-06-200-7773A-IR4
45	1. Except as specifically modified by this Contract, all provisions of IR4 are
46	renewed with the same force and effect as if they were included in full text with the exception of
47	Article 1 of IR4 thereof, which is revised as follows:
48	(a) The first sentence in subdivision (a) of Article 1 of IR4 is modified as
49	follows: "This Contract shall be effective from March 1, 2017, and shall remain in effect

50	through February 28, 2019, and thereafter will be renewed as described in Article 2 of IR1 if a
51	long-term renewal contract has not been executed with an effective commencement date of
52	March 1, 2019."
53	(b) Subdivision (b) of Article 1 of IR4 is amended by deleting the date
54	"February 28, 2017," and replacing same with the date "February 28, 2019."
