18	THIS CONTRACT, hereinafter referred to as "Settlement Contract," is
19	entered into by THE UNITED STATES OF AMERICA, hereinafter referred to as the
20	United States, made this day of, 2004, pursuant to the
21	applicable authority granted to it generally in the Act of June 17, 1902 (32 Stat. 388), and
22	acts amendatory or supplementary thereto, including, but not limited to, the Acts of
23	August 26, 1937 (50 Stat. 844), as amended and supplemented, August 4, 1939 (53 Stat.
24	1187), as amended and supplemented, including, but not limited to, Sections 9 and 14
25	thereto, July 2, 1956 (70 Stat. 483), June 21, 1963 (77 Stat. 68), October 12, 1982 (96
26	Stat. 1262), October 27, 1986 (100 Stat. 3050), as amended, and Title XXXIV of the Act
27	of October 30, 1992 (106 Stat. 4706), all collectively hereinafter referred to as Federal
28	Reclamation law, and M. & T. INCORPORATED, hereinafter referred to as the
29	Contractor, a corporation acting pursuant to Sections 12003 and 12004 of the California
30	Water Code, with its principal place of business in California;
31	WITNESSETH, that:

1	EXPLANATORY RECITALS
2	[1 <sup>st]</sup> WHEREAS, the United States has constructed and is operating the Centr
3	Valley Project, California, for multiple purposes pursuant to its statutory authority; and
4	[2 <sup>nd]</sup> WHEREAS, the Contractor has rights to divert, is diverting, and will
5	continue to divert for reasonable beneficial use, water from the natural flow of the
6	Sacramento River and tributaries thereto, that would have been flowing therein if the
7	Central Valley Project were not in existence; and
8	[3 <sup>rd]</sup> WHEREAS, the construction and operation of the integrated and
9	coordinated Central Valley Project has changed and will further change the regimen of
10	the Sacramento, American, San Joaquin, and Trinity Rivers and the Sacramento-San
11	Joaquin Delta from unregulated flow to regulated flow; and
12	[4 <sup>th]</sup> WHEREAS, the United States has rights to divert, is diverting, and will
13	continue to divert waters from said Rivers and said Delta in connection with the operation
14	of said Central Valley Project, and
15	[5 <sup>th</sup> ] WHEREAS, the Contractor and the United States had a dispute over the
16	respective rights of the parties to divert and use water from the regulated flow of the
17	Sacramento River which threatened to result in litigation, and as a means to settle that
18	dispute entered into Contract No. 14-06-200-940A, as revised, hereinafter referred to as
19	the Existing Contract, which established terms for the delivery to the Contractor of
20	Central Valley Project Water, and the quantities of Base Supply the United States and the
21	Contractor agreed may be diverted by the Contractor from the Sacramento River pursua
22	to such contract; and

1	[6 <sup>th]</sup> WHEREAS, the United States and the Contractor disagree with respect to
2	the authority of the United States to change the quantities of Base Supply and/or Project
3	Water specified as available for diversion in this Settlement Contract from the quantities
4	specified in the Existing Contract, and other issues related thereto. That dispute was the
5	subject of litigation in a lawsuit entitled Glenn-Colusa Irrigation District, et al. v. United
6	States, et al. [Civ. No. S-01-1816 GEB/JFM (E.D. Cal.)], but that litigation was
7	dismissed, without prejudice, pursuant to a stipulation of dismissal filed by the parties
8	thereto on August 29, 2002. Notwithstanding that dismissal, the Contractor and the
9	United States enter into this Settlement Contract to renew the Existing Contract, pursuant
10	to the terms of the Existing Contract, Federal Reclamation law, and the laws of the State
11	of California; and
12	[7 <sup>th]</sup> WHEREAS, to assure the Contractor of the enjoyment and use of the
13	regulated flow of the said Rivers and the Delta, and to provide for the economical
14	operation of the Central Valley Project by, and the reimbursement to, the United States
15	for expenditures made for said Project.
16	NOW, THEREFORE, in consideration of the performance of the herein
17	contained provisions, conditions, and covenants, it is agreed as follows:
18	<u>DEFINITIONS</u>
19	1. When used herein, unless otherwise expressed or incompatible with the
20	intent hereof, the term:
21	(a) "Base Supply" shall mean the quantity of Surface Water
22	established in Articles 3 and 5 which may be diverted by the Contractor from the

1 Sacramento River each month during the period April through October of each Year 2 without payment to the United States for such quantities diverted; 3 (b) "Basin-Wide Water Management Plan" shall mean the mutually 4 agreeable Sacramento River Basinwide Water Management Plan, dated \_\_\_\_\_\_, 5 developed by Glenn-Colusa Irrigation District, Maxwell Irrigation District, Natomas 6 Central Mutual Water Company, Pelger Mutual Water Company, Princeton-Codora-7 Glenn Irrigation District, Provident Irrigation District, Reclamation District 108, Sutter 8 Mutual Water Company, Anderson-Cottonwood Irrigation District, M&T, Inc., Meridian 9 Farms Water Company, Reclamation District 1004 and the U.S. Bureau of Reclamation. 10 (c) "Charges" shall mean the payments for Project Water that the 11 Contractor is required to pay to the United States in addition to the "Rates" specified in 12 this Settlement Contract. The Contracting Officer will, on an annual basis, determine the 13 extent of these Charges. The type and amount of each Charge shall be specified in 14 Exhibit D; 15 (d) "Contract Total" shall mean the sum of the Base Supply and 16 Project Water available for diversion by the Contractor for the period April 1 through 17 October 31; 18 "Critical Year" shall mean any Year in which either of the (e) 19 following eventualities exists: 20 (1) The forecasted full natural inflow to Shasta Lake for the 21 current Water Year, as such forecast is made by the United States on or before February 22 15 and reviewed as frequently thereafter as conditions and information warrant, is equal

23

to or less than 3.2 million acre-feet; or

1	(2) The total accumulated actual deficiencies below 4 million
2	acre-feet in the immediately prior Water Year or series of successive prior Water Years
3	each of which had inflows of less than 4 million acre-feet, together with the forecasted

deficiency for the current Water Year, exceed 800,000 acre-feet.

For the purpose of determining a Critical Year, the computation of inflow to Shasta Lake shall be performed in a manner that considers the extent of upstream development above Shasta Lake during the year in question, and shall be used as the full natural flow to Shasta Lake. In the event that major construction has occurred or occurs above Shasta Lake after September 1, 1963 and which has materially altered or alters the regimen of the stream systems contributing to Shasta Lake, the computed inflow to Shasta Lake used to define a Critical Year will be adjusted to eliminate the effect of such material alterations. After consultation with the State of California, the National Weather Service, and other recognized forecasting agencies, the Contracting Officer will select the forecast to be used and will make the details of it available to the Contractor. The same forecasts used by the United States for the operation of the Project shall be used to make the forecasts hereunder;

- 17 (f) "CVPIA" shall mean the Central Valley Project Improvement Act, 18 Title XXXIV of the Act of October 30, 1992 (106 Stat. 4706);
- 19 (g) "Eligible Lands" shall mean all lands to which Project Water may 20 be delivered in accordance with Section 204 of the Reclamation Reform Act of October 21 12, 1982 (96 Stat. 1263), as amended, hereinafter referred to as RRA;

1	(h) "Excess Lands" shall mean all lands in excess of the limitations
2	contained in Section 204 of the RRA, other than those lands exempt from acreage
3	limitation under Federal Reclamation law;
4	(i) "Full Cost Rate" shall mean that water rate described in Sections
5	205(a)(3) or 202(3) of the RRA, whichever is applicable;
6	(j) "Ineligible Lands" shall mean all lands to which Project Water
7	may not be delivered in accordance with Section 204 of the RRA;
8	(k) "Landholder" shall mean a party that directly or indirectly owns or
9	leases nonexempt land, as provided in 43 CFR 426.2;
10	(l) "Project" shall mean the Central Valley Project owned by the
11	United States and managed by the Department of the Interior, Bureau of Reclamation;
12	(m) "Project Water" shall mean all Surface Water diverted or
13	scheduled to be diverted each month during the period April through October of each
14	Year by the Contractor from the Sacramento River which is in excess of the Base Supply
15	The United States recognizes the right of the Contractor to make arrangements for
16	acquisition of water from projects of others than the United States for delivery through
17	the Sacramento River and tributaries subject to written agreement between Contractor
18	and the United States as to identification of such water which water when so identified
19	shall not be deemed Project Water under this Settlement Contract;
20	(n) "Rates" shall mean the payments for Project Water determined
21	annually by the Contracting Officer in accordance with the then current applicable water
22	ratesetting policies for the Project, as described in subdivision (a) of Article 8 of this
23	Settlement Contract:

1	(0)	"Secretary" or "Contracting Officer" shall mean the Secretary of
2	the Interior, a duly a	ppointed successor, or an authorized representative acting pursuant to
3	any authority of the S	Secretary and through any agency of the Department of the Interior;
4	(p)	"Surface Water" shall mean only those waters that are considered
5	as surface water unde	er California law;
6	(q)	"Water Year" shall mean the period commencing with October 1
7	of one year and exter	nding through September 30 of the next; and
8	(r)	"Year" shall mean a calendar year.
9		TERM OF SETTLEMENT CONTRACT
10	2. (a)	This Settlement Contract shall become effective April 1, 2004, and
11	shall remain in effect	t until and including March 31, 2044: <u>Provided</u> , that under terms and
12	conditions mutually	agreeable to the parties hereto, renewals may be made for successive
13	periods not to exceed	d 40 years each. The terms and conditions of each renewal shall be
14	agreed upon not later	than one year prior to the expiration of the then existing Settlement
15	Contract.	
16	(b)	With respect to Project Water and the portions of this Settlement
17	Contract pertaining t	hereto, upon written request by the Contractor of the Secretary made
18	not later than one year	ar prior to the expiration of this Settlement Contract, whenever,
19	account being taken	of the amount then credited to the costs of construction of water
20	supply works, the rea	maining amount of construction costs of water supply work which is
21	properly assignable f	For ultimate return by the Contractor as established by the Secretary
22	of the Interior pursua	ant to (3) of Section 1 of Public Law 643 (70 Stat. 483), probably can
23	be repaid to the Unit	ed States within the term of a contract under subsection 9(d) of the

- 1 1939 Reclamation Project Act (53 Stat. 1187), the relevant portions of this Settlement
- 2 Contract may be converted to a contract under said subsection 9(d) upon terms and
- 3 conditions mutually agreeable to the United States and the Contractor. The Secretary
- 4 shall make a determination 10 years after the date of execution of this Settlement
- 5 Contract, and every five years thereafter, of whether a conversion to a contract under said
- 6 subsection 9(d) can be accomplished pursuant to Public Law 643. Notwithstanding any
- 7 provision of this Settlement Contract, the Contractor reserves and shall have all rights and
- 8 benefits under Public Law 643.

### WATER TO BE FURNISHED TO CONTRACTOR

- 3. (a) Subject to the conditions, limitations, and provisions hereinafter expressed, the Contractor is hereby entitled and authorized to divert from the Sacramento
- River at the locations shown in Exhibit A, for beneficial use within the area delineated on
- 13 Exhibit B, (both Exhibits are attached hereto and made a part hereof), the Contract Total
- designated in Exhibit A, or any revision thereof, in accordance with the monthly
- operating schedule required by Article 3(c) of this Settlement Contract, <u>Provided</u>,
- 16 <u>however</u>, that the Contractor reserves the right to, and may at its option, divert water from
- Butte Creek to the extent permitted under Permits Nos. 4743, 4744, 5847, 5848; Licenses
- Nos. 2614, 2615, 2616, 2617; and the Decree rendered on May 25, 1920, by the Superior
- Court of Sutter County in the matter of <u>Central California Investment Company</u> v. <u>John</u>
- 20 <u>Crouch Land Company, et al.</u>, Action No. 1355, for beneficial use within the area
- 21 delineated on Exhibit B. The lawfulness of the Contractor's points of diversion for said
- area from Butte Creek will not be challenged by, or on behalf of, the Bureau of
- Reclamation except in the case of a general adjudication as provided in subdivisions (b)

1 and (c) of Article 9. The quantity of any water diverted under this Settlement Contract

2 from the Sacramento River, during the period April through October, for use on any lands

delineated on Exhibit B, by the owner of such lands or otherwise shall constitute a part of

the Contract Total as shown on Exhibit A and shall be subject to all the provisions of this

Settlement Contract relating to such Contract Total as if such diversion were made by the

Contractor.

- (b) The Contractor may have acquired rights to divert water from the Sacramento River during the period April through October, that were obtained after the date of execution of the Existing Contract, or the Contractor may acquire such rights in the future. All diversions made from the Sacramento River, pursuant to such rights, during the period April through October, shall not be considered a part of the quantity of Base Supply and Project Water specified in Exhibit A; Provided, that the quantities diverted pursuant to the above rights shall be identified on the schedule submitted pursuant to Article 3(c) below, and shall not be substituted for any Base Supply or Project Water; Provided, further, that any such identified quantities of other acquired rights may be diverted by the Contractor before incurring any fee pursuant to Article 3(c)(1), below.
- when a revision is needed, the Contractor shall submit a written schedule to the Contracting Officer indicating the Contract Total to be diverted by the Contractor during each month under this Settlement Contract. The United States shall furnish water to the Contractor in accordance with the monthly operating schedule or any revisions thereof.

However, the United States recognizes the need of the Contractor to change from time to

1	time its monthly diversions of water from the quantities shown in Exhibit A; the
2	Contractor may make such changes, provided:
3	(1) that for the quantity of Base Supply diverted in excess of
4	the monthly quantity shown in Exhibit A, and as may be reduced in accordance with
5	Article 5(a), during June, July, August, September, or October of any Water Year, the
6	Contractor shall be charged a rescheduling fee equal to 50% of the sum of the storage
7	operations and maintenance rate and the storage capital rate components of the Project
8	ratesetting policy.
9	(2) that in no event shall the total quantity scheduled for
10	diversion by the Contractor from the Sacramento River:
11	(i) During the period April through October exceed the
12	aggregate of the Contract Total for that period shown in Exhibit A or any revision
13	thereof;
14	(ii) During the period July through September exceed
15	the aggregate of the Contract Total for that period shown in Exhibit A or any revision
16	thereof.
17	(d) In the event conditions warrant, the Contracting Officer reserves
18	the right to require the Contractor to submit, at least 72 hours prior to the beginning of
19	each weekly period, its estimate of daily diversion requirements for each such period
20	from the Sacramento River: Provided, however, that changes during any such period
21	may be made upon the giving of 72 hours' notice thereof to the Contracting Officer.
22	(e) No sale, transfer, exchange, or other disposal of any of the
23	Contract Total designated in Exhibit A or the right to the use thereof for use on land other

- 1 than that shown on Exhibit B shall be made by the Contractor without first obtaining the
- 2 written consent of the Contracting Officer. Such consent will not be unreasonably
- 3 withheld and a decision will be rendered in a timely manner. For short-term actions that
- 4 will occur within one year or less, the decision will be rendered within 30 days after
- 5 receipt of a complete written proposal. For long-term actions that will occur in a period
- 6 longer than one year, the decision will be rendered within 90 days after receipt of a
- 7 complete written proposal. For a proposal to be deemed complete by the Contracting
- 8 Officer, it must comply with all provisions required by State and Federal law, including
- 9 information sufficient to enable the Contracting Officer to comply with the National
- 10 Environmental Policy Act, the Endangered Species Act, and applicable rules or
- regulations then in effect; <u>Provided</u> that, such consent does not authorize the use of
- 12 Federal facilities to facilitate or effectuate the sale, transfer, exchange or other disposal of
- 13 Base Supply. Such use of Federal facilities will be the subject of a separate agreement to
- be entered into between the Contractor and Reclamation.
- 15 (f) For the purpose of determining whether section 3405(a)(1)(M) of
- the CVPIA applies to the Contractor as a transferor or transferee of Project Water, the
- 17 Contracting Officer acknowledges that the Contractor is within a county, watershed or
- other area of origin, as those terms are utilized under California law.
- 19 (g) Nothing herein contained shall prevent the Contractor from
- 20 diverting water during the months of November through March for beneficial use on the
- 21 land shown on Exhibit B or elsewhere to the extent authorized under the laws of the State
- 22 of California.

- 1 (h) The United States assumes no responsibility for and neither it nor 2 its officers, agents, or employees shall have any liability for or on account of:
  - (1) The quality of water to be diverted by the Contractor;
- 4 (2) The control, carriage, handling, use, disposal, or
- 5 distribution of water diverted by the Contractor outside the facilities constructed and then
- 6 being operated and maintained by or on behalf of the United States;
- 7 Claims of damage of any nature whatsoever, including but
- 8 not limited to, property loss or damage, personal injury, or death arising out of or
- 9 connected with the control, carriage, handling, use, disposal, or distribution of said water
- 10 outside of the hereinabove referred to facilities; and
- 11 (4) Any damage whether direct or indirect arising out of or in
- any manner caused by a shortage of water whether such shortage be on account of errors
- in operation, drought, or unavoidable causes.

### 14 <u>RETURN FLOW</u>

- 15 4. Nothing herein shall be construed as an abandonment or a relinquishment
- by the United States of any right it may have to the use of waste, seepage, and return flow
- water derived from water diverted by the Contractor hereunder and which escapes or is
- discharged beyond the boundaries of the lands shown on Exhibit B; <u>Provided</u>, that this
- shall not be construed as claiming for the United States any right to such water which is
- 20 recovered by the Contractor pursuant to California law from within the boundaries of the
- 21 lands shown on Exhibit B, and which is being used pursuant to this Settlement Contract
- for surface irrigation or underground storage for the benefit of the lands shown on Exhibit
- B by the Contractor.

### CONSTRAINTS ON THE AVAILABILITY OF WATER

- 2 5. (a) In a Critical Year, the Contractor's Base Supply and Project Water
- 3 agreed to be diverted during the period April through October of the Year in which the
- 4 principal portion of the Critical Year occurs and, each monthly quantity of said period
- 5 shall be reduced by twenty-five percent.
- 6 (b) The amount of any overpayment by the Contractor shall, at its
- 7 option, be refunded or credited upon amounts to become due to the United States from
- 8 the Contractor under the provisions hereof in the ensuing Year. To the extent of such
- 9 deficiency such adjustment of overpayment shall constitute the sole remedy of the
- 10 Contractor.

### INTEGRATED WATER MANAGEMENT AND PARTNERSHIPS

- 12 6. The Contractor and United States desire to work together to maximize the
- reasonable beneficial use of water for their mutual benefit. As a consequence, the United
- 14 States and the Contractor will work in partnership and with others within the Sacramento
- 15 Valley, including other Contractors, to facilitate the better integration within the
- 16 Sacramento Valley of all water supplies including, but not limited to, the better
- 17 management and integration of surface water and groundwater, the development and
- better utilization of surface water storage, the effective utilization of waste, seepage and
- 19 return flow water, and other operational and management options that may be identified
- in the future.

21

### USE OF WATER FURNISHED TO CONTRACTOR

- 22 7. (a) Project Water furnished to the Contractor pursuant to this
- 23 Settlement Contract shall not be delivered or furnished by the Contractor for any

- 1 purposes other than agricultural purposes without the written consent of the Contracting
- 2 Officer. For purposes of this Settlement Contract, "agricultural purposes" includes, but is
- 3 not restricted to, the watering of livestock, incidental domestic use including related
- 4 landscape irrigation, or underground water replenishment.
- 5 (b) The Contractor shall comply with requirements applicable to the
- 6 Contractor in biological opinion(s) prepared as a result of a consultation regarding the
- 7 execution of this Settlement Contract undertaken pursuant to Section 7 of the Endangered
- 8 Species Act of 1973, as amended, that are within the Contractor's legal authority to
- 9 implement. The Contractor shall comply with the limitations or requirements imposed by
- 10 environmental documentation applicable to the Contractor and within its legal authority
- to implement. The Existing Contract, which evidences in excess of 40 years of
- diversions, for agricultural uses, of the quantities of water provided for in Article 3, and
- the underlying water rights of the Contractor will be considered in developing an
- 14 appropriate base-line for the Biological Assessment prepared pursuant to the Endangered
- 15 Species Act, and in any other needed environmental review. Nothing herein shall be
- 16 construed to prevent the Contractor from challenging or seeking judicial relief in a court
- of competent jurisdiction with respect to any biological opinion or other environmental
- documentation referred to in this Article.

### RATE AND METHOD OF PAYMENT FOR WATER

- 20 8. (a) The Contractor shall make payments to the United States as
- 21 provided in this Article for all Project Water shown in Exhibit A as follows:
- 22 (1) seventy-five percent of the amount shown as Project Water
- shall be paid for by the Contractor in each Year; and in addition

1	(2) the Contractor shall pay for Project Water actually diverted
2	in excess of seventy-five percent of the amount shown as Project Water.
3	Such payments shall be at Rates and Charges established in accordance with:
4	(i) the Secretary's then-current ratesetting policies for the Project; and (ii) applicable
5	Reclamation law and associated rules and regulations, or policies: <u>Provided</u> , that if the
6	Contractor desires to use Project Water for other than agricultural use the Rates and
7	Charges set forth above will be adjusted by the Contracting Officer to the applicable
8	Rates and Charges for such use. The Rates and Charges applicable to the Contractor
9	upon execution of this Settlement Contract are set forth in Exhibit D, as may be revised
10	annually. The Secretary's ratesetting policies for the Project shall be amended, modified,
11	or superseded only through a public notice and comment procedure. The Contracting
12	Officer shall adjust the amount of Project Water for which payment is required to the
13	extent of any reduction in diversions of Project Water made in accordance with the water
14	conservation provisions of Article 29 (e).
15	(b) The Contracting Officer shall notify the Contractor of the Rates
16	and Charges as follows:
17	(1) Prior to July 1 of each Year, the Contracting Officer shall

- 12 (1) With respect to Rates, prior to May 1 of each Year, the
- 13 Contractor shall pay the United States one-half the total amount payable pursuant to
- subdivision (a) of this Article and the remainder shall be paid prior to July 1 or such later
- date or dates as may be specified by the United States in a written notice to the
- 16 Contractor: <u>Provided</u>, <u>however</u>, that if at any time during the Year the amount of Project
- Water diverted by the Contractor shall equal the amount for which payment has been
- made, the Contractor shall pay for the remaining amount of such water as shown in
- 19 Exhibit A in advance of any further diversion of Project Water.
- 20 With respect to Charges, the Contractor shall also make a
- 21 payment to the United States, in addition to the Rate(s) in subdivision (c)(1) of this
- Article, at the Charges then in effect, before the end of the month following the month of
- 23 delivery or transfer. The payments shall be consistent with the quantities of Project

- 1 Water delivered or transferred. Adjustment for overpayment or underpayment of
- 2 Charges shall be made through the adjustment of payments due to the United States for
- 3 Charges for the next month. Any amount to be paid for past due payment of Charges
- 4 shall be computed pursuant to Article 13 of this Settlement Contract.
- 5 (d) Payments to be made by the Contractor to the United States under
- 6 this Settlement Contract may be paid from any revenues available to the Contractor.
- 7 (1) All revenues received by the United States from the
- 8 Contractor relating to the delivery of Project Water or the delivery of non-Project water
- 9 through Project facilities shall be allocated and applied in accordance with Federal
- 10 Reclamation law and the associated rules or regulations, and the then current Project
- 11 ratesetting policies for Irrigation Water.
- 12 (e) The Contracting Officer shall keep its accounts pertaining to the
- administration of the financial terms and conditions of its long-term water service and
- 14 Settlement Contracts, in accordance with applicable Federal standards, so as to reflect the
- application of Project costs and revenues. The Contracting Officer shall, each Year upon
- request of the Contractor, provide to the Contractor a detailed accounting of all Project
- and Contractor expense allocations, the disposition of all Project and Contractor
- 18 revenues, and a summary of all water delivery information. The Contracting Officer and
- 19 the Contractor shall enter into good faith negotiations to resolve any discrepancies or
- 20 disputes relating to accountings, reports, or information.
- 21 (f) The parties acknowledge and agree that the efficient administration
- of this Settlement Contract is their mutual goal. Recognizing that experience has
- demonstrated that mechanisms, policies, and procedures used for establishing Rates and

- 1 Charges and/or for making and allocating payments, other than those set forth in this
- 2 Article may be in the mutual best interest of the parties, it is expressly agreed that the
- 3 parties may enter into agreements to modify the mechanisms, policies, and procedures for
- 4 any of those purposes while this Settlement Contract is in effect without amendment of
- 5 this Settlement Contract.
- 6 (g) For the term of this Settlement Contract, Rates under the respective
- 7 ratesetting policies for the Project will be established to recover only reimbursable
- 8 operation and maintenance (including any deficits) and capital costs of the Project, as
- 9 those terms are used in the then current Project ratesetting policies, and interest, where
- appropriate, except in instances where a minimum Rate is applicable in accordance with
- the relevant Project ratesetting policy. Proposed changes of significance in practices
- which implement the ratesetting policies for the Project will not be implemented until the
- 13 Contracting Officer has provided the Contractor an opportunity to discuss the nature,
- 14 need, and impact of the proposed change. The Contractor retains all rights to challenge
- the validity of Rates and Charges imposed pursuant to this Settlement Contract, including
- but not limited to operation and maintenance expenses and operation and maintenance
- deficits, in an appropriate administrative or judicial proceeding.
- 18 (h) Except as provided in subsection 3405(a)(1)(B) of the CVPIA, the
- 19 Rates for Project Water transferred, exchanged, or otherwise disposed of, by the
- 20 Contractor shall be the Contractor's Rates adjusted upward or downward to reflect the
- 21 changed costs of delivery (if any) of the transferred, exchanged, or otherwise disposed of
- 22 Project Water to the transferee's point of delivery in accordance with the then-current
- ratesetting policies for the Project. Except as provided in subsection 3407(d)(2)(A) of the

- 1 CVPIA, the Charges for Project Water transferred, exchanged, or otherwise disposed of,
- 2 by the Contractor shall be the Contractor's Charges specified in Exhibit D. If the
- 3 Contractor is receiving lower Rates and Charges because of inability to pay and is
- 4 transferring, exchanging, or otherwise disposing of Project Water to another entity whose
- 5 Rates and Charges are not adjusted due to inability to pay, the Rates and Charges for
- 6 transferred, exchanged, or otherwise disposed of Project Water shall be the Contractor's
- 7 Rates and Charges unadjusted for ability to pay.
- 8 (i) Pursuant to the Act of October 27, 1986 (100 Stat. 3050), the
- 9 Contracting Officer is authorized to adjust determinations of ability to pay every five

- 11 (j) Each payment to be made pursuant to subdivisions (a) and (b) of

12	Base Supply and Project Water which may be diverted by the Contractor from the
13	Sacramento River for beneficial use on the land shown on Exhibit B which said
14	diversion, use, and allocation shall not be disturbed so long as the Contractor shall fulfill
15	all of its obligations hereunder;

18	(b) Nothing herein contained is intended to or does limit rights of the
19	Contractor against others than the United States or of the United States against any

21	United States, or any other person shall become a party to a general adjudication of rights
22	to the use of water of the Sacramento River system, this Settlement Contract shall not
23	ieopardize the rights or position of either party hereto or of any other person and the

rights of all such persons in respect to the use of such water shall be determined in such proceedings the same as if this Settlement Contract had not been entered into, and if final judgment in any such general adjudication shall determine that the rights of the parties hereto are different from the rights as assumed herein, the parties shall negotiate an amendment to give effect to such judgment. In the event the parties are unable to agree on an appropriate amendment they shall, within 60 days of determining that there is an impasse, employ the services of a neutral mediator, experienced in resolving water rights disputes, to assist in resolving the impasse. The cost of the mediation will be shared equally. A failure to reach agreement on an amendment within 60 days of the end of mediation will cause the immediate termination of this Settlement Contract.

Board or a court of competent jurisdiction issues a final decision or order modifying the terms and conditions of the water rights of either party to this Settlement Contract in order to impose Bay-Delta water quality obligations, the Contractor and the United States shall promptly meet to determine whether or not to modify any of the terms of this Settlement Contract to comply with the final decision or order, including, but not limited to, the applicability of the rescheduling charge in Article 3(c)(1) of this Settlement Contract. If within 60 days of the date of the issuance of the final decision or order the parties are not able to reach agreement regarding either the need to modify this Settlement Contract or the manner in which this Settlement Contract is to be modified, the parties shall promptly retain a neutral mediator, experienced in resolving water right disputes, to assist the parties in resolving their dispute. The cost of the mediator shall be shared equally. In the event that either of the parties to this Settlement Contract

determines that the parties will not be able to develop mutually-agreeable modification(s) to this Settlement Contract even with the assistance of a mediator, either of the parties to this Settlement Contract may attempt to resolve the impasse by seeking appropriate judicial relief including, but not limited to, filing a general adjudication of the rights to the use of water in the Sacramento River system. The foregoing provisions of this subarticle shall only apply to the incremental obligations contained within a final decision or order of the State Water Resources Control Board that reflects a modification to the obligations imposed in State Water Resources Control Board Revised Water Rights

Decision 1641 dated March 15, 2000, and its associated 1995 Water Quality Control Plan which, taken together, will be considered the baseline for the application of the

provisions of this sub-article.

(d) In the event this Settlement Contract terminates, the rights of the parties to thereafter divert and use water shall exist as if this Settlement Contract had not been entered into; and the fact that as a compromise settlement of a controversy as to the respective rights of the parties to divert and use water and the yield of such rights during the term hereof, this Settlement Contract places a limit on the Contract Total to be diverted annually by the Contractor during the Settlement Contract term and segregates it into Base Supply and Project Water shall not jeopardize the rights or position of either party with respect to its water rights or the yield thereof at all times after the Settlement Contract terminates. It is further agreed that the Contractor at all times will first use water to the use of which it is entitled by virtue of its own water rights, and neither the provisions of this Settlement Contract, action taken thereunder, nor payments made thereunder to the United States by the Contractor shall be construed as an

- 1 admission that any part of the water used by the Contractor during the term of this
- 2 Settlement Contract was in fact water to which it would not have been entitled under
- 3 water rights owned by it nor shall receipt of payments thereunder by the United States
- 4 from the Contractor be construed as an admission that any part of the water used by the
- 5 Contractor during the term of this Settlement Contract was in fact water to which it
- 6 would have been entitled under water rights owned by it.

The parties agree that the delivery of Project Water for irrigation use or 3 use of Federal facilities pursuant to this Settlement Contract is subject to Federal 4 Reclamation law, including but not limited to, the Reclamation Reform Act of 1982 (43 5 U.S.C. 390aa et seq.), as amended and supplemented, and the rules and regulations 6 promulgated by the Secretary of the Interior under Federal Reclamation law. 7 GENERAL OBLIGATION--BENEFITS CONDITIONED UPON PAYMENT 8 9 12. The obligation of the Contractor to pay the United States as 10 provided in this Settlement Contract is a general obligation of the Contractor 11 notwithstanding the manner in which the obligation may be distributed among the Contractor's water users and notwithstanding the default of individual water users in their 12 13 obligations to the Contractor. 14 15 The payment of Charges becoming due hereunder is a condition precedent to receiving benefits under this Settlement Contract. The United States shall 16 17 not make water available to the Contractor through Project facilities during any period in 18 which the Contractor may be in arrears in the advance payment of water Rates due the 19 United States. The Contractor shall not furnish water made available pursuant to this 20 Settlement Contract for lands or parties which are in arrears in the advance payment of 21 water rates levied or established by the Contractor. 22 23 With respect to subdivision (b) of this Article, the Contractor shall (c) 24 have no obligation to require advance payment for water Rates which it levies. 25 26 CHARGES FOR DELINQUENT PAYMENTS 27 28 13. The Contractor shall be subject to interest, administrative and (a) 29 penalty charges on delinquent installments or payments. When a payment is not received 30 by the due date, the Contractor shall pay an interest charge for each day the payment is 31 delinquent beyond the due date. When a payment becomes 60 days delinquent, the 32 Contractor shall pay an administrative charge to cover additional costs of billing and 33 processing the delinquent payment. When a payment is delinquent 90 days or more, the 34 Contractor shall pay an additional penalty charge of six percent per year for each day the 35 payment is delinquent beyond the due date. Further, the Contractor shall pay any fees 36 incurred for debt collection services associated with a delinguent payment. 37 38 The interest charge rate shall be the greater of the rate prescribed 39 quarterly in the Federal Register by the Department of the Treasury for application to

overdue payments, or the interest rate of one-half of one percent per month prescribed by

1 Section 6 of the Reclamation Project Act of 1939 (Public Law 76-260). The interest 2 charge rate shall be determined as of the due date and remain fixed for the duration of the 3 delinguent period. 4 5 (c) When a partial payment on a delinquent account is received, the 6 amount received shall be applied, first to the penalty, second to the administrative 7 charges, third to the accrued interest, and finally to the overdue payment. 8 9 **QUALITY OF WATER** 10 14. The operation and maintenance of Project facilities shall be performed in 11 such manner as is practicable to maintain the quality of raw water made available through 12 such facilities at the highest level reasonably attainable as determined by the Contracting 13 Officer. The United States does not warrant the quality of water and is under no obligation to construct or furnish water treatment facilities to maintain or better the 14 15 quality of water. 16 WATER AND AIR POLLUTION CONTROL 17 15. The Contractor, in carrying out this Settlement Contract, shall comply 18 with all applicable water and air pollution laws and regulations of the United States and 19 the State of California, and shall obtain all required permits or licenses from the 20 appropriate Federal, State, or local authorities. 21 **EQUAL OPPORTUNITY** 22 During the performance of this Settlement Contract, the Contractor agrees 16. 23 as follows: 24 25 The Contractor will not discriminate against any employee or (a) 26 applicant for employment because of race, color, religion, sex, or national origin. The 27 Contractor will take affirmative action to ensure that applicants are employed, and that employees are treated during employment, without regard to their race, color, religion, 28 29 sex, or national origin. Such action shall include, but not be limited to, the following: 30 Employment, upgrading, demotion, or transfer; recruitment or recruitment advertising; 31 layoff or termination, rates of payment or other forms of compensation; and selection for training, including apprenticeship. The Contractor agrees to post in conspicuous places, 32

available to employees and applicants for employment, notices to be provided by the Contracting Officer setting forth the provisions of this nondiscrimination clause.

(b) The Contractor will, in all solicitations or advertisements for employees placed by or on behalf of the Contractor, state that all qualified applicants will receive consideration for employment without discrimination because of race, color, religion, sex, or national origin.

(c) The Contractor will send to each labor union or representative of workers with which it has a collective bargaining agreement or other contract or understanding, a notice, to be provided by the Contracting Officer, advising the said labor union or workers' representative of the Contractor's commitments under Section 202 of Executive Order No. 11246 of September 24, 1965, as amended, and shall post copies of the notice in conspicuous places available to employees and applicants for employment.

(d) The Contractor will comply with all provisions of Executive Order No. 11246 of September 24, 1965, as amended, and of the rules, regulations, and relevant orders of the Secretary of Labor.

(e) The Contractor will furnish all information and reports required by said amended Executive Order and by the rules, regulations, and orders of the Secretary of Labor, or pursuant thereto, and will permit access to its books, records, and accounts by the Contracting Officer and the Secretary of Labor for purposes of investigation to ascertain compliance with such rules, regulations, and orders.

(f) In the event of the Contractor's noncompliance with the nondiscrimination clauses of this Settlement Contract or with any of the said rules, regulations, or orders, this Settlement Contract may be canceled, terminated, or suspended, in whole or in part, and the Contractor may be declared ineligible for further Government contracts in accordance with procedures authorized in said amended Executive Order, and such other sanctions may be imposed and remedies invoked as provided in said Executive Order, or by rule, regulation, or order of the Secretary of Labor, or as otherwise provided by law.

No liability shall accrue to the United States in case funds are not appropriated or allotted.

11	Settlement Contract is intended to or shall affect or alter the standard of judicial review
12	applicable under Federal law to any opinion or determination implementing a specific
13	provision of Federal law embodied in statute or regulation.
14	(b) The Contracting Officer shall have the right to make
15	determinations necessary to administer this Settlement Contract that are consistent with
16	the provisions of this Settlement Contract, the laws of the United States and of the State

(a) In addition to all other payments to be made by the Contractor pursuant to this Settlement Contract, the Contractor shall pay to the United States, within 60 days after receipt of a bill and detailed statement submitted by the Contracting Officer to the Contractor for such specific items of direct cost incurred by the United States for work requested by the Contractor associated with this Settlement Contract plus indirect costs in accordance with applicable Bureau of Reclamation policies and procedures. All such amounts referred to in this Article shall not exceed the amount agreed to in writing in advance by the Contractor. This Article shall not apply to costs for routine contract administration.

(b) All advances for miscellaneous costs incurred for work requested by the Contractor pursuant to Article 31 of this Settlement Contract shall be adjusted to reflect the actual costs when the work has been completed. If the advances exceed the actual costs incurred, the difference will be refunded to the Contractor. If the actual costs exceed the Contractor's advances, the Contractor will be billed for the additional costs pursuant to Article 31 of this Settlement Contract.

### WAIVER OF DEFAULT

32. The waiver by either party to this Settlement Contract as to any default shall not be construed as a waiver of any other default or as authority of the other party to continue such default or to make, do, or perform, or not to make, do, or perform, as the case may be, any act or thing which would constitute a default.

### CONTRACT ASSIGNMENT OR TERMINATION UPON TRANSFER OF LAND
