1 WITNESSETH, that: 2 **EXPLANATORY RECITALS** $[1^{st}]$ WHEREAS, the United States has constructed and is operating the Central Valley 3 4 Project, California, for multiple purposes pursuant to its statutory authority; and $[2^{\text{nd}}]$ WHEREAS, the Contractor has rights to divert, is diverting, and will continue to 5 6 divert for reasonable beneficial use, water from the natural flow of the Sacramento River and 7 tributaries thereto, that would have been flowing therein if the Central Valley Project were not in 8 existence; [3^{rd]} 9 WHEREAS, the construction and operation of the integrated and coordinated 10 Central Valley Project has changed and will further change the regimen of the Sacramento, 11 American, San Joaquin, and Trinity Rivers and the Sacramento-San Joaquin Delta from 12 unregulated flow to regulated flow; and [4^{th]} 13 WHEREAS, the United States has rights to divert, is diverting, and will continue 14 to divert waters from said Rivers and said Delta in connection with the operation of said Central 15 Valley Project; and [5^{th]} WHEREAS, the Contractor and the United States had a dispute over the 16 17 respective rights of the parties to divert and use water from the regulated flow of the Sacramento 18 River which threatened to result in litigation, and as a means to settle that dispute entered into 19 Contract No. 14-06-200-3346A, hereinafter referred to as the Existing Contract, which 20 established terms for the delivery to the Contractor of Central Valley Project Water, and the 21 quantities of Base Supply the United States and the Contractor agreed may be diverted by the

Contractor from the Sacramento River pursuant to such contract; and

[6 ^{th]} WHEREAS, the United States and the Contractor disagree with respect to the
authority of the United States to change the quantities of Base Supply and/or Project Water
specified as available for diversion in this Settlement Contract from the quantities specified in
the Existing Contract, and other issues related thereto. That dispute was the subject of litigation
in a lawsuit entitled Glenn-Colusa Irrigation District, et al. v. United States, et al. [Civ. No. S-
01-1816 GEB/JFM (E.D. Cal.)], but that litigation was dismissed, without prejudice, pursuant to
a stipulation of dismissal filed by the parties thereto on August 29, 2002. Notwithstanding that
dismissal, the Contractor and the United States enter into this Settlement Contract to renew the
Existing Contract, pursuant to the terms of the Existing Contract, Federal Reclamation law, and
the laws of the State of California; and
[7 th] WHEREAS, to assure the Contractor of the enjoyment and use of the regulated
flow of the said Rivers and the Delta, and to provide for the economical operation of the Central
Valley Project by, and the reimbursement to, the United States for expenditures made for said
Project.
NOW, THEREFORE, in consideration of the performance of the herein contained
provisions, conditions, and covenants, it is agreed as follows:
<u>DEFINITIONS</u>
1. When used herein, unless otherwise expressed or incompatible with the intent
hereof, the term:
(a) "Base Supply" shall mean the quantity of Surface Water established in
Articles 3 and 5 which may be diverted by the Contractor from the Sacramento River each month
during the period April through October of each Year without payment to the United States for
such quantities diverted;

1	(b) "Basin-Wide Water Management Plan" shall mean the mutually agreeable
2	Sacramento River Basinwide Water Management Plan, dated, developed by
3	Glenn-Colusa Irrigation District, Maxwell Irrigation District, Natomas Central Mutual Water
4	Company, Pelger Mutual Water Company, Princeton-Codora-Glenn Irrigation District, Provident
5	Irrigation District, Reclamation District 108, Sutter Mutual Water Company, Anderson-
6	Cottonwood Irrigation District, M&T, Inc., Meridian Farms Water Company, Reclamation
7	District 1004, and the U.S. Bureau of Reclamation;
8	(c) "Charges" shall mean the payments for Project Water that the Contractor
9	is required to pay to the United States in addition to the "Rates" specified in this Settlement
10	Contract. The Contracting Officer will, on an annual basis, determine the extent of these
11	Charges. The type and amount of each Charge shall be specified in Exhibit D;
12	(d) "Contract Total" shall mean the sum of the Base Supply and Project Water
13	available for diversion by the Contractor for the period April 1 through October 31;
14	(e) "Critical Year" shall mean any Year in which either of the following
15	eventualities exists:
16	(1) The forecasted full natural inflow to Shasta Lake for the current
17	Water Year, as such forecast is made by the United States on or before February 15 and reviewed
18	as frequently thereafter as conditions and information warrant, is equal to or less than 3.2 million
19	acre-feet; or
20	(2) The total accumulated actual deficiencies below 4 million acre-feet
21	in the immediately prior Water Year or series of successive prior Water Years each of which had
22	inflows of less than 4 million acre-feet, together with the forecasted deficiency for the current
23	Water Year, exceed 800,000 acre-feet.

1	For the purpose of determining a Critical Year, the computation of inflow to
2	Shasta Lake shall be performed in a manner that considers the extent of upstream development
3	above Shasta Lake during the year in question, and shall be used as the full natural flow to
4	Shasta Lake. In the event that major construction has occurred or occurs above Shasta Lake after
5	September 1, 1963, and which has materially altered or alters the regimen of the stream systems
6	contributing to Shasta Lake, the computed inflow to Shasta Lake used to define a Critical Year
7	will be adjusted to eliminate the effect of such material alterations. After consultation with the
8	State of California, the National Weather Service, and other recognized forecasting agencies, the
9	Contracting Officer will select the forecast to be used and will make the details of it available to
10	the Contractor. The same forecasts used by the United States for the operation of the Project
11	shall be used to make the forecasts hereunder;
12	(f) "CVPIA" shall mean the Central Valley Project Improvement Act, Title
13	XXXIV of the Act of October 30, 1992 (106 Stat. 4706);
14	(g) "Eligible Lands" shall mean all lands to which Project Water may be
15	delivered in accordance with Section 204 of the Reclamation Reform Act of October 12, 1982
16	(96 Stat. 1263), as amended, hereinafter referred to as RRA;
17	(h) "Excess Lands" shall mean all lands in excess of the limitations contained
18	in Section 204 of the RRA, other than those lands exempt from acreage limitation under Federal
19	Reclamation law;
20	(i) "Full Cost Rate" shall mean that water rate described in Sections 205(a)(3)
21	or 202(3) of the RRA, whichever is applicable;
22	(j) "Ineligible Lands" shall mean all lands to which Project Water may not be
23	delivered in accordance with Section 204 of the RRA;

1	(k) "Landholder" shall mean a party that directly or indirectly owns or leases
2	nonexempt land, as provided in 43 CFR 426.2;
3	(l) "Project" shall mean the Central Valley Project owned by the United
4	States and managed by the Department of the Interior, Bureau of Reclamation;
5	(m) "Project Water" shall mean all Surface Water diverted or scheduled to be
6	diverted each month during the period April through October of each Year by the Contractor
7	from the Sacramento River which is in excess of the Base Supply. The United States recognize
8	the right of the Contractor to make arrangements for acquisition of water from projects of others
9	than the United States for delivery through the Sacramento River and tributaries subject to
10	written agreement between Contractor and the United States as to identification of such water
11	which water when so identified shall not be deemed Project Water under this Settlement
12	Contract;
13	(n) "Rates" shall mean the payments for Project Water determined annually
14	by the Contracting Officer in accordance with the then current applicable water ratesetting
15	policies for the Project, as described in subdivision (a) of Article 8 of this Settlement Contract;
16	(o) "Secretary" or "Contracting Officer" shall mean the Secretary of the
17	Interior, a duly appointed successor, or an authorized representative acting pursuant to any
18	authority of the Secretary and through any agency of the Department of the Interior;
19	(p) "Surface Water" shall mean only those waters that are considered as
20	surface water under California law;
21	(q) "Water Year" shall mean the period commencing with October 1 of one
22	year and extending through September 30 of the next; and
23	(r) "Year" shall mean a calendar year.

TERM OF SETTLEMENT CONTRACT

- 2. (a) This Settlement Contract shall become effective April 1, 2004, and shall remain in effect until and including March 31, 2044: Provided, that under terms and conditions mutually agreeable to the parties hereto, renewals may be made for successive periods not to exceed 40 years each. The terms and conditions of each renewal shall be agreed upon not later than 1 year prior to the expiration of the then existing Settlement Contract.
- pertaining thereto, upon written request by the Contractor of the Secretary made not later than 1 year prior to the expiration of this Settlement Contract, whenever, account being taken of the amount then credited to the costs of construction of water supply works, the remaining amount of construction costs of water supply work which is properly assignable for ultimate return by the Contractor as established by the Secretary of the Interior pursuant to (3) of Section 1 of Public Law 643 (70 Stat. 483), probably can be repaid to the United States within the term of a contract under subsection 9(d) of the 1939 Reclamation Project Act (53 Stat. 1187), the relevant portions of this Settlement Contract may be converted to a contract under said subsection 9(d) upon terms and conditions mutually agreeable to the United States and the Contractor. The Secretary shall make a determination 10 years after the date of execution of this Settlement Contract, and every 5 years thereafter, of whether a conversion to a contract under said subsection 9(d) can be accomplished pursuant to Public Law 643. Notwithstanding any provision of this Settlement Contract, the Contractor reserves and shall have all rights and benefits under Public Law 643.

WATER TO BE FURNISHED TO CONTRACTOR

3. (a) Subject to the conditions, limitations, and provisions hereinafter expressed, the Contractor is hereby entitled and authorized to divert from the Sacramento River

1 at the locations shown in Exhibit A, for beneficial use within the area delineated on Exhibit B, 2 (both Exhibits are attached hereto and made a part hereof), the Contract Total designated in 3 Exhibit A, or any revision thereof, in accordance with the monthly operating schedule required 4 by Article 3(c) of this Settlement Contract. The quantity of any water diverted under this 5 Settlement Contract from the Sacramento River, during the period April through October, for use 6 on any lands delineated on Exhibit B, by the owner of such lands or otherwise shall constitute a 7 part of the Contract Total as shown on Exhibit A and shall be subject to all the provisions of this 8 Settlement Contract relating to such Contract Total as if such diversion were made by the 9 Contractor: Provided, that water diverted and used for municipal, industrial, and domestic 10 purposes within the Contractor's service area shall not be subject to the provisions of this 11 contract and shall not constitute a part of the total supply Contract Total when such diversions 12 are made by the following: 13 The City of Redding, a municipality, or by others for use in the 14 area lying west of the Sacramento River and north of Clear Creek; or 15 (2)Any industrial firm which erects its principal buildings on land riparian to the Sacramento River not then being served by the Contractor, or, if then being served 16 by the Contractor, to the extent the water diverted for industrial purposes is greater than the 17 18 water so served to such land by the Contractor it shall not constitute a part of the total supply Contract Total. 19 20 (b) The Contractor may have acquired rights to divert water from the 21 Sacramento River during the period April through October, that were obtained after the date of 22 execution of the Existing Contract, or the Contractor may acquire such rights in the future. All 23 diversions made from the Sacramento River, pursuant to such rights, during the period April

1	through October, shall not be considered a part of the quantity of Base Supply and Project Water
2	specified in Exhibit A; Provided, that the quantities diverted pursuant to the above rights shall be
3	identified on the schedule submitted pursuant to Article 3(c) below, and shall not be substituted
4	for any Base Supply or Project Water; Provided, further, that any such identified quantities of
5	other acquired rights may be diverted by the Contractor before incurring any fee pursuant to
6	Article 3(c)(1), below.
7	(c) Before April 1 and before the first day of each month thereafter when a
8	revision is needed, the Contractor shall submit a written schedule to the Contracting Officer
9	indicating the Contract Total to be diverted by the Contractor during each month under this
10	Settlement Contract. The United States shall furnish water to the Contractor in accordance with
11	the monthly operating schedule or any revisions thereof. However, the United States recognizes
12	the need of the Contractor to change from time to time its monthly diversions of water from the
13	quantities shown in Exhibit A; the Contractor may make such changes, provided:
14	(1) that for the quantity of Base Supply diverted in excess of the
15	monthly quantity shown in Exhibit A, and as may be reduced in accordance with Article 5(a),
16	during June, July, August, September, or October of any Water Year, the Contractor shall be
17	charged a rescheduling fee equal to 50 percent of the sum of the storage operations and
18	maintenance rate and the storage capital rate components of the Project ratesetting policy.
19	(2) that in no event shall the total quantity scheduled for diversion by
20	the Contractor from the Sacramento River:
21	(i) During the period April through October exceed the
22	aggregate of the Contract Total for that period shown in Exhibit A or any revision
23	thereof;

(ii) During the period July through August exceed the
aggregate of the Contract Total for that period shown in Exhibit A or any revision
thereof.
(d) In the event conditions warrant, the Contracting Officer reserves the right
to require the Contractor to submit, at least 72 hours prior to the beginning of each weekly
period, its estimate of daily diversion requirements for each such period from the Sacramento
River: <u>Provided</u> , <u>however</u> , that changes during any such period may be made upon the giving of
72 hours' notice thereof to the Contracting Officer: <u>Provided, further</u> , that the Contractor shall
notify the United States as far in advance as is reasonably possible each time it intends to install
or remove boards from its diversion dam. The United States shall notify the Contractor as far in
advance as is reasonably possible each time it intends to change the release of water from
Keswick Reservoir into the Sacramento River. In addition, during the irrigation season, the
Contractor may from time to time notify the United States of the maximum flow the Contractor
believes its diversion dam with the then setting of boards can safely accommodate without
damage thereto or to the walkway, and the Contracting Officer shall notify the Contractor as far
in advance as possible but not less than 24 hours of any change in releases to be made at
Keswick Reservoir that would exceed such maximum flow designated by the Contractor. The
United States shall assist the Contractor in connection with the installation or removal of boards
from the diversion dam by the Contractor as follows:
(1) Adjust Keswick releases to the extent reasonably needed to
facilitate installation or removal of boards, the adjustments to be made at times that will
accomplish that purpose but not unduly interfere with other obligations of the United States; and

1 (2) Furnish manpower to assist the Contractor in placing or removing 2 boards when an emergency condition exists as a result of the operations of the United States. 3 (e) No sale, transfer, exchange, or other disposal of any of the Contract Total 4 designated in Exhibit A or the right to the use thereof for use on land other than that shown on 5 Exhibit B shall be made by the Contractor without first obtaining the written consent of the 6 Contracting Officer. Such consent will not be unreasonably withheld and a decision will be 7 rendered in a timely manner. For short-term actions that will occur within 1 year or less, the 8 decision will be rendered within 30 days after receipt of a complete written proposal. For long-9 term actions that will occur in a period longer than 1 year, the decision will be rendered within 10 90 days after receipt of a complete written proposal. For a proposal to be deemed complete by 11 the Contracting Officer, it must comply with all provisions required by State and Federal law, 12 including information sufficient to enable the Contracting Officer to comply with the National 13 Environmental Policy Act, the Endangered Species Act, and applicable rules or regulations then 14 in effect; Provided that, such consent does not authorize the use of Federal facilities to facilitate 15 or effectuate the sale, transfer, exchange, or other disposal of Base Supply. Such use of Federal 16 facilities will be the subject of a separate agreement to be entered into between the Contractor 17 and Reclamation. 18 (f) For the purpose of determining whether Section 3405(a)(1)(M) of the 19 CVPIA applies to the Contractor as a transferor or transferee of Project Water, the Contracting 20 Officer acknowledges that the Contractor is within a county, watershed, or other area of origin, 21 as those terms are utilized under California law.

1	(g) Nothing herein contained shall prevent the Contractor from diverting
2	water during the months of November through March for beneficial use on the land shown on
3	Exhibit B or elsewhere to the extent authorized under the laws of the State of California.
4	(h) The United States assumes no responsibility for and neither it nor its
5	officers, agents, or employees shall have any liability for or on account of:
6	(1) The quality of water to be diverted by the Contractor;
7	(2) The control, carriage, handling, use, disposal, or distribution of
8	water diverted by the Contractor outside the facilities constructed and then being operated and
9	maintained by or on behalf of the United States;
10	(3) Claims of damage of any nature whatsoever, including but not
11	limited to, property loss or damage, personal injury, or death arising out of or connected with the
12	control, carriage, handling, use, disposal, or distribution of said water outside of the hereinabove
13	referred to facilities; and
14	(4) Any damage whether direct or indirect arising out of or in any
15	manner caused by a shortage of water whether such shortage be on account of errors in
16	operation, drought, or unavoidable causes.
17	<u>RETURN FLOW</u>
18	4. Nothing herein shall be construed as an abandonment or a relinquishment by the
19	United States of any right it may have to the use of waste, seepage, and return flow water derived
20	from water diverted by the Contractor hereunder and which escapes or is discharged beyond the
21	boundaries of the lands shown on Exhibit B; Provided, that this shall not be construed as
22	claiming for the United States any right to such water which is recovered by the Contractor
23	pursuant to California law from within the boundaries of the lands shown on Exhibit B, and

1 which is being used pursuant to this Settlement Contract for surface irrigation or underground 2 storage for the benefit of the lands shown on Exhibit B by the Contractor. 3 CONSTRAINTS ON THE AVAILABILITY OF WATER 4 5. (a) In a Critical Year, the Contractor's Base Supply and Project Water agreed 5 to be diverted during the period April through October of the Year in which the principal portion 6 of the Critical Year occurs and, each monthly quantity of said period shall be reduced by 7 25 percent. 8 (b) The amount of any overpayment by the Contractor shall, at its option, be 9 refunded or credited upon amounts to become due to the United States from the Contractor under 10 the provisions hereof in the ensuing Year. To the extent of such deficiency such adjustment of 11 overpayment shall constitute the sole remedy of the Contractor. 12 INTEGRATED WATER MANAGEMENT AND PARTNERSHIPS 6. The Contractor and United States desire to work together to maximize the 13 14 reasonable beneficial use of water for their mutual benefit. As a consequence, the United States 15 and the Contractor will work in partnership and with others within the Sacramento Valley, 16 including other Contractors, to facilitate the better integration within the Sacramento Valley of 17 all water supplies including, but not limited to, the better management and integration of surface 18 water and groundwater, the development and better utilization of surface water storage, the 19 effective utilization of waste, seepage and return flow water, and other operational and 20 management options that may be identified in the future. 21 USE OF WATER FURNISHED TO CONTRACTOR 7. Project Water furnished to the Contractor pursuant to this Settlement 22 (a)

Contract shall not be delivered or furnished by the Contractor for any purposes other than

1	agricultural purposes without the written consent of the Contracting Officer. For purposes of this
2	Settlement Contract, "agricultural purposes" includes, but is not restricted to, the irrigation of
3	crops, the watering of livestock, incidental domestic use including related landscape irrigation, or
4	underground water replenishment. The parties anticipate that, during the term of this Settlement
5	Contract, a gradual change in the purpose of use of water will occur within the place of water use
6	shown in Exhibit B from predominantly agricultural purposes to a mixture of municipal and
7	industrial, wildlife habitat and agricultural purposes, and the parties agree to work cooperatively
8	to accommodate and facilitate such change. Project Water furnished to the Contractor pursuant
9	to this Settlement Contract may be delivered or furnished by the Contractor for agricultural or
10	municipal and industrial purposes: Provided, however, that the Contractor shall not deliver or
11	furnish Project Water for municipal and industrial purposes outside those areas delineated on
12	Exhibit B, as approved for such purposes by the Contracting Officer, without the written consent
13	of the Contracting Officer. Such consent will not be unreasonably withheld and a decision will
14	be provided in a timely manner following completion of any environmental review required
15	under applicable law. For purposes of this Settlement Contract, "agricultural purposes" includes,
16	but is not restricted to, the irrigation of crops, the watering of livestock, incidental domestic use
17	including related landscape irrigation, or underground water replenishment; and "municipal and
18	industrial purposes" includes, but is not limited to, the watering of landscaping or pasture for
19	animals (e.g., horses) which are kept for personal enjoyment or water delivered to landholdings
20	operated in units of less than 5 acres unless the Contractor establishes to the satisfaction of the
21	Contracting Officer that the use of Project Water is for agricultural purposes.

9	Nothing herein shall be construed to prevent the Contractor from challenging or seeking judicial
10	relief in a court of competent jurisdiction with respect to any biological opinion or other
11	environmental documentation referred to in this Article.
12	RATE AND METHOD OF PAYMENT FOR WATER
13	8. (a) The Contractor shall make payments to the United States as provided in
14	this Article for all Project Water shown in Exhibit A as follows:
15	(1) 75 percent of the amount shown as Project Water shall be paid for
16	by the Contractor in each Year; and in addition
17	(2) the Contractor shall pay for Project Water actually diverted in
18	excess of 75 percent of the amount shown as Project Water.

4	The Contracting Officer shall adjust the amount of Project Water for which payment is required
5	to the extent of any reduction in diversions of Project Water made in accordance with the water
6	conservation provisions of Article 29(e). The Contractor shall make payments to the United
7	States as provided in this Article for all Project Water shown in Exhibit A as follows:
8	(1) 75 percent of the amount shown as Project Water shall be paid for

19	limited to diversions for municipal and industrial uses and diversions for direct application to

21	such diversions, the Contractor shall provide the Contracting Officer with an estimate of the
22	annual quantities of Project Water to be diverted or furnished for such purposes through the end

- 1 Charges applicable to the Contractor upon execution of this Settlement Contract are set forth in
- 2 Exhibit D, as may be revised annually. The Secretary's ratesetting policies for the Project shall
- 3 be amended, modified, or superseded only through a public notice and comment procedure. The
- 4 Contracting Officer shall adjust the amount of Project Water for which payment is required to
- 5 the extent of any reduction in diversions of Project Water made in accordance with the water
- 6 conservation provisions of Article 29(e).
- 7 (b) The Contracting Officer shall notify the Contractor of the Rates and
- 8 Charges as follows:

- 20 allocations. By December 31 of each Year, the Contracting Officer shall provide the Contractor
- 21 with the final Rates to be in effect for the upcoming Year, and such notification shall revise

18	(d) Payments to be made by the Contractor to the United States under this

The Contracting Officer shall, each Year upon request of the Contractor, provide to the Contractor a detailed accounting of all Project and Contractor expense allocations, the disposition of all Project and Contractor revenues, and a summary of all water delivery information. The Contracting Officer and the Contractor shall enter into good faith negotiations to resolve any discrepancies or disputes relating to accountings, reports, or information.

- (f) The parties acknowledge and agree that the efficient administration of this Settlement Contract is their mutual goal. Recognizing that experience has demonstrated that mechanisms, policies, and procedures used for establishing Rates and Charges and/or for making and allocating payments, other than those set forth in this Article may be in the mutual best interest of the parties, it is expressly agreed that the parties may enter into agreements to modify the mechanisms, policies, and procedures for any of those purposes while this Settlement Contract is in effect without amendment of this Settlement Contract.
- ratesetting policies for the Project will be established to recover only reimbursable operation and maintenance (including any deficits) and capital costs of the Project, as those terms are used in the then current Project ratesetting policies, and interest, where appropriate, except in instances where a minimum Rate is applicable in accordance with the relevant Project ratesetting policy.

- 1 Proposed changes of significance in practices which implement the ratesetting policies for the
- 2 Project will not be implemented until the Contracting Officer has provided the Contractor an

- 5 Settlement Contract, including but not limited to operation and maintenance expenses and

The Contractor 6 shall not be relieved of the whole or any part of its said obligation by, on account of, or 7 notwithstanding, as the case may be: 8 Its failure, refusal, or neglect to divert 75 percent of the quantity of (1) Project Water shown on Exhibit A; 9 10 (2) The default in payment to it by any water user of assessments, 11 tolls, or other charges levied by or owing to said Contractor; 12 (3) Any judicial determination that any assessment, toll, or other charge referred to in subsection 8(c)(2) of this Settlement Contract is irregular, void, or 13 14 ineffectual; or 15 (4) Any injunctive process enjoining or restraining the Contractor 16 from making or collecting any such assessment, toll, or other charge referred to in subsection 17 8(c)(2) of this Settlement Contract. 18 AGREEMENT ON WATER QUANTITIES 9. 19 During the term of this Settlement Contract and any renewals thereof: (a) 20 (1) It shall constitute full agreement as between the United States and 21 the Contractor as to the quantities of water and the allocation thereof between Base Supply and 22 Project Water which may be diverted by the Contractor from the Sacramento River for beneficial

- 1 use on the land shown on Exhibit B which said diversion, use, and allocation shall not be
- 2 disturbed so long as the Contractor shall fulfill all of its obligations hereunder;
- 3 (2) Neither party shall claim any right against the other in conflict with 4 the provisions of Article 9(a)(1) hereof.
- 5 (b) Nothing herein contained is intended to or does limit rights of the
- 6 Contractor against others than the United States or of the United States against any person other
- 7 than the Contractor: <u>Provided</u>, <u>however</u>, that in the event the Contractor, the United States, or
- 8 any other person shall become a party to a general adjudication of rights to the use of water of
- 9 the Sacramento River system, this Settlement Contract shall not jeopardize the rights or position
- of either party hereto or of any other person and the rights of all such persons in respect to the
- use of such water shall be determined in such proceedings the same as if this Settlement Contract
- had not been entered into, and if final judgment in any such general adjudication shall determine
- that the rights of the parties hereto are different from the rights as assumed herein, the parties
- shall negotiate an amendment to give effect to such judgment. In the event the parties are unable
- to agree on an appropriate amendment they shall, within 60 days of determining that there is an
- impasse, employ the services of a neutral mediator, experienced in resolving water rights
- disputes, to assist in resolving the impasse. The cost of the mediation will be shared equally. A
- 18 failure to reach agreement on an amendment within 60 days of the end of mediation will cause
- 19 the immediate termination of this Settlement Contract.

- (c) In the event that the California State Water Resources Control Board or a court of competent jurisdiction issues a final decision or order modifying the terms and
- 22 conditions of the water rights of either party to this Settlement Contract in order to impose Bay-
- 23 Delta water quality obligations, the Contractor and the United States shall promptly meet to

determine whether or not to modify any of the terms of this Settlement Contract to comply with the final decision or order, including, but not limited to, the applicability of the rescheduling charge in Article 3(c)(1) of this Settlement Contract. If within 60 days of the date of the issuance of the final decision or order the parties are not able to reach agreement regarding either the need to modify this Settlement Contract or the manner in which this Settlement Contract is to be modified, the parties shall promptly retain a neutral mediator, experienced in resolving water right disputes, to assist the parties in resolving their dispute. The cost of the mediator shall be shared equally. In the event that either of the parties to this Settlement Contract determines that the parties will not be able to develop mutually-agreeable modification(s) to this Settlement Contract even with the assistance of a mediator, either of the parties to this Settlement Contract may attempt to resolve the impasse by seeking appropriate judicial relief including, but not limited to, filing a general adjudication of the rights to the use of water in the Sacramento River system. The foregoing provisions of this sub-article shall only apply to the incremental obligations contained within a final decision or order of the State Water Resources Control Board that reflects a modification to the obligations imposed in State Water Resources Control Board Revised Water Rights Decision 1641 dated March 15, 2000, and its associated 1995 Water Quality Control Plan which, taken together, will be considered the baseline for the application of the provisions of this sub-article. (d) In the event this Settlement Contract terminates, the rights of the parties to thereafter divert and use water shall exist as if this Settlement Contract had not been entered into; and the fact that as a compromise settlement of a controversy as to the respective rights of the parties to divert and use water and the yield of such rights during the term hereof, this Settlement

- 10. (a) All water diverted by the Contractor from the Sacramento River will be diverted at the existing point or points of diversion shown on Exhibit A or at such other points as may be mutually agreed upon in writing by the Contracting Officer and the Contractor.
- (b) All water diverted from the Sacramento River pursuant to this Settlement Contract will be measured or caused to be measured by the United States at each point of diversion with existing equipment or equipment to be installed, operated, and maintained by the United States, and/or others, under contract with and at the option of the United States. The equipment and methods used to make such measurement shall be in accordance with sound engineering practices. Upon request of the Contractor, the accuracy of such measurements will be investigated by the Contracting Officer and any errors appearing therein will be corrected.

1	(c) The right of ingress to and egress from all points of diversion is hereby
2	granted to all authorized employees of the United States. The Contractor also hereby grants to
3	the United States the right to install, operate, maintain, and replace such equipment on diversion
4	or carriage facilities at each point of diversion as the Contracting Officer deems necessary.
5	(d) The Contractor shall not modify, alter, remove, or replace diversion
6	facilities or do any other act which would alter the effectiveness or accuracy of the measuring
7	equipment installed by the United States or its representatives unless and until the Contracting

9	measuring equipment in such manner as may be necessary or appropriate. In the event of an

(f) Contractor and Contracting Officer shall develop a mutually agreeable surface water delivery water measurement program which shall be implemented by the Contractor, and such measurement program shall be consistent with the conservation and efficiency criteria for evaluating water conservation plans as provided in Article 29(a).

(g) All new surface water delivery systems installed within the lands delineated on Exhibit B after the effective date of this Settlement Contract shall also comply with the measurement provisions described in this Article.

1 **RULES AND REGULATIONS** 2 11. The parties agree that the delivery of Project Water for irrigation use or use of 3 Federal facilities pursuant to this Settlement Contract is subject to Federal Reclamation law, 4 including but not limited to, the Reclamation Reform Act of 1982 (43 U.S.C. 390aa et seq.), as 5 amended and supplemented, and the rules and regulations promulgated by the Secretary of the 6 Interior under Federal Reclamation law. 7 GENERAL OBLIGATION--BENEFITS CONDITIONED UPON PAYMENT 8 The obligation of the Contractor to pay the United States as provided in 12. 9 this Settlement Contract is a general obligation of the Contractor notwithstanding the manner in which the obligation may be distributed among the Contractor's water users and notwithstanding 10 the default of individual water users in their obligations to the Contractor. 11 12 (b) The payment of Charges becoming due hereunder is a condition precedent 13 to receiving benefits under this Settlement Contract. The United States shall not make water 14 available to the Contractor through Project facilities during any period in which the Contractor may be in arrears in the advance payment of water Rates due the United States. The Contractor 15 16 shall not furnish water made available pursuant to this Settlement Contract for lands or parties 17 which are in arrears in the advance payment of water rates levied or established by the 18 Contractor. 19 With respect to subdivision (b) of this Article, the Contractor shall have no (c) obligation to require advance payment for water Rates which it levies. 20 21 CHARGES FOR DELINQUENT PAYMENTS 22 13. (a) The Contractor shall be subject to interest, administrative and penalty 23 charges on delinquent installments or payments. When a payment is not received by the due 24 date, the Contractor shall pay an interest charge for each day the payment is delinquent beyond 25 the due date. When a payment becomes 60 days delinquent, the Contractor shall pay an administrative charge to cover additional costs of billing and processing the delinquent payment. 26 27 When a payment is delinquent 90 days or more, the Contractor shall pay an additional penalty charge of six percent per year for each day the payment is delinquent beyond the due date. 28 29 Further, the Contractor shall pay any fees incurred for debt collection services associated with a 30 delinquent payment.

The 8 United States does not warrant the quality of water and is under no obligation to construct or 9 furnish water treatment facilities to maintain or better the quality of water. 10 WATER AND AIR POLLUTION CONTROL 11 15. The Contractor, in carrying out this Settlement Contract, shall comply with all 12 applicable water and air pollution laws and regulations of the United States and the State of 13 California, and shall obtain all required permits or licenses from the appropriate Federal, State, 14 or local authorities. 15 **EQUAL OPPORTUNITY** 16 16. During the performance of this Settlement Contract, the Contractor agrees as follows: 17 18 The Contractor will not discriminate against any employee or applicant for (a) employment because of race, color, religion, sex, or national origin. The Contractor will take 19 20 affirmative action to ensure that applicants are employed, and that employees are treated during 21 employment, without regard to their race, color, religion, sex, or national origin. Such action shall include, but not be limited to, the following: Employment, upgrading, demotion, or 22 23 transfer; recruitment or recruitment advertising; layoff or termination, rates of payment or other 24 forms of compensation; and selection for training, including apprenticeship. The Contractor 25 agrees to post in conspicuous places, available to employees and applicants for employment, notices to be provided by the Contracting Officer setting forth the provisions of this 26 27 nondiscrimination clause.

The Contractor recognizes and agrees that such Federal assistance will be extended in reliance on the representations and agreements made in this Article, and that the United States reserves the right to seek judicial enforcement thereof.

MINGLING OF CONTRACTOR'S PROJECT AND NON-PROJECT WATER

- 18. (a) Project Water must of necessity be transported by the Contractor to its water users by means of the same works and channels used for the transport of its non-Project Water including Base Supply. Notwithstanding such mingling of water, the provisions of Article 11 hereof shall be applicable only to Project Water, and such mingling of water shall not in any manner subject to the provisions of Article 11 hereof the Contractor's non-Project water including Base Supply.
- (b) If required in accordance with subdivision (c) of this Article, the

 Contractor shall install and maintain such measuring equipment and distribution facilities and
 maintain such records as may be necessary to determine the amounts of water delivered to

 Excess Lands served by the Contractor. The Contractor shall not within any month deliver to

 Ineligible Lands water in excess of the non-Project Water, including Base Supply, for that

- 1 month. The Contracting Officer or authorized representative shall have the right at all 2 reasonable times to inspect such records and measuring equipment.
- The Contractor will not be considered in violation of the requirement that

 Project Water be delivered only to Eligible Lands during any month of the irrigation season that

 the water requirement for beneficial use on Eligible Lands for that month is equal to or in excess

 of the Project Water for that month as shown on Exhibit A or any revision thereof pursuant to

 subdivision (c) of Article 3. The water requirement for beneficial use on Eligible Lands will be

 determined by multiplying:
 - (1) the number of irrigable acres of the particular types of crops grown in that year on the acreage designated as eligible by

a part hereof, or by such other Unit Duties mutually agreed upon by the Contractor and the Contracting Officer. In order to make the computation of the water requirement for Eligible Lands, on April 1 of each Year and concurrently with its order for water for the irrigation season, the Contractor shall designate the acreage of and type of crops to be grown on its Eligible Lands that irrigation season. During any month the water requirement as above determined for crops growing on Eligible Lands during such month is equal to or in excess of the Project Water for that month as provided herein the Contractor shall not be required to measure the water delivered to Excess Lands. Any month the said water requirement is less than the amount of Project Water as provided herein, the Contractor will be required to measure water delivered to excess land in accordance with subdivision (b) hereof.

BOOKS, RECORDS, AND REPORTS

19. The Contractor shall establish and maintain accounts and other books and records pertaining to administration of the terms and conditions of this Settlement Contract, including:

- 1 the Contractor's financial transactions, water supply data, and Project land and right-of-way 2 agreements; the water users' land-use (crop census), land ownership, land-leasing and water use 3 data; and other matters that the Contracting Officer may require. Reports thereon shall be 4 furnished to the Contracting Officer in such form and on such date or dates as the Contracting 5 Officer may require. Subject to applicable Federal laws and regulations, each party to this 6 Settlement Contract shall have the right during office hours to examine and make copies of each 7 other's books and official records relating to matters covered by this Settlement Contract. 8 CHANGE OF PLACE OF USE OR ORGANIZATION 9 20. (a) Unless the written consent of the United States is first obtained no change 10 shall be made in the place of water use shown on Exhibit B. 11 While this Settlement Contract is in effect, no change shall be made in the (b) 12 area of the Contractor as shown on its Exhibit B, by inclusion, exclusion, annexation, or 13 detachment of lands, by dissolution, consolidation, or merger or otherwise, except upon the 14 Contracting Officer's written consent thereto. Such consent will not be unreasonably withheld 15 and a decision will be provided in a timely manner. 16 (c) In the event lands are annexed to or detached from the area of the Contractor, as provided herein, the quantity of Project Water to be diverted may be increased or 17 18 decreased, as may be appropriate, pursuant to a supplemental agreement to be executed in 19 respect thereto. 20 CONSOLIDATION OF CONTRACTING ENTITIES
 - 21. Consolidation of Contractors may be approved by the Contracting Officer provided: (i) the Contracting Officer approves the form and organization of the resulting entity and the utilization by it of the Contract Total; and (ii) the obligations of the Contractors are assumed by such entity.
- No such consolidation shall be valid unless and until approved by the Contracting

 Officer.

WATER CONSERVATION

29. Prior to the diversion of Project Water, the Contractor shall be (a) implementing an effective water conservation and efficiency program based on the Basin-Wide Water Management Plan and/or Contractor's water conservation plan that has been determined by the Contracting Officer to meet the conservation and efficiency criteria for evaluating water conservation plans established under Federal law. The water conservation and efficiency program shall contain definite water conservation objectives, appropriate economically feasible water conservation measures, and time schedules for meeting those objectives. Continued diversion of Project Water pursuant to this Settlement Contract shall be contingent upon the Contractor's continued implementation of such water conservation program. In the event the Contractor's water conservation plan or any revised water conservation plan completed pursuant to subdivision (c) of Article 29 of this Settlement Contract have not yet been determined by the Contracting Officer to meet such criteria, due to circumstances which the Contracting Officer determines are beyond the control of the Contractor, Project Water deliveries shall be made under this Settlement Contract so long as the Contractor diligently works with the Contracting Officer to obtain such determination at the earliest practicable date, and thereafter the Contractor immediately begins implementing its water conservation and efficiency program in accordance with the time schedules therein.

1	(b) The Contractor shall submit to the Contracting Officer a report on the			
2	status of its implementation of the water conservation plan on the reporting dates specified in the			
3	then existing conservation and efficiency criteria established under Federal law.
