## Narrative:

#### Narrative Description

This action consists of providing cost share funding for construction of fish screen projects in Central Valley streams, and for research projects to help assess the benefits of fish screens and to evaluate potential fish screen design improvements. In FY 2014, AFSP and CDFW funded activities to assess fish screen priorities in priority watersheds in the Central Valley, and the AFSP is currently coordinating with CDFW, NMFS and USFWS (AFRP) to assess additional fish screen projects to be funded in FY 2015. Project selection will be based on project costs and benefits, and project readiness. Priority will be given to projects that have matching cost share funding (at least 50% cost share match).
