Ground Rules


- **Participate Fully**

Draft Purpose Statement

- The purpose of the Central Valley Project Improvement Act (Act) Program Activity Review is to define completion criteria, clarify performance goals, and assess the status and progress of the Section 3406 and 3408 provisions of the Act.
 - **The Bureau of Reclamation (Reclamation) and Fish & Wildlife Service (Service) will conduct this Program Review with other federal, tribal, and state agencies, stakeholders, and other interested parties.**
- Reclamation and the Service will prepare a document presenting the perspectives and conclusions of the Program Activity Review by July 2006.
 - **The document will show the status and progress achieved in implementing the Act and recommendations for guiding future decisions in the development of program activities.**



Terminology & Definitions

- **Definitions**

- *Performance Goal* – Sets a target level of performance over time expressed as a tangible, measurable objective, against which actual achievement can be measured

- A *performance goal* includes:

- *Performance Measure* (next slide)

- *Targets* – Quantifiable or measurable characteristic that tells how well a program must accomplish a performance measure

- *Timeframe* – The anticipated timeframe for achieving the performance measure (can be annual or long-term)

- A *performance goal* should generally be related to program purposes and goals
