We have completed the fiscal year 2002 accounting for M&I operations, which includes a breakdown of results by individual contractor and service area. Included in the accounting are the results of our analysis of the interest impact of the adjustment for the Provision for Replacement (PFR) expenses. As you know, the PFR principal was already included as a part of the Chief Financial Office audit in the fiscal year 2001 accounting.
