Included in this accounting is an adjustment for interest and other related impacts applicable to the March 2005 settlement of the <u>City of Fresno, et al. v. United States of America, et al.</u> lawsuit. This administrative adjustment covers the period fiscal year 1949 through fiscal year 2003.
