We have completed the fiscal year 2004 accounting for M&I operations, which includes a breakdown of results by individual water contractor and service area. Included in this accounting is an adjustment for interest and other related impacts applicable to the March 2005 settlement of the <u>City of Fresno, et al. v. United States of America, et al.</u> lawsuit. This administrative adjustment covers the period fiscal year 1949 through fiscal year 2003.
